This bill requires the Department of Human Services to provide medical food or formula and low-protein modified food products to individuals with phenylketonuria (PKU) or maple syrup urine disease (MSUD). It is estimated that 27 individuals will utilize this program during the 2001-2003 biennium. This bill transfers the process of purchasing and distributing formula and low-protein modified food products from the Health Department to the Department of Human Services.

The revenues are anticipated to be derived from the federal Maternal & Child Health Services Block Grant, and from individuals who purchase medical food from the Department at cost.

The expenditures reflected above are based upon purchasing and shipping medical food and low-protein modified food products for an estimated 27 individuals.

The Department of Human Services appropriation would need to be increased by \$229,344, with \$89,152 to purchase the necessary medical foods for program participants, as provided in this bill.

If the Department's appropriation is not increased to cover this additional program, the service contracts for multidisciplinary clinics, care coordination and family support activities would have to be reduced.
