SB 2045 allows pass-through entities to file a composite return on behalf of its nonresident shareholders, and requires income tax withholding for certain nonresident shareholders. While the bill does not alter the tax liability of the nonresident shareholders, enactment of SB 2045 may result in a speed up the payment of the liability. This may result in a slight positive fiscal impact in an amount that cannot be estimated.
