- 1322 § 3 Study issues related to the development of livestock feeding facilities and the use of byproducts from biofuels production as a feedstock
- 3001 Study Century Code provisions that relate to agriculture for the purpose of recommending changes to laws that are found to be irrelevant, inconsistent, illogically arranged, or unclear in their intent and direction
- 3048 Study the bonding requirements placed on grain warehouses and buyers, including ethanol plants and grain processors; and ways to reduce further the financial risk of participants in the sale, purchase, handling, and processing of grain, including the sale of grain to ethanol plants and processors, the payment for grain by such entities, and whether there exists a need for new or increased bonding and indemnification options to reduce financial risk
- Receive report from the Advisory Committee on Sustainable Agriculture on the status of the committee's activities (NDCC § 4-01-23)
- Receive report from the State Board of Agricultural Research and Education on its annual evaluation of research activities and expenditures (NDCC § 4-05.1-19(8))
