ENGROSSED HOUSE BILL NO. 1001

(At the request of the Governor)

1 A BILL for an Act to provide an appropriation for defraying the expenses of the office of the
2 governor; and to amend and reenact sections 54-07-04 and 54-08-03 of the North Dakota
3 Century Code, relating to the salaries of the governor and lieutenant governor.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the
6 funds as may be necessary, are appropriated out of any moneys in the general fund in the state
7 treasury, not otherwise appropriated, and from special funds derived from federal funds and
8 other income, to the office of the governor for the purpose of defraying the expenses of the
9 office of the governor, for the biennium beginning July 1, 2009, and ending June 30, 2011, as
10 follows:

1 **SECTION 2. APPROPRIATION - AUTHORIZATION - LIMITATION - GOVERNOR'S**
2 **OFFICE.** In addition to the amounts appropriated to the governor's office in section 1 of this
3 Act, there is appropriated any additional income from federal or other funds which may become
4 available to the agency for the biennium beginning July 1, 2009, and ending June 30, 2011.
5 Any federal funds made available to the governor's office resulting from federal action to
6 provide funding to the states to stimulate the national economy or to address state fiscal
7 recovery may be accepted under this section but may not be spent until appropriated by the
8 legislative assembly.

9 **SECTION 3. AMENDMENT.** Section 54-07-04 of the North Dakota Century Code is
10 amended and reenacted as follows:

11 **54-07-04. Salary of governor.** The annual salary of the governor is ~~ninety-six one~~
12 ~~hundred five thousand one hundred eighty-three and thirty-four~~ one hundred eighty-three and thirty-four dollars through June 30, ~~2008~~
13 2010, and one hundred ~~ten thousand thirty-one~~ ten thousand two hundred eighty-five dollars thereafter.

14 **SECTION 4. AMENDMENT.** Section 54-08-03 of the North Dakota Century Code is
15 amended and reenacted as follows:

16 **54-08-03. Salary of lieutenant governor.** The annual salary of the lieutenant
17 governor is ~~seventy-four~~ eighty-one thousand ~~six~~ five hundred ~~sixty-eight~~ thirty-eight dollars
18 through June 30, ~~2008~~ 2010, and ~~seventy-seven~~ eighty-five thousand six hundred ~~fifty-five~~
19 fifteen dollars thereafter.
