**SENATE BILL NO. 2006**

Introduced by

(At the request of the Governor)

1 A BILL for an Act to provide an appropriation for defraying the expenses of the aeronautics  
2 commission; to amend and reenact section 57-43.3-06 of the North Dakota Century Code,  
3 relating to use of special funds received by the aeronautics commission; and to provide an  
4 expiration date.

5 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

6 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the  
7 funds as may be necessary, are appropriated out of any moneys in the general fund in the state  
8 treasury, not otherwise appropriated, and from special funds derived from federal funds and  
9 other income, to the aeronautics commission for the purpose of defraying the expenses of that  
10 agency, for the biennium beginning July 1, 2009, and ending June 30, 2011, as follows:

21 **SECTION 2. AMENDMENT.** Section 57-43.3-06 of the North Dakota Century Code is  
22 amended and reenacted as follows:

23 **57-43.3-06. Distribution of revenue.** The tax collected by the commissioner pursuant  
24 to section 57-43.3-04 must be deposited by the commissioner in the office of the state

1 treasurer, who shall deposit such moneys in a special fund known as the state aeronautics  
2 commission special fund. These funds are appropriated to the commission, and must be  
3 disbursed by warrant-check prepared by the office of management and budget upon vouchers  
4 submitted by the commission and approved by the office of management and budget, for  
5 commission administration and the purpose of ~~matching of any funds made available by~~  
6 ~~political subdivisions or airport authorities of this state, the state, or the United States, only~~  
7 providing up to ninety percent of the project costs if the political subdivision or airport authority  
8 is not qualified for or does not receive any funds under section 2-05-06.5. These funds must be  
9 used for airport construction or improvement projects, including airport administration and  
10 terminal buildings, hangars, landing strips for aircraft, and purchase of sites for airports or  
11 landing fields and easements and for maintenance, clearing of sites, marking, lighting, and  
12 engineering and navigational aids, all related to aeronautics in amounts as the commission may  
13 determine and upon projects as the commission may approve.

14           **SECTION 3. EXPIRATION DATE.** Section 2 of this Act is effective through June 30,  
15 2011, and after that date is ineffective.
