1 A concurrent resolution to create and enact a new section to article XI of the Constitution of

2 North Dakota, relating to freedom of choice in health care.

STATEMENT OF INTENT

4 This measure would prohibit any law from compelling any individual to purchase health

5 insurance or compelling any individual, employer, or health care provider to participate in any

6 health care system, would allow an individual or employer to pay directly for health care service,

7 and would allow a health care provider to accept direct payment for health care services.

8 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF NORTH DAKOTA, THE 9 SENATE CONCURRING THEREIN:

10 That the following proposed new section to article XI of the Constitution of North Dakota is

agreed to and must be submitted to the qualified electors of North Dakota at the primary

12 election in 2012, in accordance with section 16 of article IV of the Constitution of North Dakota.

SECTION 1. A new section to article XI of the Constitution of North Dakota is created and
enacted as follows:

15 <u>1.</u> <u>A law or rule may not compel any individual to purchase any individual or group health</u>

16 <u>insurance policy or product or compel any individual, employer, or health care provider</u>

17 <u>to participate in any health care system. An individual or an employer may pay directly</u>

18 for lawful health care services and may not be required to pay a penalty or fine for

19 paying directly for lawful health care services. A health care provider may accept direct

- 20 payment for lawful health care services and may not be required to pay a penalty or
- 21 fine for accepting direct payment from an individual or employer for lawful health care
- 22 services. Subject to reasonable and necessary rules that do not substantially limit
- 23 <u>options, the purchase or sale of health insurance in a private health care system may</u>
- 24 <u>not be prohibited by law.</u>
- 25 <u>2.</u> <u>This section does not:</u>

3		<u>b.</u>	Affect which health care services are permitted by law.
4		<u>C.</u>	Prohibit care provided under the workers' compensation laws of this state.

6		<u>e.</u>	Affect the terms or conditions of any health care system to the extent those terms
7			or conditions do not have the effect of punishing an individual or employer for

11		<u>f.</u>	Prohibit the establishment of a state court order for support of a child which
12			includes health insurance coverage or other medical support provisions, or the
13			enforcement of that order, and does not affect or prohibit any law or rule relating
14			to that order.
15	<u>3.</u>	For	the purposes of this section:
16		<u>a.</u>	"Compel" includes imposing a penalty or fine.
17		<u>b.</u>	"Direct payment" or "pay directly" means payment for lawful health care services
18			without a public or private third party, not including an employer, paying for any
19			portion of the service.
20		<u>C.</u>	"Health care system" means any public or private entity that has the function or
21			purpose of managing, processing, or enrolling individuals for or payment for
22			health care services, data, or information for its participants.
23		<u>d.</u>	"Lawful health care services" means any health-related service or treatment to
24			the extent the service or treatment is permitted or not prohibited by law which
25			may be provided by individuals or health care providers authorized to provide the
26			service or treatment.
27		<u>e.</u>	"Penalty or fine" means any civil or criminal penalty or fine, tax, salary or wage
28			withholding or surcharge, or any other fee with a similar effect which is
20			established by low or rule by a government agency and which is used to punish
