This Bill licenses veterinary dispensing outlets and registers veterinary dispensing technicians, to make legal what appears to be going on in the industry at present. The license and registration fees will cover the inspections and continuing education audit requirements.

NDCC 43-15.4-03 is the licensing provision that accounts for the revenue on the licensees and 43-15.4-06 accounts for the registration fees on the technicians.

We estimate 30 Veterinary technicians at \$35 each accounting for \$2,100 per biennium.
