- 1 A BILL for an Act to amend and reenact sections 39-04-36 and 39-04-39.2 of the North Dakota
- 2 Century Code, relating to the return of vehicle registration fees; and to provide an effective date.

## 3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 4 **SECTION 1. AMENDMENT.** Section 39-04-36 of the North Dakota Century Code is amended and reenacted as follows:
  - 39-04-36. Transfer of registered vehicle Removal of number plates Transfer of number plates.
    - Whenever the ownership of a vehicle registered under the provisions of this chapter or chapter 39-18 is transferred or assigned, the registration of the vehicle expires and the transferor shall remove the number plates.
    - Upon applying for the transfer of the registration and paying a five dollar fee, a person who transfers or assigns to another person the ownership of a registered vehicle may receive credit for the unused portion of the fees paid for the transferred vehicle. The transferor must use a number plate previously removed pursuant tounder subsection 1, regardless of whether there is any license fee credit remaining. If the number plate has become lost, stolen, or mutilated, the transferor may apply for duplicate plates. The department may establish procedures that permit the transferor to assign the credit to the transferee if the transferor is the spouse, a sibling, or a lineal ancestor or descendant of the transferee. Any remaining credit on a vehicle owned by a leasing company must be credited to the lessee. One twelfthAfter the month of the transfer, one-twelfth of the annual fee must be credited for each month of the remaining registration period remaining after the month in which the transfer is made. The credit may not extend beyond the original expiration of the registration. Except asfor a refund provided in section 39-04-44 or this section, the credit must be applied

- to the registration fees for a replacement vehicle. The transferor shall apply for the transfer of registration within thirty days of the purchase of the replacement vehicle.
  - 3. Upon an application, the payment of a fivetwenty dollar fee, and the return of the number plates to the department, a person may apply for a refund of registration fees on the transfer of a vehicle if there is not a replacement vehicle for which to transfer a credit. After the month of the transfer, one-twelfth of the annual fee must be refunded for each month of the remaining registration period. The applicant for a refund shall apply for the refund within thirty days of the transfer of the vehicle.
    - Except as otherwise permitted in this chapter, before the transferee of a registered vehicle may operate the vehicle on a highway, the transferee must apply for and obtain a new registration of the vehicle, as on an original registration. To provide the transferee adequate time to obtain a new registration, the director may provide for the issuance of a temporary registration certificate to permit the transferee to operate the vehicle for thirty days after the date of acquisition. The certificate must be printed on the reverse side of each vehicle registration card and must be available to the transferee from licensed vehicle dealers, law enforcement agencies, and motor vehicle branch offices. The vehicle may be operated for five days from date of purchase without a plate or certificate of ownership if dated evidence of ownership is carried in the vehicle. The evidence of ownership must be in a form as prescribed by the department.

**SECTION 2. AMENDMENT.** Section 39-04-39.2 of the North Dakota Century Code is amended and reenacted as follows:

39-04-39.2. Refunds of registration fees.

No refunds A refund of registration fees may <u>not</u> be made, except when <u>unless</u> the vehicle has been <u>transferred</u> and a credit is not used, the vehicle has been improperly registered, or when the vehicle has been destroyed.

**SECTION 3. EFFECTIVE DATE.** This Act becomes effective on July 1, 2014.
