1 A BILL for an Act to create and enact a new section to chapter 20.1-02, two new subsections to
2 section 20.1-03-12, and a new section to chapter 20.1-03 of the North Dakota Century Code,
3 relating to depredation kill permits for geese and an early Canada goose season; to amend and
4 reenact section 20.1-03-07.1 of the North Dakota Century Code, relating to the early Canada
5 goose season; and to declare an emergency.

6 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

7 **SECTION 1.** A new section to chapter 20.1-02 of the North Dakota Century Code is created
8 and enacted as follows:

9 **Canada goose depredation kill permits.**

10 The department shall implement a web-based online application process for Canada goose
11 kill permits, publicize in select agricultural publications and trade journals the availability of
12 Canada goose kill permits, and implement a program to match volunteers with agricultural
13 producers with kill permits.

14 **SECTION 2. AMENDMENT.** Section 20.1-03-07.1 of the North Dakota Century Code is
15 amended and reenacted as follows:

16 **20.1-03-07.1. (~~Effective through July 31, 2013~~) Nonresident waterfowl hunting license**
17 **required.**

18 1. Except as provided in sections 20.1-02-05, 20.1-03-07.2, and 20.1-03-07.3, a
19 nonresident may not hunt waterfowl unless that individual first obtains a nonresident
20 waterfowl hunting license. However, a nonresident may hunt cranes after first
21 obtaining a nonresident waterfowl hunting license or a nonresident small game hunting
22 license.

23 2. Except as otherwise provided in this section, the nonresident waterfowl hunting license
24 entitles the nonresident to hunt waterfowl for any period of fourteen consecutive days

1 or any two periods of seven consecutive days each. A license authorizing the
2 fourteen-day hunting period allows hunting in a specified waterfowl hunting zone. A
3 license authorizing two 7-day hunting periods allows hunting in a specified zone during
4 each period.

5 3. Upon payment of the fee for a statewide nonresident waterfowl hunting license, a
6 nonresident may hunt waterfowl in any zone. Forty dollars of the fee for a statewide
7 nonresident waterfowl license must be used for the private land open to sportsmen
8 program.

9 4. The governor, in the governor's proclamation, shall specify various waterfowl hunting
10 zones for which nonresident waterfowl hunting licenses will be available, and may
11 specify the number of licenses which may be issued in each zone and the manner in
12 which they are to be issued.

13 5. A nonresident is entitled to purchase only one nonresident waterfowl hunting license
14 per year.

15 6. The fourteen-day and two 7-day hunting period restrictions do not apply to
16 nonresidents hunting in Richland and Sargent Counties or in Benson, Ramsey, or
17 Towner Counties during the early September Canada goose season.

18 **~~(Effective after July 31, 2013) Nonresident waterfowl hunting license required.~~**

19 ~~Except as provided in sections 20.1-02-05, 20.1-03-07.2, and 20.1-03-07.3, a nonresident~~
20 ~~may not hunt waterfowl unless that individual first obtains a nonresident waterfowl hunting~~
21 ~~license. However, a nonresident may hunt cranes after first obtaining a nonresident waterfowl~~

30 ~~The governor, in the governor's proclamation, shall specify various waterfowl hunting zones for~~
31 ~~which nonresident waterfowl hunting licenses will be available, and may specify the number of~~

1 ~~licenses which may be issued in each zone and the manner in which they are to be issued. A~~
2 ~~nonresident is entitled to purchase only one nonresident waterfowl hunting license per year.~~

3 **SECTION 3.** A new section to chapter 20.1-03 of the North Dakota Century Code is created
4 and enacted as follows:

5 **Early Canada goose season.**

6 A resident or nonresident may purchase an early Canada goose license to hunt geese
7 during an early season as determined by the governor by proclamation. The governor by
8 proclamation may specify the number of licenses that may be issued and the manner in which
9 the licenses are issued. A nonresident is not required to purchase any other license to hunt
10 Canada geese during an early Canada goose season. A nonresident is not entitled to more than
11 one nonresident early Canada goose season license and still may obtain a nonresident
12 waterfowl hunting license under section 20.1-03-07.1.

13 **SECTION 4.** A new subsection to section 20.1-03-12 of the North Dakota Century Code is
14 created and enacted as follows:

15 For a nonresident early Canada goose season license, fifty dollars.

16 **SECTION 5.** A new subsection to section 20.1-03-12 of the North Dakota Century Code is
17 created and enacted as follows:

18 For a resident early Canada goose season license, five dollars.

19 **SECTION 6. EMERGENCY.** This Act is declared to be an emergency measure.
