## ENGROSSED SENATE BILL NO. 2009

Introduced by

Appropriations Committee

(At the request of the Governor)

1 A BILL for an Act to provide an appropriation for defraying the expenses of the state fair  
2 association; and to declare an emergency.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds  
5 as may be necessary, are appropriated out of any moneys in the general fund in the state  
6 treasury, not otherwise appropriated, to the state fair association for the purpose of defraying  
7 the expenses of the state fair association, for the biennium beginning July 1, 2013, and ending  
8 June 30, 2015, as follows:

17 **SECTION 2. ONE-TIME FUNDING - EFFECT ON BASE BUDGET - REPORT TO**

18 **SIXTY-FOURTH LEGISLATIVE ASSEMBLY.** The following amounts reflect the one-time  
19 funding items approved by the sixty-second legislative assembly for the 2011-13 biennium and  
20 the 2013-15 one-time funding items included in the appropriation in section 1 of this Act:

3 The 2013-15 one-time funding amounts are not part of the entity's base budget for the 2015-17  
4 biennium. The state fair association shall report to the appropriations committees of the  
5 sixty-fourth legislative assembly on the use of the one-time funding for the biennium beginning  
6 July 1, 2013, and ending June 30, 2015.

7 **SECTION 3. EMERGENCY.** The capital assets line item in section 1 of this Act is declared  
8 to be an emergency measure.
