**Bismarck, December 4, 2012**

The Senate convened at 9:00 a.m., with President Wrigley presiding.

The prayer was offered by Pastor Paul Gibson of First Baptist Church, Bismarck.

The roll was called and all members were present except Senators Anderson and G. Lee.

A quorum was declared by the President.

**MOTION**

**REMARKS OF MAJORITY LEADER WARDNER**

**REMARKS OF MINORITY LEADER SCHNEIDER**
