## REMARKS OF SENATOR KREBSBACH

**MR. PRESIDENT:** Yesterday, the state of North Dakota and the city of Minot lost a dear friend. A man larger than life -- both in stature and in his achievements and contributions to this world. Chester M. Reiten, at the age of 89, passed away with his loving wife, whom he often times referred to as "My very good friend Joy", at his side.

Chester was a farm boy, a US Navy veteran, a graduate of North Dakota State University, and worked as a County Extension Agent in Wells County before entering the radio and television world. He founded the KX Network with stations in Minot, Bismarck, Dickinson and Williston. The television stations are still in the family today under the operation of his children.

Chester served in this body, the North Dakota Senate from 1972-1988, and filled the seat of District 40/50. He served as Chairman of the Industry, Business and Labor Committee. His booming voice could be heard well within these walls. He served as Mayor of Minot for 14 years, and much of this while he was a state senator.

One of his great accomplishments was the Norsk Hostfest, which this past fall celebrated its 35th year of bringing national and international acclaim to the state. This event has brought thousands of international visitors to North Dakota and has created many lasting friendships through the years.

One of the greatest honors for Chester was his induction into the Theodore Roosevelt Roughrider Hall of Fame. His picture hangs in the ground floor of the Capitol along with other great North Dakotans.

A true entrepreneur, developer, promoter - but most importantly a good, decent citizen was Chester. He truly will be missed.

APPROPRIATION.** There is appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, the sum of \$300,000, or so much of the sum as may be necessary, to the department of human services for the purpose of funding early childhood services specialists pursuant to section 50-11.1-18, for the biennium beginning July 1, 2013, and ending June 30, 2015.
  - **SECTION 7. CONTINGENT APPROPRIATION.** If the changes in the eligibility and copay requirements for the child care assistance program as contained in section 8 of this Act require more funding than the amounts appropriated to the department of human services in House Bill No. 1012, as approved by the sixty-third legislative assembly, for the child care assistance program for the 2013-15 biennium, there is appropriated out of any moneys in the general fund in the state treasury, not

otherwise appropriated, the sum of \$2,500,000, or so much of the sum as may be necessary, to the department of human services for the purpose of implementing the changes contained in section 8 of this Act, for the biennium beginning July 1, 2013, and ending June 30, 2015. If the changes in section 8 of this Act can be implemented within the child care assistance program appropriation appropriated to the department of human services in House Bill No. 1012, as approved by the sixty-third legislative assembly, for the child care assistance program for the 2013-15 biennium, or requires less than the \$2,500,000 provided in this section, up to \$1,000,000 of the \$2,500,000 appropriated in this section may be used by the department of human services to provide child care provider incentive grants pursuant to section 50-11.1-14.1.

SECTION 8. LEGISLATIVE INTENT - CHILD CARE ASSISTANCE PROGRAM - REPORT TO THE LEGISLATIVE MANAGEMENT. It is the intent of the legislative assembly that the department of human services change the eligibility requirement for the child care assistance program from fifty percent of the state median income to eighty-five percent of the state median income. Beginning July 1, 2014, if the funding appropriated to the department of human services in House Bill No. 1012, as approved by the sixty-third legislative assembly, and in section 7 of this Act for the child care assistance program is sufficient, the department of human services may reduce copay requirements for the child care assistance program. The department of human services shall report the impact of these changes to the legislative management.

**SECTION 9. APPLICATION.** Section 4 of this Act does not apply to a child care center operator who has maintained a license since before January 1, 1999.

**SECTION 10. EXPIRATION DATE.** Sections 4 and 9 of this Act are effective until the date the administrative rules containing the requirements of section 4 of this Act on maximum group size of children in a child care center take effect. The department of human services shall certify to the legislative council the date those rules will take effect, and as of that date sections 4 and 9 of this Act become ineffective."
