## **REENGROSSED SENATE BILL NO. 2107**

- 1 A BILL for an Act to create and enact chapter 12.1-41 of the North Dakota Century Code,
- 2 relating to the Uniform Act on Prevention of and Remedies for Human Trafficking; to amend and
- 3 reenact subsection 1 of section 12.1-32-15 of the North Dakota Century Code, relating to
- 4 definitions; to repeal chapter 12.1-40 of the North Dakota Century Code, relating to human
- 5 trafficking; and to provide a penalty.

## 6 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

7	SECTION 1. AMENDMENT. Subsection 1 of section 12.1-32-15 of the North Dakota

A recipient of a grant or contract under subsection 1 shall report annually to the 22 attorney general the number and demographic information of all victims receiving 23 services under the grant or contract. 24 12.1-41-20. Use of public funds for abortions prohibited. 25 Except as provided by federal law, funds of this state or a political subdivision of this state 26 and federal funds passing through the state treasury or a state agency to provide treatment and 27 support services for victims of human trafficking may-not be used to refer for or counsel in favor-
- 28 <u>of abortion</u>for family planning services, but may not be used to perform, refer for, or encourage
  29 abortion.
