1	A BILL for an Act to amend and reenact section 5-01-08 of the North Dakota Century Code,		
2	relating to the age of consumption of alcoholic beverages by military personnel on military		
3	installations.		
4	BE IT E	NAC	TED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:
5	SECTION 1. AMENDMENT. Section 5-01-08 of the North Dakota Century Code is amended		
6	and reenacted as follows:		
7	5-01-08. Individuals under twenty-one years of age prohibited from using alcoholic		
8	beverages or entering licensed premises <u>- Exception</u> - Penalty.		
9	1.	Exc	cept as permitted in this section and section 5-02-06, an individual under
10		twe	nty-one years of age may not manufacture or attempt to manufacture, purchase or
11		atte	empt to purchase, consume or have recently consumed other than during a
12		reli	gious service, be under the influence of, be in possession of, or furnish money to
13		any	individual for the purchase of an alcoholic beverage.
14	2.	An	individual under twenty-one years of age may not enter any licensed premises
15		whe	ere alcoholic beverages are being sold or displayed, except:
16		a.	A restaurant if accompanied by a parent or legal guardian;
17		b.	In accordance with section 5-02-06;
18		C.	If the individual is an independent contractor or the independent contractor's
19			employee engaged in contract work and is not engaged in selling, dispensing,
20			delivering, or consuming alcoholic beverages;
21		d.	If the individual is a law enforcement officer or other public official who enters the

premises in the performance of official duty; or

1 If the individual enters the premises for training, education, or research purposes 2 under the supervision of an individual twenty-one or more years of age with prior 3 notification of the local licensing authority. 4 3. Notwithstanding any other provision of law, an individual at least eighteen years of age 5 who is a current member of the active uniformed services of the United States, may 6 purchase and consume alcoholic beverages within the boundaries of a military 7 installation in this state if the purchase and consumption of alcoholic beverages by 8 individuals between the ages of eighteen and twenty-one is authorized by the 9 commanding officer of the military installation. 10 <del>3.</del>4. A violation of this section is a class B misdemeanor. For a violation of subsection 2, 11 the court also shall sentence a violator to alcohol and drug education. 12 <del>4.</del>5. The court, under this section, may refer the individual to an outpatient addiction facility 13 licensed by the department of human services for evaluation and appropriate 14 counseling or treatment. 15 <del>5.</del>6. The offense of consumption occurs in the county of consumption or the county where 16 the offender is arrested. 17 <del>6.</del>7. An individual under twenty-one years of age is immune from criminal prosecution 18 under this section if that individual contacted law enforcement or emergency medical 19 services and reported that another individual under twenty-one years of age was in 20 need of medical assistance due to alcohol consumption, provided assistance to the 21 individual in need of medical assistance until assistance arrived and remained on the

scene, or was the individual in need of medical assistance and cooperated with

medical assistance and law enforcement personnel on the scene. The maximum

number of individuals that may be immune for any one occurrence is five individuals.
