- 1 A BILL for an Act to create and enact a new section to chapter 23-27, a new section to chapter
- 2 26.1-36, and section 65-02-21.2 of the North Dakota Century Code, relating to air ambulance
- 3 services and classifications of ambulance services for health insurance and workers'
- 4 compensation benefits; and to amend and reenact section 50-24.1-16 of the North Dakota
- 5 Century Code, relating to classification of ambulance services for medical assistance.

## 6 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 7 SECTION 1. A new section to chapter 23-27 of the North Dakota Century Code is created
- 8 and enacted as follows:
- 9 Air ambulance services.
  10 <u>1.</u> The department shall create and maintain a primary call list and a secondary call list of air ambulance service providers operating in this state.
- 12 <u>2.</u> <u>To qualify to be listed on the primary call list, an air ambulance service provider shall</u>
- 13 <u>submit to the department attested documentation indicating the air ambulance service</u>
- 14 provider is a participating provider of the health insurance carriers in the state which
- 15 <u>collectively hold at least seventy-five percent of the health insurance coverage in the</u>
   16 <u>state as determined by annual market share reports.</u>
- 17 <u>3.</u> <u>The department shall provide the primary call list and the secondary call list for air</u>
- 18 <u>ambulance service providers operating in this state to all emergency medical services</u>
- 19 personnel, each hospital licensed under chapter 23-16, each 911 coordinator in this
- 20 <u>state, and each public safety answering point operating in this state.</u>
- 21 4. <u>The department shall establish air ambulance service response zones for rotary wing</u>
   22 <u>aircraft which are based on response times and patient health and safety.</u>
