- 1 A BILL for an Act to create and enact section 49-23-04.1 of the North Dakota Century Code,
- 2 relating to survey of areas having underground facilities; to amend and reenact sections
- 3 49-23-01, 49-23-03, 49-23-04, 49-23-05, and 49-23-06 of the North Dakota Century Code,
- 4 relating to location of underground facilities before excavation; and to provide a penalty.

5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 6 **SECTION 1. AMENDMENT.** Section 49-23-01 of the North Dakota Century Code is 7 amended and reenacted as follows:
- 8 **49-23-01. Definitions.**
- 9 As used in this chapter, unless the context otherwise requires:
- "Abandoned" means no longer in service and physically disconnected from a portion
 of the facility or from any other facility that is in use or still carries services.
- 12 2. "Board" means the board of directors of the nonprofit corporation governing the notification center under section 49-23-03.
- 14 3. "Careful and prudent manner" means:
 - <u>a.</u> <u>Manually</u> excavating within twenty-four inches [60.96 centimeters] of the outer edges of <u>anany</u> underground facility <u>on a horizontal plane as</u> located manually and marked by the owner or operator by stakes, paint, or other customary manner; and <u>supporting</u>
- 19 <u>b. Supporting</u> and protecting the uncovered facility.
- 4. "Damage" means:

- Substantial weakening of structural or lateral support of an underground facility;
- b. Penetration, impairment, or destruction of any underground protective coating,
 housing, or other protective device; or

- 1 c. Impact with or the partial or complete severance of an underground facility to the extent that the facility operator determines that repairs are required.
 - 5. "Emergency" means a sudden, unexpected occurrence, involving a clear and imminent danger, and demanding immediate action to prevent or mitigate loss of, or damage to, life, health, property, or essential public services.
 - "Emergency responder" means a fire department, a law enforcement officer, or other emergency rescue service.
 - 7. "Excavation" means any operation in which earth, rock, or other materials in or below the ground is moved or otherwise displaced by means of hand or power tools, power equipment, or explosives and includes grading, trenching, digging, ditching, drilling, augering, tunneling, boring, scraping, and cable or pipe plowing and driving. The term does not include:
 - a. Opening a grave in a cemetery.
 - Plowing, cultivating, planting, harvesting, and similar operations in connection with agricultural activities, unless any of these activities disturbs the soil to a depth of eighteen inches [45.72 centimeters] or more.
 - c. Gardening and landscaping unless it disturbs the soil to a depth of twelve inches [30.48 centimeters] or more.
 - Normal maintenance of roads and streets if the maintenance does not change the original grade and does not involve the road ditch.
 - e. Normal repair and maintenance of track and track bed by a railroad on its own right of way.
 - 8. "Excavator" means a person who conducts excavation.
- 9. "Holiday" means New Year's Day, Martin Luther King Day, Presidents' Day, Good
 Friday, Memorial Day, Independence Day, Labor Day, Columbus Day, Veterans' Day,
 Thanksgiving Day, and Christmas Day. When a holiday falls on a Saturday, it is
 observed on the preceding Friday as if the Friday were the actual holiday, and when a
 holiday falls on a Sunday, it is observed on the following Monday as if the Monday
 were the actual holiday.
 - 10. "Local governmental unit" means a county, township, or city.

1 "Locate" means an operator's markings of an underground facility showing the 2 approximate horizontal location, including all lines, line direction, intersections, tees, 3 and lateral facilities. 4 12. "Locate period" means the later of: 5 The forty-eight hour period beginning at midnight of the day the location request 6 was submitted to the notification center; excluding any Saturday, Sunday, or 7 holiday; and any twenty-four hour extension provided through the notification 8 center; or 9 The period between the submission of a location request to the notification center <u>b.</u> 10 and the noted date of excavation. 11 <u>13.</u> "Nonprofit corporation" means a corporation established under chapter 10-33. 12 13.14. "Notification center" means a center that receives notice from an excavator of planned 13 excavation or any other request for location and transmits this notice to a participating 14 operator. 15 14.15. "Operator" means a person who owns or operates an underground facility, including a 16 master meter operator with underground facilities, or a state or local governmental 17 entity. The department of transportation is considered an operator for the department's 18 facilities buried on the department's rights of way. A person is not considered an 19 operator solely because the person is an owner or tenant of real property where 20 underground facilities are located if the underground facilities are used exclusively to 21 furnish services or commodities on that property. 22 "Positive response" means notification by the operator to the notification center that 16. 23 underground facilities within the area covered by a location request have been marked 24 or cleared. 25 15.17. "Tangible marking materials" means any material perceptible by touch used to mark 26 the location of an underground facility, including flags, stakes, poles, or other materials 27 inserted into or affixed to the ground. The term does not include paint, chalk, or other 28 liquid ink-based materials applied to the ground. 29 "Underground facility" means an underground line, pipeline, cable, facility, system, and 16.18. 30 its appurtenances used to produce, store, convey, gather, transmit, or distribute 31 communications, data, electricity, power, television signals, heat, gas, oil, petroleum

1		products, carbon dioxide, water, steam, sewage, hazardous liquids, and other similar			
2		substances. Privately owned and operated underground facilities which do not extend			
3		beyond the boundary of the private property are excluded.			
4	17. <u>19.</u>	"Unexpected occurrence" includes a fire, flood, earthquake or other soil or geologic			
5		movement, riot, accident, damage to a subsurface installation requiring immediate			
6		repair, or sabotage.			
7	18. <u>20.</u>	"Water" includes potable water, wastewater, and storm water.			
8	SEC	TION 2. AMENDMENT. Section 49-23-03 of the North Dakota Century Code is			
9	amende	d and reenacted as follows:			
10	49-2	3-03. Notification center - Participation - Establishment.			
11	1.	An operator shall participate in and share in the costs of the statewide notification			
12		center operated by a vendor selected under this section.			
13	2.	An excavator licensed under this chapter shall participate in and share in the costs of			
14		a statewide notification center on a per-call basis. An operator, installing the operator's			
15		own facilities, may not be charged as an excavator.			
16	3.	An operator shall participate in and share the costs of the one-call excavation notice			
17		system by:			
18		a. Submitting the information required by the notification center to allow the center			
19		to notify the operator of excavation activity;

An operator may submit a bid and be selected to 13 contract to provide the notification center service. 14 Members of the board and any of its agents are immune from any liability of any C. 15 kind based on any acts or omissions in the course of the performance of 16 responsibilities in an official capacity except for bodily injury arising out of 17 accidents caused by or contributed to by the negligence of the board member or 18 agent. 19 The board shall aid the state's attorneys of the various counties in the d. 20 enforcement of this chapter and the prosecution of any violations. - 1 An operator, within forty-eight hours, or any extension of that period, after 3.6. a. 2 receiving an excavation notice from the center, excluding Saturdays, Sundays, 3 and holidays, unless otherwise agreed to between the excavator and operator, 4 shall locate and mark or otherwise provide the approximate horizontal location of 5 the underground facilities of the operator with underground facilities within the 6 area of a location request shall locate and mark or otherwise provide the 7 approximate horizontal location of the underground facilities of the operator within 8 the location period or as agreed by the parties.
 - b. For purposes of this section, the approximate horizontal location of the underground facilities is a strip of land two feet [60.96 centimeters] on either side of the underground facilities. An operator of a facility required to be locatable is responsible for the costs of location. If an excavator is unable to locate a facility within two feet on either side of the operator's facility location markings, the operator is responsible for reasonable costs incurred to locate the facility. This subdivision does not apply to an underground facility to convey water installed before August 1, 2013.
 - c. When an operator cannot establish the exact location of the underground facility to convey water, the operator shall mark the location as accurately as possible and the excavator may proceed with caution. When excavation operations approach the estimated location of the underground facility to convey water, the exact location of the facility must be determined by safe and acceptable means. The uncovered facility must be supported and protected to prevent damage.
 - d. Markers used to designate the approximate location of underground facilities must follow the current color code standard used by the American public works association.
 - e. If the operator cannot complete marking of the excavation area before the excavation commencement time stated in the excavation notice, the operator shall promptly contact the excavator.
 - f. After facilities are located by an operator, an excavator shall notify the notification center if:

1 The excavator postpones the excavation commencement time stated in the (1) 2 excavation notice by more than forty-eight hours, or any extension of that 3 period, or cancels the excavation; 4 (2) The markings have been obliterated or obscured; 5 Weather conditions have impeded visibility of the markings; (3) 6 (4) The site shows evidence of recent excavation; or 7 The excavator has other reason to believe the markings are incorrect or (5) 8 missing. 9 An excavator may not use a location more than twenty-one days, or any g. 10 extension of that period, after the planned excavation date unless the excavator 11 has made previous arrangements with the operators affected. 12 h. If excavation has not occurred within the initial twenty-one days of the locate, the 13 excavator shall request that the facility be relocated before excavating unless 14 other arrangements have been made with the underground facility owner. Upon 15 the third locate request at the same excavation site where no excavation has 16 occurred after the initial two locates, the excavator is responsible for reasonable 17 costs associated with relocating facilities in that location. If the issue of whether 18 excavation has occurred is disputed for purposes of this section, the excavator 19 bears the burden of proof that excavation has occurred. 20 If a relocate request is made for an area which includes areas where excavation 21 has been completed, a request for relocate must be modified from the original 22 locate request to reflect only the area to be excavated during each subsequent 23 twenty-one-day period, otherwise the excavator is responsible for reasonable 24 costs associated with relocating facilities in the location. 25 An excavator that makes repeated location requests within the area of a 26 previously made location request due to the excavator's failure to reasonably 27 maintain and remove markings under subsection 3 of section 49-23-05 or failure 28 to follow prudent and careful digging practices required by subsection 5 of 29 section 49-23-05 is responsible for reasonable costs of location and removal if 30 the public service commission determines the additional location request was

caused by the excavator's failure described in this subdivision.

- SECTION 5. AMENDMENT. Section 49-23-05 of the North Dakota Century Code is
 amended and reenacted as follows:
- 9 **49-23-05.** Precautions to avoid damage.
 - To avoid damage to and minimize interference with underground facilities in and near the constructionexcavation area, an excavatora ticket holder shall:
 - Maintain a clearance between an underground facility and the cutting edge or point of any mechanized equipment, considering the known limit of control of the cutting edge or point to avoid damage to the facility.
 - Provide support in a manner approved by the operator for underground facilities in and near the construction area, including backfill operations to protect the facilities. Backfill must be of a material equal to or better in both quality and quantity to the existing backfill.
 - 3. Assume ownership of materials used to mark the facility, use reasonable efforts to maintain markings during excavation, and remove all tangible marking materials used to mark the <u>underground</u> facility <u>and site area</u> upon completion of the excavation.
- 4. Assume the cost of excavation to expose the facility unless otherwise indicated by
 owner of facility.
- 5. Conduct the excavation in a careful and prudent manner.
- 25 6. Properly manage spoil material to prevent shifting or falling material that could damage belowground facilities.
- 27 **SECTION 6. AMENDMENT.** Section 49-23-06 of the North Dakota Century Code is amended and reenacted as follows:
- 29 49-23-06. Damage to facilities Penalty.
- 30 1. a. If any damage occurs to an underground facility or its protective covering, the excavator shall notify the operator as soon as reasonably possible. When the

1 operator receives a damage notice, the operator shall dispatch, as soon as 2 reasonably possible, personnel to the damage area to investigate. If the damage 3 endangers life, health, or property, the excavator responsible for the work shall 4 take immediate action to protect the public and property and to minimize the 5 hazard until arrival of the operator's personnel or until emergency responders 6 have arrived and taken charge of the damaged area. 7 An excavator shall delay backfilling in the immediate area of the damaged b. 8 underground facilities until the damage has been investigated by the operator, 9 unless the operator authorizes otherwise. The repair of damage must be 10 performed by the operator or by qualified personnel authorized by the operator. 11 An excavator who knowingly is quilty of a class A misdemeanor if: 12 The excavator willfully damages an underground facility and who; 13 (2)The excavator knew or reasonably should have known damage occurred to 14 an underground facility or its protective covering and does not notify the 15 operator as soon as reasonably possible; or who 16 The excavator backfills in violation of subdivision b is quilty of a class A <u>(3)</u> 17 misdemeanor. 18 2. a. If an excavator fails to comply with this chapter or damages an underground 19 facility, the excavator is liable for all damages caused by the failure to comply 20 with this chapter and for all damages to the facilities and must reimburse the 21 operator for the cost of location, repair and restoration, loss of product, and 22 interruption of service occurring because of the damage or injury to the facilities, 23 together with reasonable costs and expenses of suit, including reasonable 24 attorney's fees. 25 b. Reimbursement to the operator under this subsection is not required if the 26 damage to the underground facility was caused by the sole negligence of the 27 operator or the operator failed to comply with sections 49-23-03 and 49-23-04.
