ENGROSSED SENATE BILL NO. 2035**

1 A BILL for an Act to create and enact a new section to chapter 57-39.2 of the North Dakota
2 Century Code, relating to a sales tax exemption for tangible personal property used to construct
3 a fertilizer or chemical processing facility; to amend and reenact section 40-57.1-03 and
4 subsection 4 of section 57-40.2-03.3 of the North Dakota Century Code, relating to
5 requirements of a city or county granting a property tax exemption and a use tax exemption for
6 tangible personal property used to construct a fertilizer or chemical processing facility; to
7 provide for studies by the legislative management and industrial commission; and to provide for
8 a retroactive effective date.

9 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

10 **SECTION 1. AMENDMENT.** Section 40-57.1-03 of the North Dakota Century Code is
11 amended and reenacted as follows:

12 ~~40-57.1-03. (Effective for the first taxable year beginning after December 31, 2013)~~

13 ~~Municipality's authority to grant or revoke tax exemption or payments in lieu of taxes --~~

14 ~~Notice to competitors -- Limitations.~~

15 1. ~~After negotiation with a potential project operator, a municipality may grant a partial or~~
16 ~~complete exemption from ad valorem taxation on all buildings, structures, fixtures, and~~
17 ~~improvements used in or necessary to the operation of a project for a period not~~
18 ~~exceeding five years from the date of commencement of project operations. A~~
19 ~~municipality may also grant a partial or complete exemption from ad valorem taxation~~
20 ~~on buildings, structures, fixtures, and improvements used in or necessary to the~~
21 ~~operation of a project that produces or manufactures a product from agricultural~~
22 ~~commodities for all or part of the sixth year through the tenth year from the date of~~
23 ~~commencement of project operations.~~

- 1 2. ~~In addition to, or in lieu of, a property tax exemption granted under this section, a~~
2 ~~municipality may establish an amount due as payments in lieu of ad valorem taxes on~~
3 ~~buildings, structures, fixtures, and improvements used in the operation of a project.~~
4 ~~The governing body of the municipality shall designate the amount of the payments for~~
5 ~~each year and the beginning year and the concluding year for payments in lieu of~~
6 ~~taxes, but the option to make payments in lieu of taxes under this section may not~~
7 ~~extend beyond the twentieth year from the date of commencement of project~~
8 ~~operations. To establish the amount of payments in lieu of taxes, the governing body~~
9 ~~of the municipality may use actual or estimated levels of assessment and taxation or~~
10 ~~may establish payment amounts based on other factors. The governing body of the~~
11 ~~municipality may designate different amounts of payments in lieu of taxes in different~~
12 ~~years to recognize future project expansion plans or other considerations.~~
- 13 3. ~~By November first of each year, the municipality that granted the option to make~~
14 ~~payments in lieu of taxes shall certify to the county auditor the amount of payments~~
15 ~~in lieu of taxes due under this section in the following year. After receiving the~~
16 ~~statement from the municipality, the county auditor shall certify the payments in lieu of~~
17 ~~taxes to the county treasurer for collection at the time when, and in the manner in~~
18 ~~which, ad valorem taxes must be certified. Upon receipt by the county treasurer of the~~
19 ~~amount of payments in lieu of taxes under this section, the county treasurer shall~~
20 ~~apportion and distribute that amount to taxing districts on the basis on which the~~
21 ~~general real estate tax levy is apportioned and distributed. The municipality may enter~~
22 ~~into a written agreement with the local school district and any other local taxing~~
23 ~~districts that wish to enter the agreement for an alternate method of apportionment~~
24 ~~and distribution. If such an agreement is entered into, the county treasurer shall~~
25 ~~apportion and distribute the money according to the written agreement. All provisions~~
26 ~~of law relating to enforcement, administration, collection, penalties, and delinquency~~
27 ~~proceedings for ad valorem taxes apply to payments in lieu of taxes under this section.~~
28 ~~However, the discount for early payment of taxes under section 57-20-09 does not~~
29 ~~apply to payments in lieu of taxes under this section. The buildings, structures,~~
30 ~~fixtures, and improvements comprising a project for which payments in lieu of taxes~~

1 are allowed under this section must be excluded from the valuation of property in the
2 taxing district for purposes of determining the mill rate for the taxing district.

- 3 4. ~~Negotiations with potential project operators for tax exemption or payments in lieu of~~
4 ~~taxes must be carried on by the city council or commission if the project is proposed to~~
5 ~~be located within the boundaries of a city, and by the board of county commissioners if~~
6 ~~the project is proposed to be located outside the corporate limits of any city. A partial~~
7 ~~exemption must be stated as a percentage of the total ad valorem taxes assessed~~
8 ~~against the property. Unless the governing body of the municipality determines that~~
9 ~~there is no existing business within the municipality for which the potential project~~
10 ~~would be a competitor, the potential project operator shall publish two notices to~~
11 ~~competitors, the form of which must be prescribed by the tax commissioner, of the~~
12 ~~application for tax exemption or payments in lieu of taxes in the official newspaper of~~
13 ~~the municipality at least one week apart. The publications must be completed not less~~
14 ~~than fifteen nor more than thirty days before the governing body of the municipality is~~
15 ~~to consider the application. The municipality shall determine whether the granting of~~

5 ~~exemption or the option to make payments in lieu of taxes was approved.~~
- 6 6. ~~During the negotiation and deliberation of a property tax exemption or the option to~~
7 ~~make payments in lieu of taxes under this chapter, a municipality shall include, as~~
8 ~~nonvoting ex officio members of its governing body, a representative appointed by the~~
9 ~~school board of each school district affected by the proposed action and a~~
10 ~~representative appointed by the board of township supervisors of each township~~
11 ~~affected by the proposed action.~~

12 ~~(Effective for taxable years beginning after December 31, 2014) Municipality's~~
13 ~~authority to grant or revoke tax exemption or payments in lieu of taxes - Notice to~~
14 ~~competitors - Limitations.~~

- 15 1. After negotiation with a potential project operator, a municipality may grant a partial or
16 complete exemption from ad valorem taxation on all buildings, structures, fixtures, and
17 improvements used in or necessary to the operation of a project for a period not
18 exceeding five years from the date of commencement of project operations. A
19 municipality may also grant a partial or complete exemption from ad valorem taxation
20 on buildings, structures, fixtures, and improvements used in or necessary to the
21 operation of a project that produces or manufactures a product from agricultural
22 commodities for all or part of the sixth year through the tenth year from the date of
23 commencement of project operations. Before a municipality may grant a partial or
24 complete exemption from ad valorem taxation under this section:
- 25 a. The governing body of the municipality must have received the certification of the
26 department of commerce division of economic development and finance that the
27 project is a primary sector business, as defined in subsection 3 of section
28 40-57.1-02; or
- 29 b. The city council or commission, if the project is proposed to be located within the
30 boundaries of a city of fewer than forty thousand population, or the board of
31 county commissioners, of a county of fewer than forty thousand population and if

1 the project is proposed to be located in the county but outside the corporate limits
2 of any city, may grant a partial or complete exemption from ad valorem taxation
3 for a project operating in the retail sector if that governing body has obtained the
4 approval of exemption of property under this subdivision from a majority of the
5 qualified electors of the city or county voting on the question at a city or county
6 election held in conjunction with a statewide general election and if that
7 governing body has established by resolution or ordinance the criteria that will be
8 applied by the governing body to determine whether it is appropriate to grant a
9 partial or complete exemption from ad valorem taxation under this section for a
10 project operating in the retail sector. The ballot for elector approval of exemption
11 of property under this subdivision must present the question at the election for a
12 yes or no vote on the question:

13 Shall the governing body of [name of county or city] be empowered to grant
14 property tax exemptions upon application of new or expanding retail sector
15 businesses?

16 Only a governing body of a city or county that meets the requirements of this
17 subdivision may grant a partial or complete exemption from ad valorem taxation
18 under this section for a project operating in the retail sector. Criteria established
19 by the governing body under this subdivision, at a minimum, must be intended to
20 require:

- 21 (1) Evaluation of the potential positive or adverse consequences for existing
22 retail sector businesses in the municipality from granting the exemption;
- 23 (2) Evaluation of the short-term and long-term effects for other property
24 taxpayers in the municipality from granting the exemption;
- 25 (3) A written agreement with the project operator, including performance
26 requirements for which the exemption may be terminated by the governing
27 body of the municipality if those requirements are not met; and
- 28 (4) Evaluation of whether the project operator would locate the project within
29 the municipality without the exemption.

- 30 2. In addition to, or in lieu of, a property tax exemption granted under this section, a
31 municipality may establish an amount due as payments in lieu of ad valorem taxes on

1 buildings, structures, fixtures, and improvements used in the operation of a project.

2 The governing body of the municipality shall designate the amount of the payments for
3 each year and the beginning year and the concluding year for payments in lieu of
4 taxes, but the option to make payments in lieu of taxes under this section may not
5 extend beyond the twentieth year from the date of commencement of project
6 operations. To establish the amount of payments in lieu of taxes, the governing body
7 of the municipality may use actual or estimated levels of assessment and taxation or
8 may establish payment amounts based on other factors. The governing body of the
9 municipality may designate different amounts of payments in lieu of taxes in different
10 years to recognize future project expansion plans or other considerations.

11 3. Before a governing body may grant a partial or complete exemption from ad valorem
12 taxation or the option to make payments in lieu of ad valorem taxes under this chapter,
13 the governing body shall consult with the department of commerce. If the department
14 of commerce determines that the total project costs are estimated to exceed one
15 billion dollars, the department of commerce shall conduct a public hearing and notice
16 of that hearing must be provided to each affected taxing district and any existing
17 business within the municipality for which the potential project would be a competitor.

18 4. By November first of each year, the municipality that granted the option to make
19 payments in lieu of taxes shall certify to the county auditor the amount of payments
20 in lieu of taxes due under this section in the following year. After receiving the
21 statement from the municipality, the county auditor shall certify the payments in lieu of
22 taxes to the county treasurer for collection at the time when, and in the manner in
23 which, ad valorem taxes must be certified. Upon receipt by the county treasurer of the
24 amount of payments in lieu of taxes under this section, the county treasurer shall
25 apportion and distribute that amount to taxing districts on the basis on which the
26 general real estate tax levy is apportioned and distributed. The municipality may enter
27 into a written agreement with the local school district and any other local taxing
28 districts that wish to enter the agreement for an alternate method of apportionment
29 and distribution. If such an agreement is entered into, the county treasurer shall
30 apportion and distribute the money according to the written agreement. All provisions
31 of law relating to enforcement, administration, collection, penalties, and delinquency

1 proceedings for ad valorem taxes apply to payments in lieu of taxes under this section.
2 However, the discount for early payment of taxes under section 57-20-09 does not

6 the option to make payments in lieu of taxes was approved; or

7 d. There has been a change of ownership of the property since the property tax
8 exemption or the option to make payments in lieu of taxes was approved.

9 ~~6-7.~~ During the negotiation and deliberation of a property tax exemption or the option to
10 make payments in lieu of taxes under this chapter, a municipality shall include, as
11 nonvoting ex officio members of its governing body, a representative appointed by the
12 school board of each school district affected by the proposed action and a
13 representative appointed by the board of township supervisors of each township
14 affected by the proposed action.

15 ~~7-8.~~ A city or county may not supersede or expand the provisions of this section under
16 home rule authority.

17 **SECTION 2.** A new section to chapter 57-39.2 of the North Dakota Century Code is created
18 and enacted as follows:

19 **Sales and use tax exemption for materials used to construct a fertilizer or chemical**
20 **processing facility.**

21 1. Gross receipts from sales of tangible personal property used to construct a fertilizer or
22 chemical processing facility in this state, and any component integral to the fertilizer or
23 chemical processing plant, are exempt from taxes under this chapter. To be exempt,
24 the tangible personal property must be incorporated in the structure of the facility or
25 used in the construction process to the point of having no residual economic value.
26 The exemption provided in this section applies to all phases of construction under the
27 permit or application for permit required by subsection 2. An integral component to the
28 fertilizer or chemical processing plant:

29 a. May be owned directly or indirectly by the fertilizer or chemical processing facility,
30 or by an unrelated third party;

31 b. Must be located at the facility site; and

- 1 c. Must be necessary for the plant's processing of fertilizer or chemicals.
- 2 2. On or before June 30, 2017, the owner of the fertilizer or chemical processing plant
3 must receive from the department of health an air quality permit or a notice that the air
4 quality permit application is complete. The owner shall provide this documentation to
5 the tax commissioner to qualify for the exemption under this section. Denial,
6 expiration, or revocation of a permit terminates the exemption under this section.
- 7 3. To receive the exemption under this section at the time of purchase, the owner of the
8 processing facility must receive from the tax commissioner a certificate that the
9 tangible personal property used to construct the processing facility which the owner
10 intends to purchase qualifies for exemption. If a certificate is not received before the
11 purchase, the owner shall pay the applicable tax imposed by this chapter and apply to
12 the tax commissioner for a refund.
- 13 4. If the tangible personal property is purchased or installed by a contractor subject to the
14 tax imposed by this chapter, the owner may apply for a refund of the difference
15 between the amount remitted by the contractor and the exemption imposed or allowed
16 by this section. Application for refund must be made at the times and in the manner
17 directed by the tax commissioner and must include sufficient information to permit the
18 tax commissioner to verify the sales and use taxes paid and the exempt status of the
19 sale or use.
- 20 5. For purposes of this section, a fertilizer or chemical processing facility means a
21 processing plant that produces for retail or wholesale a fertilizer, chemical, or chemical
22 derivative from natural gas, natural gas liquids, or crude oil components.

23 **SECTION 3. AMENDMENT.** Subsection 4 of section 57-40.2-03.3 of the North Dakota
24 Century Code is amended and reenacted as follows:

- 25 4. The tax imposed by this section does not apply to:
- 26 a. Production equipment or tangible personal property as authorized or approved
27 for exemption by the tax commissioner under section 57-39.2-04.2;
- 28 b. Machinery, equipment, or other tangible personal property used to construct an
29 agricultural commodity processing facility as authorized or approved for
30 exemption by the tax commissioner under section 57-39.2-04.3 or 57-39.2-04.4;

- 1 c. Tangible personal property used to construct or expand a system used to
2 compress, process, gather, or refine gas recovered from an oil or gas well in this
3 state or used to expand or build a gas-processing facility in this state as
4 authorized or approved for exemption by the tax commissioner under section
5 57-39.2-04.5;
- 6 d. Tangible personal property used to construct or expand a qualifying oil refinery as
7 authorized or approved for exemption by the tax commissioner under section
8 57-39.2-04.6;
- 9 e. Tangible personal property used to construct or expand a qualifying facility as
10 authorized or approved for exemption by the tax commissioner under section
11 57-39.2-04.10;
- 12 f. Tangible personal property used to construct or expand a qualifying facility as
13 authorized or approved for exemption by the tax commissioner under section
14 57-39.2-04.11; ~~or~~
- 15 g. Telecommunications infrastructure that is capable of providing
16 telecommunications service as authorized or approved for exemption by the
17 commissioner under chapter 57-39.2; or
- 18 h. Tangible personal property used to construct a qualifying fertilizer or chemical
19 processing facility as authorized or approved for exemption by the tax
20 commissioner under section 2 of this Act.

21 **SECTION 4. LEGISLATIVE MANAGEMENT STUDY - ECONOMIC DEVELOPMENT**

22 **IMPACT.** During the 2015-16 interim, the legislative management shall consider studying the
23 impact of large economic development projects on political subdivisions. The study may include
24 a review of the current process for seeking out input from political subdivisions potentially
25 impacted by a large economic development project and any mechanisms in place to address
26 the potential impact. The legislative management shall report its findings and recommendations,
27 together with any legislation required to implement the recommendations, to the sixty-fifth
28 legislative assembly.

29 **SECTION 5. OIL AND GAS RESEARCH - NATURAL GAS PRODUCTION STUDY.** The
30 industrial commission may use the sum of one hundred thousand dollars or so much of the sum
31 as necessary from the oil and gas research fund, or so much of the amount as may be

1 necessary, pursuant to its continuing appropriation under section 57-51.1-07.3 for the purpose
2 of contracting for an independent, non-matching natural gas production study.

3 **SECTION 6. EFFECTIVE DATE - RETROACTIVE APPLICATION.** Section 1 of this Act is
4 effective for taxable years beginning after December 31, 2014. Sections 2 and 3 of this Act are
5 retroactively effective, and apply to taxable events occurring after December 31, 2014.
