**ENGROSSED SENATE BILL NO. 2010**

1 A BILL for an Act to provide an appropriation for defraying the expenses of the council on the  
2 arts.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds  
5 as may be necessary, are appropriated out of any moneys in the general fund in the state  
6 treasury, not otherwise appropriated, and from special funds derived from federal funds and  
7 other income, to the council on the arts for the purpose of defraying the expenses of the  
8 council on the arts, for the biennium beginning July 1, 2017, and ending June 30, 2019, as  
9 follows:

1 | **SECTION 2. HEALTH INSURANCE INCREASE.** Section 1 of this Act includes the sum of  
2 | \$13,273 from the general fund for increases in employee health insurance premiums from  
3 | \$1,130 to \$1,241 per month.

4 | **SECTION 3. APPROPRIATION - CULTURAL ENDOWMENT FUND.** All income from the  
5 | cultural endowment fund is appropriated to the council on the arts for the furthering of the  
6 | cultural arts in the state for the biennium beginning July 1, 2017, and ending June 30, 2019.
