5 Dakota Century Code, relating to implementation of the North Dakota Compassionate Care Act
6 to authorize medical marijuana; to amend and reenact sections 19-24-01, 19-24-02, 19-24-03,
7 19-24-04, 19-24-05, 19-24-06, 19-24-07, 19-24-08, 19-24-09, 19-24-10, 19-24-11, 19-24-12,
8 and 19-24-13 of the North Dakota Century Code, relating to implementation of the North Dakota
9 Compassionate Care Act to authorize medical marijuana; to provide a report to the legislative
10 management; to provide a penalty; to provide a continuing appropriation; and to declare an
11 emergency.

12 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

13 **SECTION 1. AMENDMENT.** Section 19-24-01 of the North Dakota Century Code is
14 amended and reenacted as follows:

15 **19-24-01. Title - Compassionate care program.**

16 This Act may be cited as the "North Dakota Compassionate Care Act". The state
17 department of health shall establish a compassionate care program to implement the medical
18 marijuana program under this chapter.

19 **SECTION 2. AMENDMENT.** Section 19-24-02 of the North Dakota Century Code is
20 amended and reenacted as follows:

21 **19-24-02. Definitions.**

22 ~~The following words and terms, when used in these regulations, should have the following~~
23 ~~meaning, unless the context clearly indicates otherwise:~~

24 1. ~~"Act" means the North Dakota Compassionate Care Act.~~

- 1 2. ~~"Adulterated" means made impure or inferior by adding extraneous ingredients. Goods~~
2 ~~that are prepared in food establishments that are licensed facilities in response and~~
3 ~~that contain marijuana for medical use by a registered patient are not considered to be~~
4 ~~adulterated.~~
- 5 3. ~~"Advisory board" means a nine-member committee established, chaired, and~~
6 ~~appointed by the governor, in conjunction with the attorney general, to evaluate and~~
7 ~~make recommendations to the state legislature and the department.~~
- 8 4. ~~"Applicant" means any person applying to participate in the North Dakota~~
9 ~~Compassionate Care Act.~~
- 10 5. ~~"Cardholder" means a registered patient of any age or a registered designated~~
11 ~~caregiver who has been issued and possesses a valid registry identification card.~~
- 12 6. ~~"Compassion center agent" means a principal officer, board member, employee, or~~
13 ~~agent of a registered compassion center who is twenty-one years of age or older and~~
14 ~~has not been convicted of an excluded felony offense, and has not been convicted of a~~
15 ~~drug misdemeanor within five years.~~
- 16 7. ~~"Debilitating medical condition" means one or more of the following:~~
- 17 a. ~~Cancer and its treatments;~~
- 18 b. ~~Positive status for human immunodeficiency virus (HIV);~~
- 19 c. ~~Acquired immune deficiency syndrome (AIDS);~~
- 20 d. ~~Decompensated cirrhosis (hepatitis C);~~
- 21 e. ~~Amyotrophic lateral sclerosis (ALS or Lou Gehrig's disease);~~
- 22 f. ~~Posttraumatic stress disorder (PTSD);~~
- 23 g. ~~Agitation of Alzheimer's disease, dementia, or the treatment of these conditions;~~
- 24 h. ~~Crohn's disease or fibromyalgia;~~
- 25 i. ~~Spinal stenosis or chronic back pain including neuropathy or damage to the~~
26 ~~nervous tissue of the spinal cord with objective neurological indication of~~
27 ~~intractable spasticity;~~
- 28 j. ~~Glaucoma;~~
- 29 k. ~~Epilepsy;~~
- 30 l. ~~A chronic or debilitating disease medical condition or its treatment that produces~~
31 ~~one or more of the following: cachexia or wasting syndrome; severe debilitating~~

1 pain that has not responded to previously prescribed medication or surgical
2 measures for more than three months or for which other treatment options
3 produced serious side effects; intractable nausea; seizures; or severe and
4 persistent muscle spasms, including but not limited to those characteristic of
5 multiple sclerosis;

6 m. Any other medical condition or its treatment added by the North Dakota
7 department of health.

8 8. "Department" means the North Dakota department of health.

9 9. "Designated caregiver" means a person who:

10 a. Is at least twenty one years of age;

11 b. Has agreed to assist with a patient's medical use of marijuana;

12 c. Has not been convicted of a felony offense; and

13 d. Assists no more than five qualifying patients with their medical use of marijuana.

14 10. "Incidental amount of marijuana" means marijuana seeds, stalks and roots of the plant
15 that are not included when calculating the allowable amounts of marijuana specified in
16 these rules. This includes the weight of any nonmarijuana ingredients combined with
17 marijuana, such as ingredients added to prepare a topical ointment, food, or drink.

18 11. "Marijuana", also known as cannabis, is an annual, dioecious, flowering herb that
19 produces a group of chemicals called cannabinoids.

20 12. "Marijuana paraphernalia" is limited to equipment, products, and materials that are
21 ordinarily used in planting, propagating, cultivating, growing, harvesting, processing,
22 preparing, testing, analyzing, packaging, repackaging, storing, containing, ingesting,
23 inhaling, or otherwise introducing marijuana into the human body. It includes:

24 a. Scales and balances;

25 b. Separation gins and sifters, used or intended for use in removing twigs and
26 seeds from, or in otherwise cleaning or refining, marijuana;

27 c. Envelopes and other containers used or intended for use in packaging small
28 quantities of marijuana for medical use;

29 d. Containers and other objects used or intended for use in storing medical
30 marijuana; and

- 1 e. Objects used or intended for use in ingesting, inhaling, or otherwise introducing
2 marijuana into the human body, including but not limited to:
- 3 (1) Metal, wooden, acrylic, glass, stone, plastic, or ceramic pipes with or without
4 screens, permanent screens, hashish heads or punctured metal bowls;
- 5 (2) Water pipes;
- 6 (3) Carburetion tubes and devices;
- 7 (4) Smoking and carburetion masks;
- 8 (5) Roach clips, meaning objects used to hold burning marijuana cigarettes that
9 have become too small or too short to be held in the hand;
- 10 (6) Chamber pipes;
- 11 (7) Carburetor pipes;
- 12 (8) Electric pipes;
- 13 (9) Air-driven pipes;
- 14 (10) Chillums;
- 15 (11) Bongs designed for marijuana and not for cocaine; or
- 16 (12) Ice pipes or chillers.
- 17 13. "Medical use" means the acquisition, possession, use, delivery, transfer, or
18 transportation of marijuana or paraphernalia relating to the administration of marijuana
19 to treat or alleviate a registered patient's debilitating medical condition or symptoms
20 associated with the registered patient's debilitating medical condition.
- 21 14. "Onsite assessment" means a visit by an employee of the department for the purpose
22 of ensuring compliance with the requirements of these rules.
- 23 15. "Physician" means a properly licensed physician in the state of North Dakota. If the
24 qualifying patient's debilitating medical condition is posttraumatic stress disorder, the
25 physician must also be a licensed psychiatrist.
- 26 16. "Posttraumatic stress disorder" means that a patient meets the diagnostic criteria for
27 posttraumatic stress disorder (PTSD), per DSM-5 or subsequent current edition,
28 including symptoms of intense physical reactions such as tachycardia, shortness of
29 breath, rapid breathing, muscle tension, and sweating.
- 30 17. "Qualifying patient" means a person who has been diagnosed by a physician as
31 having a debilitating medical condition.

- 1 18. ~~"Registry identification card" means a document issued by the department that~~
2 ~~identifies a person as a registered patient or registered designated caregiver.~~
- 3 19. ~~"Tincture" means a mixture created from a concentrated extract of marijuana.~~
- 4 20. ~~"Topical treatment" means a mixture or extract of marijuana made into a balm, lotion,~~
5 ~~ointment, or rubbing alcohol solution that is applied transcutaneously.~~
- 6 21. ~~"Usable amount of medical marijuana for medical use" means three ounces or less of~~
7 ~~usable marijuana as defined below.~~
- 8 22. ~~"Usable marijuana" means the dried leaves and flowers of the marijuana plant, and~~
9 ~~any mixture or preparation of those dried leaves and flowers, including but not limited~~
10 ~~to tinctures, ointments, and other preparations. It does not include the weight of any~~
11 ~~nonmarijuana ingredients combined with marijuana, such as ingredients added to~~
12 ~~prepare a topical administration, food, or drink.~~
- 13 23. ~~"Verification system" means a phone or web-based system established and~~
14 ~~maintained by the department that is available to law enforcement personnel and~~
15 ~~compassion center agents on a twenty-four hour basis for verification of registry~~
16 ~~identification cards.~~
- 17 24. ~~"Written certification" means a document dated and signed by a physician, stating that~~
18 ~~in the physician's opinion the patient is likely to receive therapeutic or palliative benefit~~
19 ~~from the medical use of marijuana to treat or alleviate the patient's debilitating medical~~
20 ~~condition or symptoms associated with the debilitating medical condition. A written~~
21 ~~certification shall be made only in the course of a bona fide physician-patient~~
22 ~~relationship where the qualifying patient is under the physician's care for the qualifying~~
23 ~~patient's primary care or for the qualifying patient's debilitating condition after the~~
24 ~~physician has completed an assessment of the qualifying patient's medical history and~~
25 ~~current medical condition. The bona fide physician-patient relationship may not be~~
26 ~~limited to authorization for the patient to use medical marijuana or consultation for that~~
27 ~~purpose. The written certification shall specify the qualifying patient's debilitating~~
28 ~~medical condition.~~

29 As used in this chapter, unless the context indicates otherwise:

- 30 1. "Allowable amount of usable marijuana for medical use" means the amount of usable
31 marijuana an individual may purchase for medical use in a thirty-day period or have in

1 the individual's possession at any time. A registered qualifying patient may not
2 purchase or have purchased by a registered caregiver more than two and one-half
3 ounces [70.87 grams] of ~~usable marijuana~~ dried leaves or flowers of the plant of genus
4 cannabis in a combustible delivery form in a thirty-day period and may not possess
5 more than three ounces [85.05 grams] of ~~usable marijuana~~ dried leaves or flowers of
6 the plant of genus cannabis in a combustible delivery form at any time. ~~The allowable~~
7 amount does not include the weight of any nonmarijuana ingredients combined with
8 marijuana, such as ingredients added to prepare a liquid delivery form.A registered
9 qualifying patient may not purchase or have purchased by a registered caregiver more
10 than ten grams of liquid, including oil, or pill delivery form of marijuana with a
11 maximum delta-9-tetrahydrocannabinol concentration of thirty percent in a thirty-day
12 period and may not possess more than fifteen grams of liquid, including oil, or pill
13 delivery form of marijuana with a maximum delta-9-tetrahydrocannabinol concentration
14 of thirty percent at any time.

- 15 2. "Bona fide physician-patient relationship" means a treatment or counseling
16 relationship between a physician and patient in which all the following are present:
- 17 a. The physician has reviewed the patient's relevant medical records and completed
18 a full assessment of the patient's medical history and current medical condition,
19 including a relevant, in-person, medical evaluation of the patient.
 - 20 b. The physician has created and maintained records of the patient's condition in
21 accordance with medically accepted standards.
 - 22 c. The patient is under the physician's continued care for primary medical care for
23 the debilitating medical condition that qualifies the patient for the use of medical
24 marijuana.
 - 25 d. The physician has a reasonable expectation the physician will provide followup
26 care to the patient to monitor the use of medical marijuana as a treatment of the
27 patient's debilitating medical condition.
 - 28 e. The relationship is not for the sole purpose of providing written certification for the
29 use of medical marijuana.
- 30 3. "Cardholder" means a qualifying patient, designated caregiver, or compassion center
31 agent who has been issued and possesses a valid registry identification card.

- 1 4. "Compassion center" means a manufacturing facility or dispensary.
- 2 5. "Compassion center agent" means a principal officer, board member, member,
- 3 manager, governor, employee, volunteer, or agent of a compassion center.
- 4 6. "Contaminated" means made impure or inferior by extraneous substances.
- 5 7. "Debilitating medical condition" means one or more of the following:
- 6 a. Cancer;
- 7 b. Positive status for human immunodeficiency virus;
- 8 c. Acquired immune deficiency syndrome;
- 9 d. Decompensated cirrhosis caused by hepatitis C;
- 10 e. Amyotrophic lateral sclerosis;
- 11 f. Posttraumatic stress disorder;
- 12 g. Agitation of Alzheimer's disease or related dementia;
- 13 h. Crohn's disease;
- 14 i. Fibromyalgia;
- 15 j. Spinal stenosis or chronic back pain, including neuropathy or damage to the
- 16 nervous tissue of the spinal cord with objective neurological indication of
- 17 intractable spasticity;
- 18 k. Glaucoma;
- 19 l. Epilepsy; and
- 20 m. A chronic or debilitating disease or medical condition or treatment for such
- 21 disease or medical condition that produces one or more of the following:
- 22 (1) Cachexia or wasting syndrome;
- 23 (2) Severe debilitating pain that has not responded to previously prescribed
- 24 medication or surgical measures for more than three months or for which
- 25 other treatment options produced serious side effects;
- 26 (3) Intractable nausea;
- 27 (4) Seizures; or
- 28 (5) Severe and persistent muscle spasms, including those characteristic of
- 29 multiple sclerosis; and
- 30 ~~n. Any other medical condition or treatment for such condition which is identified by~~
- 31 ~~the department.~~

- 1 8. "Department" means the state department of health.
- 2 9. "Designated caregiver" means an individual who agrees to manage the well-being of a
3 registered qualifying patient with respect to the qualifying patient's medical use of
4 marijuana.
- 5 10. "Dispensary" means an entity registered with the department under this chapter to
6 acquire, possess, store, deliver, transfer, transport, sell, supply, or dispense usable
7 marijuana or related supplies and educational materials to a registered qualifying
8 patient or registered designated caregiver.
- 9 11. "Enclosed, locked facility" means a closet, room, greenhouse, building, or other
10 enclosed area equipped with locks or other security devices that permit access limited
11 to individuals authorized under this chapter or rules adopted under this chapter.
- 12 12. "Manufacturing facility" means an entity registered with the department under this
13 chapter to acquire, possess, cultivate, or transport marijuana for the sole purpose of
14 manufacturing usable marijuana for the delivery, supply, or sale of usable marijuana to
15 a dispensary.
- 16 13. "Marijuana" means all parts of the plant of the genus cannabis; the seeds of the plant;
17 the resin extracted from any part of the plant; and every compound, manufacture, salt,
18 derivative, mixture, or preparation of the plant, the seeds of the plant, or the resin
19 extracted from any part of the plant.
- 20 14. "Medical marijuana waste" means unused, surplus, returned, or out of date usable
21 marijuana; recalled usable marijuana; and any marijuana plant debris, including dead
22 plants and all unused plant parts and roots.
- 23 15. "Medical use" means the acquisition, use, and possession of usable marijuana to treat
24 or alleviate a registered qualifying patient's debilitating medical condition.
- 25 16. "Minor" means an individual under the age of ~~twenty-one~~nineteen.
- 26 17. "North Dakota identification" means a North Dakota driver's license or comparable
27 state of North Dakota or federal issued photo identification card verifying North Dakota
28 residence.
- 29 18. "Pediatric medical marijuana oil" means cannabidiol oil, which is processed cannabis
30 plant extract that contains no more than six percent tetrahydrocannabinol, or is a

- 1 dilution of the resin of the cannabis plant which contains no more than six percent
2 tetrahydrocannabinol.
- 3 19. "Physician" means a physician licensed to practice medicine in the state of North
4 Dakota who has the authority to prescribe drugs to humans. If the qualifying patient's
5 debilitating medical condition is posttraumatic stress disorder, the physician must be a
6 licensed psychiatrist. If the qualifying patient is younger than eighteen years of age,
7 the physician must be a pediatric neurologist, pediatric gastroenterologist, pediatric
8 oncologist, or pediatric palliative care specialist or must be a pediatrician working in
9 consultation with one of these pediatric specialists.
- 10 20. "Posttraumatic stress disorder" means a patient meets the diagnostic criteria for
11 posttraumatic stress disorder under the "Diagnostic and Statistical Manual of Mental
12 Disorders", American psychiatric association, fifth edition, text revision (2013), or a
13 future edition adopted by the department, including symptoms of intense physical
14 reactions such as tachycardia, shortness of breath, rapid breathing, muscle tension,
15 and sweating.
- 16 21. "Qualifying patient" means an individual who has been diagnosed by a physician as
17 having a debilitating medical condition.
- 18 22. "Registry identification card" means a document issued by the department which
19 identifies an individual as a registered qualifying patient, registered designated
20 caregiver, or registered compassion center agent.
- 21 23. "Usable marijuana" means a liquid, including an oil, or a pill delivery form of marijuana
22 or the dried leaves or flowers of the plant of the genus cannabis in a combustible
23 delivery form. The term does not include ~~the dried leaves or flowers of the~~
24 ~~plant~~marijuana infused food. In the case of a registered qualifying patient who is a
25 minor, "usable marijuana" is limited to pediatric medical marijuana oil.
- 26 24. "Verification system" means the system maintained by the department under section
27 19-24-36 for verification of registry identification cards.
- 28 25. "Written certification" means a form established by the department which is executed,
29 dated, and signed by a physician within ninety calendar days of the date of application,
30 stating that in the physician's professional opinion the patient is likely to receive
31 therapeutic or palliative benefit from the medical use of usable marijuana to treat or

1 alleviate the patient's debilitating medical condition. If the physician authorizes the use
2 of dried leaves or flowers of the plant of the genus cannabis in a combustible delivery
3 form, the written certification must include an attestation in the physician's professional
4 opinion no other form of usable marijuana would be effective in providing the patient
5 therapeutic or palliative benefits. A written certification may not be made except in the
6 course of a bona fide physician-patient relationship.

7 **SECTION 3. AMENDMENT.** Section 19-24-03 of the North Dakota Century Code is
8 amended and reenacted as follows:

9 **19-24-03. Qualifying patient registry identification card application- Application**
10 **requirements.**

- 11 1. ~~The department shall issue a registry identification card to an applicant for the purpose~~
12 ~~of participating in the medical marijuana program upon the written certification of the~~
13 ~~applicant's physician, supporting application documents, and a nonrefundable~~
14 ~~application fee with a personal check or a cashier's check made out to "North Dakota~~
15 ~~department of health, compassionate care program". The following information shall~~
16 ~~be provided in the participant enrollment form submitted to the department in order for~~
17 ~~a registry identification card to be obtained and processed.~~
- 18 2. ~~An attached original written certification for patient eligibility form shall contain:~~
- 19 a. ~~The name, address, and telephone number of the applicant's physician;~~
 - 20 b. ~~The physician's clinical licensure;~~
 - 21 c. ~~The patient applicant's name and date of birth;~~
 - 22 d. ~~The medical justification for the physician's certification of the patient's~~
23 ~~debilitating medical condition;~~
 - 24 e. ~~The physician's signature and date;~~
 - 25 f. ~~The name, address, and date of birth of the applicant;~~
 - 26 g. ~~The name, address, and date of birth of the applicant's primary caregiver, if any;~~
 - 27 h. ~~A reasonable photographic copy of the applicant's North Dakota driver's license~~
28 ~~or comparable state of North Dakota or federal issued photo identification card~~
29 ~~verifying North Dakota residence; state of North Dakota issued identification card~~
30 ~~must be available for inspection or verification. Should the applicant be a minor, a~~
31 ~~certificated copy of a birth record will meet the identification requirement;~~

- 1 i. ~~The length of time the applicant has been under the care of the physician~~
2 ~~providing the medical provider certification for patient eligibility;~~
3 j. ~~The applicant's or guardian's signature and date; and~~
4 k. ~~A signed consent for release of medical information related to the patient's~~
5 ~~debilitating medical condition, on a form provided by the North Dakota~~
6 ~~department of health.~~
- 7 1. A qualifying patient is not eligible to participate in the compassionate care program
8 unless the qualifying patient has a valid registry identification card issued by the
9 department.
- 10 2. A qualifying patient application for a registry identification card is complete and eligible
11 for review if an applicant submits to the department:
- 12 a. A nonrefundable annual application fee of two hundred dollars with a personal
13 check or cashier's check payable to "North Dakota State Department of Health,
14 Compassionate Care Program". ~~The department shall establish an application~~
15 ~~fee in an amount not to exceed three hundred dollars.~~
- 16 b. An original written certification, which must include:
- 17 (1) The name, address, and telephone number of the practice location of the
18 applicant's physician;
- 19 (2) The physician's North Dakota clinical licensure number;
- 20 (3) The physician's medical specialty;
- 21 (4) The applicant's name and date of birth;
- 22 (5) The applicant's debilitating medical condition and the medical justification
23 for the physician's certification of the patient's debilitating medical condition;
- 24 (6) Attestation the written certification is made in the course of a bona fide
25 physician-patient relationship and that in the physician's professional
26 opinion the applicant is likely to receive therapeutic or palliative benefit from
27 the medical use of marijuana to treat or alleviate the applicant's debilitating
28 medical condition; and
- 29 (7) If the physician authorizes the patient to use the dried leaves or flowers of
30 the plant of the genus cannabis in a combustible delivery form, attestation in

the physician's professional opinion no other form of usable marijuana will
be effective in providing the patient therapeutic or palliative benefits; and

(8) The physician's signature and the date.

c. An original qualifying patient application for a registry identification card form
established by the department which must include:

(1) The applicant's name, address, and date of birth;

(2) The applicant's social security number;

(3) The name, address, and date of birth of the applicant's proposed
designated caregiver, if any;

(4) A photographic copy of the applicant's North Dakota identification. The
North Dakota identification must be available for inspection and verification
upon request of the department. If the applicant is a minor, a certificated
copy of a birth record is required; and

(5) The applicant's or guardian's signature and the date, or in the case of a
minor, the signature of the minor's parent or legal guardian with
responsibility for health care decisions and the date.

d. A signed consent for release of medical information related to the applicant's
debilitating medical condition, on a form provided by the department.

e. A recent two-by-two inch [5.08 by 5.08 centimeter] photograph of the applicant.

3. If the applicant is unable to submit the required application information due to age or
medical condition, the individual responsible for making medical decisions for the
applicant may submit the application on behalf of the applicant. The individual
responsible for making medical decisions:

a. Must be identified on the qualifying patient application for a registry identification
card; and

b. Shall provide a copy of the individual's North Dakota identification. The North
Dakota identification must be available for inspection and verification upon the
request of the department.

4. If the applicant is a minor, the department may waive the application or renewal fee if:

a. The parent or legal guardian of the applicant is the applicant's registered
designated caregiver; and

1 b. The applicant resides with the applicant's registered designated caregiver.

2 **SECTION 4. AMENDMENT.** Section 19-24-04 of the North Dakota Century Code is
3 amended and reenacted as follows:

4 **19-24-04. Designated caregiver registry identification card application- Application**
5 **requirements.**

6 1. ~~The department shall issue a registry identification card to a primary caregiver-~~
7 ~~applicant for the purpose of managing the well-being of one to five qualified patients,~~
8 ~~including themselves if the caregiver is a qualified patient, in response to the~~
9 ~~requirements of this rule upon the completion and approval of the primary caregiver-~~
10 ~~application form, available from the medical marijuana program, and a nonrefundable~~
11 ~~application fee, in the form of a personal check or a cashier's check made out to~~
12 ~~"North Dakota department of health, compassionate care program". In order for a~~
13 ~~registry identification card to be obtained and processed, the following information~~
14 ~~shall be submitted to the medical marijuana program:~~

15 a. ~~A certified copy of a birth record verifying that the applicant is at least twenty-one~~
16 ~~years of age;~~

17 b. ~~A reasonable photographic copy of the applicant's North Dakota driver's license-~~
18 ~~or comparable state of North Dakota or federal issued photo identification card-~~
19 ~~verifying North Dakota residence; state of North Dakota issued identification card-~~
20 ~~must be available for inspection or verification;~~

21 c. ~~Written approval by the qualified patient authorizing responsibility for managing-~~
22 ~~the well-being of a qualified patient with respect to the use of marijuana;~~

11 interview, may result in sanctions, including suspension, revocation, nonrenewal or
12 denial of licensure, and referral to state or local law enforcement.

14 primary caregiver to the appropriate North Dakota state or appropriate local

24 writing after receiving notice of the corrective action that the corrective action is
25 satisfactory.
- 26 d. If the violation has not been corrected, the department may issue a notice of
27 contemplated action to revoke the qualified patient's or designated caregiver's
28 registry identification card.
- 29 e. Suspension of registry identification card without prior hearing: If immediate
30 action is required to protect the health and safety of the general public, the

1 department may suspend the qualified patient or designated caregiver registry
2 identification card without notice.

3 (1) A qualified patient or primary caregiver whose registry identification card has
4 been summarily suspended is entitled to a record review not later than thirty
5 calendar days after the registry identification card was summarily
6 suspended.

7 (2) The record review requested subsequent to a summary suspension shall be
8 conducted by the department.

9 (3) The department shall conduct the record review on the summary
10 suspension by reviewing all documents submitted by both the card holder
11 and the department.

12 (4) The sole issue at a record review on a summary suspension is whether the
13 card holder's registry identification card shall remain suspended pending a
14 final adjudicatory hearing and ruling.

15 (5) A card holder given notice of summary suspension by the department may
16 submit a written request for a record review. To be effective, the written
17 request shall:

18 (a) Be made within thirty calendar days, as determined by the postmark,

11 the cardholder or applicant. Before conducting an onsite interview, the department
12 shall provide the cardholder or applicant at least twenty-four hours' notice.

d. A designation as to whether a qualifying patient or a designated caregiver's qualifying patient is authorized to use the dried leaves or flowers of the plant of the genus cannabis;

e. The date of issuance and expiration date;

f. A random ten-digit alphanumeric identification number containing at least four numbers and at least four letters which is unique to the cardholder;

g. If the cardholder is a designated caregiver, the random identification number of the qualifying patient the designated caregiver is authorized to assist;

h. A photograph of the cardholder; and

i. The phone number or website address at which the card can be verified.

2. Except as otherwise provided in this section, a registry identification card expiration date must be one year after the date of issuance.

3. If a physician states in the written certification that the qualifying patient would benefit from the medical use of marijuana until a specified date, less than one year, the registry identification card expires on that date.

- 17 2. The activities of a dispensary are limited to acquiring, possessing, storing, delivering,
18 transferring, transporting, selling, supplying, and dispensing usable marijuana or
19 related supplies and educational materials to a registered qualifying patient directly or
20 through the registered qualifying patient's registered designated caregiver.

21 **SECTION 14.** Section 19-24-14 of the North Dakota Century Code is created and enacted
22 as follows:

23 **19-24-14. Compassion centers - Application.**

- 24 1. The department shall establish forms for an application to be registered as a
25 compassion center. For a compassion center registration application to be complete
26 and eligible for review, the applicant shall submit to the department:
- 27 a. A nonrefundable application fee of five thousand dollars, made payable to the
28 "North Dakota State Department of Health, Compassionate Care Program",~~in the~~
29 ~~amount set by the department, not to exceed five thousand dollars:~~
- 30 b. The legal name, articles of incorporation or articles of organization, and bylaws or
31 operating agreement of the proposed compassion center applicant;

- 1 c. Evidence of the proposed compassion center applicant's registration with the
2 secretary of state and certificate of good standing;
- 3 d. The physical address of the proposed location of the proposed compassion
4 center and:
- 5 (1) Evidence of approval from local officials as to the proposed compassion
6 center applicant's compliance with local zoning laws for the physical
7 address to be used by the proposed compassion center; and
- 8 (2) Evidence the physical address of the proposed compassion center is not
9 located within one thousand feet [604.80 meters] of a property line of a
10 pre-existing public or private school;
- 11 e. For a manufacturing facility applicant, a description of the enclosed, locked
12 facility that would be used in the cultivation of marijuana, including steps that will
13 be taken to ensure the marijuana cultivation and production is not visible from the
14 street or other public areas;
- 15 f. The name, address, and date of birth of each principal officer and board member,
16 or of each member-manager, manager, or governor, of the proposed compassion
17 center applicant and verification each officer and board member, or each
18 member-manager, manager, or governor, has consented to a criminal history
19 record check conducted under section 12-60-24;
- 20 g. For each of the proposed compassion center applicant's principal officers and
21 board members, or for each of the proposed compassion center applicant's
22 member-managers, managers, or governors, a description of that individual's
23 relevant experience, including training or professional licensing related to
24 medicine, pharmaceuticals, natural treatments, botany, food science, food safety,
25 and marijuana cultivation and preparation and the individual's experience running
26 a business entity;
- 27 h. A description of proposed security and safety measures, which demonstrate
28 compliance with the security and safety requirements under section 19-24-24;
- 29 i. An example of the design and security features of usable marijuana containers
30 which demonstrates compliance with section 19-24-20;

- 1 j. A complete operations manual, which demonstrates compliance with section
2 19-24-26;
- 3 k. A description of the plans for making usable marijuana available on an affordable
4 basis to registered qualifying patients enrolled in medical assistance or receiving
5 supplemental security income or social security disability insurance;
- 6 l. A list of all individuals and business entities having direct or indirect authority over
7 the management or policies of the proposed compassion center applicant;
- 8 m. A list of all individuals and business entities having an ownership interest in the
9 proposed compassion center applicant, whether direct or indirect, and whether
10 the interest is in profits, land, or building, including owners of any business entity
11 that owns all or part of the land or building; and
- 12 n. The identity of any creditor holding a security interest in the proposed
13 compassion center premises.
- 14 2. The department is not required to review an application submitted under this section
15 unless the department determines the application is complete. The criteria considered
16 by the department in reviewing an application must include:
- 17 a. The suitability of the proposed compassion center location, including compliance
18 with any local zoning laws, and the geographic convenience to access
19 compassion centers for registered qualifying patients and registered designated
20 caregivers from throughout the state;
- 21 b. The character and relevant experience of the principal officers and board
22 members, or of the member-managers, managers, or governors, including
23 training or professional licensing and business experience;
- 24 c. The applicant's plan for operations and services, including staffing and training
25 plans, whether the applicant has sufficient capital to operate, and the applicant's
26 ability to provide an adequate supply of usable marijuana to registered qualifying
27 patients and registered designated caregivers;
- 28 d. The sufficiency of the applicant's plans for recordkeeping;
- 29 e. The sufficiency of the applicant's plans for safety, security, and the prevention of
30 diversion, including the proposed location and security devices employed;

- 1 f. The applicant's plan for making usable marijuana available on an affordable basis
2 to registered qualifying patients with limited financial resources;
3 g. The applicant's plan for safe and accurate packaging and labeling of usable
4 marijuana; and
5 h. The applicant's plans for testing medical marijuana.
6 3. Following completion of the review under subsection 2, the department shall select the
7 applicants eligible for registration under section 19-24-15.

8 **SECTION 15.** Section 19-24-15 of the North Dakota Century Code is created and enacted
9 as follows:

10 **19-24-15. Compassion centers - Registration certification.**

- 11 1. Upon receipt of notification by the department a compassion center application is
12 eligible for registration, the applicant shall submit the following additional items to the
13 department to qualify for registration:
14 a. A certification fee, made payable to the "North Dakota State Department of
15 Health, Compassionate Care Program", in the amount ~~established by the~~
16 ~~department, not to exceed one hundred thousand dollars~~ of sixty thousand dollars
17 for a dispensary and eighty thousand dollars for a manufacturing facility;
18 b. A financial assurance or security bond to ensure the protection of the public
19 health and safety and the environment in the event of abandonment, default, or
20 other inability or unwillingness to meet the requirements of this chapter;
21 c. The legal name, articles of incorporation or articles of organization, and bylaws or
22 operating agreement, of the proposed compassion center applicant;
23 d. The physical address of the proposed compassion center; confirmation the
24 information in the application regarding the physical location of the proposed
25 compassion center has not changed, and if the information has changed the
26 department shall determine whether the new information meets the requirements
27 of this chapter; and a current certificate of occupancy, or equivalent document, to
28 demonstrate compliance with the provisions of state and local fire code for the
29 physical address of the proposed compassion center. It is not necessary for an
30 applicant to resubmit any information provided in the initial application unless
31 there has been a change in that information; and

- 1 e. An update to previously submitted information, including information about
2 compassion center agents and compliance with section 19-24-28.
3 2. If an applicant complies with subsection 1, the department shall issue the applicant a
4 registration certificate.

5 **SECTION 16.** Section 19-24-16 of the North Dakota Century Code is created and enacted
6 as follows:

7 **19-24-16. Compassion centers - Registration certificate - Renewal.**

- 8 1. A compassion center's registration expires two years after issuance. A compassion
9 center may submit a renewal application at any time beginning ninety calendar days
10 before the expiration of the registration certificate. A compassion center shall submit a
11 renewal application a minimum of sixty calendar days before the expiration of the
12 registration certificate to avoid suspension of the certificate.
13 2. The department shall approve a compassion center's renewal application within sixty
14 calendar days of submission if the following conditions are satisfied:
15 a. The compassion center submits a renewal fee ~~in an amount established by the~~
16 ~~department, not to exceed one hundred thousand dollars~~ of sixty thousand dollars
17 for a dispensary and eighty thousand dollars for a manufacturing facility, which
18 the department shall refund if the department rejects the renewal application;
19 b. The compassion center submits a complete renewal application;
20 c. The department has at no time suspended the compassion center's registration
21 for violation of this chapter;
22 d. Inspections conducted under this chapter do not raise any serious concerns
23 about the continued operation of the compassion center; and
24 e. The compassion center continues to meet all the requirements for the operation
25 of a compassion center as set forth in this chapter.
26 3. If a compassion center does not meet the requirements for renewal, the department
27 may not issue a registration certificate and the department shall provide the
28 compassion center with written notice of the determination. If a compassion center's
29 certificate is not renewed, the compassion center shall dispose all marijuana and
30 usable marijuana in accordance with rules adopted under this chapter.

1 **SECTION 17.** Section 19-24-17 of the North Dakota Century Code is created and enacted
2 as follows:

3 **19-24-17. Compassion centers - Registration certificate - Nontransferable.**

- 4 1. A registration certificate authorizing operation of a compassion center may not be
5 transferred to another person. Unless a compassion center applies for and receives an
6 amended registration certificate authorizing operation of a compassion center, the
7 registration certificate is void if there is a change in ownership of the compassion
8 center, there is a change in the authorized physical location of the compassion center,
9 or if the compassion center discontinues operation.
- 10 2. A compassion center shall provide the department a written notice of any change
11 described under this section at least sixty calendar days before the proposed effective
12 date of the change. The department may waive all or part of the required advance
13 notice to address emergent or emergency situations.

14 **SECTION 18.** Section 19-24-18 of the North Dakota Century Code is created and enacted
15 as follows:

16 **19-24-18. Compassion centers - Bylaws or operating agreement.**

17 As part of a proposed compassion center's initial application, the applicant shall provide to
18 the department a current copy of the applicant's bylaws or operating agreement. Upon receipt of
19 a registration certificate, a compassion center shall maintain the bylaws or operating agreement
20 in accordance with this chapter. In addition to any other requirements, the bylaws or operating
21 agreement must include the ownership or management structure of the compassion center, the
22 composition of the board of directors, board of governors, member-managers, or managers,
23 and provisions relative to the disposition of revenues and earnings.

24 **SECTION 19.** Section 19-24-19 of the North Dakota Century Code is created and enacted
25 as follows:

26 **19-24-19. Compassion centers - Financial reports.**

27 A compassion center shall keep detailed financial reports of proceeds and expenses. A
28 compassion center shall maintain all inventory, sales, and financial records in accordance with
29 generally accepted accounting principles. The compassion center shall maintain for a period of
30 seven years all reports and records required under this section. A compassion center shall allow

1 the department, or an audit firm contracted by the department, access at all times to all books
2 and records kept by the compassion center.

3 **SECTION 20.** Section 19-24-20 of the North Dakota Century Code is created and enacted
4 as follows:

5 **19-24-20. Compassion centers - Dispensing.**

6 1. A compassion center shall comply with the dispensing requirements of this section.

7 2. Design and security features of usable marijuana containers must be in accordance
8 with rules adopted under this section.

9 3. A manufacturing facility or agent of the manufacturing facility may not dispense
10 marijuana, except the manufacturing facility or agent may dispense usable marijuana
11 to a dispensary.

12 4. A dispensary or agent of the dispensary may not dispense usable marijuana unless
13 the dispensary first uses the verification system to confirm the registered qualifying
14 patient or registered designated caregiver identification card is valid. A dispensary or
15 agent of the dispensary:

16 a. May not dispense usable marijuana to a person other than a registered qualifying
17 patient or a registered qualifying patient's registered designated caregiver. If a
18 registered qualifying patient is a minor:

19 (1) The dispensary or agent of the dispensary may not dispense usable
20 marijuana to a minor; and

21 (2) The usable marijuana dispensed to the minor's designated caregiver must
22 be in the form of pediatric medical marijuana oil.

23 b. May not dispense to a registered qualifying patient or registered caregiver more
24 than the allowable amount of usable marijuana for medical use and may not
25 dispense an amount if it is known that amount would cause the recipient to
26 possess more marijuana than is permitted as usable marijuana.

27 c. May not dispense to a registered qualifying patient or registered caregiver the
28 dried leaves or flowers of the plant of the genus cannabis in a combustible
29 delivery form unless the registry identification card and verification system
30 authorize this form of useable marijuana.

1 **SECTION 21.** Section 19-24-21 of the North Dakota Century Code is created and enacted
2 as follows:

3 **19-24-21. Compassion centers - Inspections.**

- 4 1. A compassion center is subject to random inspection by the department. During an
5 inspection, the department may review the compassion center's records, including the
6 compassion center's financial and dispensing records, which may track transactions
7 according to registered qualifying patient and registered designated caregiver registry
8 identification numbers.
- 9 2. The department shall conduct inspections of compassion centers to ensure
10 compliance with this chapter.
- 11 3. The department shall conduct inspections of manufacturing facilities for the presence
12 of pesticides, fungi, and molds.
- 13 4. The department shall select a certified laboratory to conduct random quality sampling
14 testing, in accordance with rules adopted under this chapter. A compassion center
15 shall pay the cost of all random quality sampling testing.

16 **SECTION 22.** Section 19-24-22 of the North Dakota Century Code is created and enacted
17 as follows:

18 **19-24-22. Compassion centers - Pesticide testing.**

19 A manufacturing facility shall test marijuana at a manufacturing facility for the presence of
20 pesticides. If a marijuana pesticide test or a random quality sampling test under section
21 19-24-21 indicates the presence of a pesticide, the manufacturing facility shall report the test
22 result immediately to the department and to the agriculture commissioner. Upon the order of the
23 department or agriculture commissioner, the manufacturing facility immediately shall destroy all
24 affected or contaminated marijuana inventory in accordance with rules adopted under this
25 chapter, and shall certify to the department and to the agriculture commissioner that all affected
26 or contaminated marijuana inventory has been destroyed.

27 **SECTION 23.** Section 19-24-23 of the North Dakota Century Code is created and enacted
28 as follows:

29 **19-24-23. Compassion centers - Marijuana plants.**

30 The department shall adopt rules establishing the maximum amount of marijuana a
31 compassion center may possess. The rules may not allow a manufacturing facility to possess

1 more than one thousand marijuana plants, regardless of the stage of growth, and may not allow
2 a dispensary to possess more than three thousand five hundred ounces [99.22 kilograms] of
3 usable marijuana at any time, regardless of formulation.

4 **SECTION 24.** Section 19-24-24 of the North Dakota Century Code is created and enacted
5 as follows:

6 **19-24-24. Compassion centers - Security and safety measures.**

- 7 1. A compassion center shall implement appropriate security and safety measures to
8 deter and prevent the unauthorized entrance to areas containing marijuana and the
9 theft of marijuana. The measures must comply with this section and rules adopted
10 under this chapter.
- 11 2. The compassion center shall keep access from outside the compassion center
12 premises to the minimum required by local fire or building regulations and access must
13 be controlled. The outside perimeter of the premises must be well lighted ~~as provided~~
14 by rules adopted under this chapter and in a manner determined appropriate by local
15 ordinance to ensure public safety and security. The compassion center shall limit to
16 authorized personnel the entry to any areas in which marijuana is cultivated or
17 manufactured or in which usable marijuana is held.
- 18 3. A compassion center must have a fully operational security alarm system at the
19 authorized physical address which includes an electrical support backup system for
20 the alarm system to provide suitable protection against theft and diversion. For the
21 purpose of this subsection, a fully operational security alarm system must include:
- 22 a. Immediate automatic or electronic notification sent directly to local or municipal
23 law enforcement agencies to alert such entities of an unauthorized breach of
24 security;
- 25 b. Immediate automatic or electronic notification sent directly to local or municipal
26 public safety personnel to alert such entities of a loss of electrical support backup
27 system; and
- 28 c. Protection against theft or diversion facilitated or hidden by tampering with
29 computers or electronic records.
- 30 4. A compassion center shall conduct a maintenance inspection and test of the security
31 alarm system for the compassion center's authorized location at intervals not to

- 1 exceed thirty calendar days from the previous inspection and test. The compassion
2 center shall make all necessary repairs in a timely manner to ensure the proper
3 operation of the security alarm system.
- 4 5. In the event of a failure of the security alarm system due to loss of electrical support or
5 mechanical malfunction, the compassion center shall:
- 6 a. Immediately upon discovery of the event, notify the department and local or
7 municipal law enforcement by telephone; and
- 8 b. Provide alternative security measures approved by the department or close the
9 compassion center until the security alarm system is restored to full operation.
- 10 6. The compassion center shall maintain documentation in an auditable form for:
- 11 a. All maintenance inspections and tests conducted under this section, and any
12 servicing, modification, or upgrade performed on the security alarm system. The
13 documentation must include the date of the action, a summary of each action
14 performed, and the name, signature, and title of the individual who performed the
15 actions;
- 16 b. An alarm activation or other event that requires response by public safety
17 personnel; and
- 18 c. Any breach of security.
- 19 7. A compassion center shall use a video surveillance system that includes access to
20 recorded surveillance and meets the requirements of this subsection and rules
21 adopted under this chapter.
- 22 a. Video surveillance quality must be a minimum of seven hundred twenty
23 progressive scan;
- 24 b. Video surveillance must record:
- 25 (1) All access areas;
- 26 (2) Any customer service and dispensing areas;
- 27 (3) Any growing areas and manufacturing areas, including processing and
28 packaging areas; and
- 29 (4) All areas marijuana or usable marijuana is handled;
- 30 c. Video footage must be digitally recorded and the compassion center shall hold
31 the recordings for at least one hundred twenty calendar days; and

- 1 d. The compassion center shall allow the department access to the video
2 surveillance footage at all times. A search warrant or consent from the
3 compassion center is not required for the department to obtain access to video
4 surveillance footage.

5 **SECTION 25.** Section 19-24-25 of the North Dakota Century Code is created and enacted
6 as follows:

7 **19-24-25. Compassion centers - Inventory controls.**

- 8 1. A compassion center shall comply with the inventory control requirements provided
9 under this section and rules adopted under this chapter.
- 10 2. A manufacturing facility shall:
- 11 a. Employ a bar coding inventory control system to track batch, strain, and amounts
12 of marijuana and usable marijuana in inventory and to track amounts of usable
13 marijuana sold to dispensaries; and
- 14 b. Host a secure computer interface to transfer inventory amounts and dispensary
15 purchase information to the department.
- 16 3. A dispensary shall:
- 17 a. Employ a bar coding inventory control system to track batch, strain, and amounts
18 of usable marijuana in inventory and to track amounts sold to registered
19 qualifying patients and registered designated caregivers; and
- 20 b. Host a secure computer interface to transfer inventory amounts and registered
21 qualifying patient and registered designated caregiver purchase information to
22 the department.
- 23 4. A compassion center shall store the compassion center's marijuana and usable
24 marijuana in an enclosed locked facility with adequate security, in accordance with
25 rules adopted under this chapter.
- 26 5. A compassion center shall:
- 27 a. Conduct an initial comprehensive inventory of any marijuana and usable
28 marijuana at the authorized location before the date the compassion center first
29 sells or dispenses usable marijuana;
- 30 b. Conduct a comprehensive inventory at intervals not to exceed twelve months
31 from the date of the previous comprehensive inventory;

- 1 c. Conduct a monthly inventory review of any marijuana and usable marijuana at
2 the authorized location; and
- 3 d. Conduct each inventory in a manner that includes two individuals. One of the two
4 individuals may not be involved in the manufacturing of marijuana, the dispensing
5 of usable marijuana, or the preparation of the compassion center financial
6 records.
- 7 6. If an inventory results in the identification of a discrepancy, the compassion center
8 shall notify the department and appropriate law enforcement authorities immediately.
- 9 7. Inventory documentation must include:
- 10 a. The date of the inventory;
- 11 b. A summary of the inventory findings;
- 12 c. The name, signature, and title of the individuals who conducted the inventory and
13 an attestation by both individuals as to the accuracy of the inventory; and
- 14 d. The name, signature, and title of the individual who conducted the independent
15 review.

16 **SECTION 26.** Section 19-24-26 of the North Dakota Century Code is created and enacted
17 as follows:

18 **19-24-26. Compassion centers - Operation manual.**

- 19 1. A compassion center shall maintain a current copy of the compassion center's
20 operating manual that meets the requirements of this section and rules adopted under
21 this chapter. The operating manual must include:
- 22 a. Procedures for the oversight of the compassion center, including documentation
23 of the reporting and management structure of the compassion center.
- 24 b. Procedures to ensure accurate recordkeeping, including protocols to ensure
25 quantities purchased do not suggest redistribution.
- 26 c. Employee security policies.
- 27 d. Safety and security procedures, including a disaster plan with procedures to be
28 followed in case of fire or other emergency.
- 29 e. Personal safety and crime prevention techniques.
- 30 f. An overview of inventory control provisions consistent with section 19-24-25.

- 1 g. A job description or employment contract developed for all employees and a
2 volunteer agreement for all volunteers which includes duties, responsibilities,
3 authority, qualification, and supervision.
- 4 h. The compassion center's alcohol-free and drug-free workplace policy;
- 5 i. A description of the usable marijuana packaging the compassion center utilizes,
6 in accordance with section 19-24-20 and rules adopted under this chapter.
- 7 j. A description of the documentation required to accompany a registered
8 compassion center agent while transporting usable marijuana on behalf of the
9 compassion center. The documentation must be in accordance with any rules
10 adopted under this chapter.
- 11 2. A manufacturing facility's operating manual must include detailed procedures
12 regarding the growing, manufacturing, and testing of marijuana and usable marijuana.
13 The procedures must include a description of how the marijuana will be sampled and
14 tested in accordance with rules adopted under this chapter.
- 15 3. A dispensary's operating manual must include:
- 16 a. Procedures for safely dispensing usable marijuana to a registered qualifying
17 patient and registered designated caregiver;
- 18 b. A distribution plan to provide registered qualifying patients and designated
19 registered caregivers access to usable marijuana;
- 20 c. A description of the dispensary's outreach activities to registered qualifying
21 patients and registered designated caregivers which must include:
- 22 (1) Providing each new registered qualifying patient who visits the dispensary
23 with a department-designed document of frequently asked questions which
24 explains the state and federal law limitations on the right to use medical
25 marijuana;
- 26 (2) Providing information regarding forms of usable marijuana provided by the
27 dispensary;
- 28 (3) Providing information regarding potential side effects of marijuana; and
- 29 (4) A plan on how the outreach activities will be implemented.

30 **SECTION 27.** Section 19-24-27 of the North Dakota Century Code is created and enacted
31 as follows:

1 **19-24-27. Compassion centers - Training curriculum.**

2 1. A compassion center shall develop, implement, and maintain on the premises an
3 onsite training curriculum or shall enter contractual relationships with outside
4 resources capable of meeting compassion center agent training needs.

5 2. A compassion center shall ensure each compassion center agent receives training
6 that includes:

7 a. Education regarding professional conduct, ethics, and state and federal laws
8 regarding patient confidentiality;

9 b. Informational developments in the field of medical use of marijuana;

10 c. All safety and security measures required as part of section 19-24-24;

11 d. Specific procedural instructions for responding to an emergency, including
12 robbery or violent accident; and

13 e. The compassion center's operations manual and all requirements related to
14 recordkeeping.

15 **SECTION 28.** Section 19-24-28 of the North Dakota Century Code is created and enacted
16 as follows:

17 **19-24-28. Compassion centers - Records - Agents.**

18 1. Each compassion center shall maintain:

19 a. A personnel record for each compassion center agent for a period of at least
20 three years following termination of the individual's affiliation with the compassion
21 center. The personnel record must include:

22 (1) An application for employment or to volunteer;

23 (2) A record of each disciplinary action;

24 (3) Documentation of completion of all required training. Documentation must
25 include a signed statement from the agent indicating the date, time, and
26 place of the training, the topics discussed, and the name and title of
27 presenters; and

28 (4) Documentation of the agent's registry identification card.

29 b. A record of the source of funds that will be used to open or maintain the
30 compassion center, including the name, address, and date of birth of any
31 investor.

- 1 c. A record of each instance in which a current or prospective board member,
2 member-manager, manager, or governor, who managed or served on the board
3 of a business or not-for-profit entity and in the course of that service was
4 convicted, fined, or censured or had a registration or license suspended or
5 revoked in any administrative or judicial proceeding.
- 6 2. A compassion center agent must hold a valid registry identification card. Upon
7 issuance of a compassion center registry certificate, the department shall issue a
8 registry identification card to each qualified compassion center agent associated with
9 the compassion center. To qualify to be issued a registry identification card, each
10 compassion center agent shall submit the following registry identification card
11 application material to the department:
- 12 a. A certified copy of a birth record verifying the agent is at least twenty-one years of
13 age;
- 14 b. A photographic copy of the agent's North Dakota identification verifying North
15 Dakota residence. The agent shall make the license or identification card
16 available for inspection and verification by the department;
- 17 c. A recent two-by-two inch [5.08 by 5.08 centimeter] photograph of the agent;
- 18 d. A written and signed statement from an officer or executive staff member of the
19 compassion center stating the applicant is associated with the compassion center
20 and the capacity of the association;
- 21 e. The name, address, and telephone number of the agent;
- 22 f. The agent's social security number;
- 23 g. The name, address, and telephone number of the compassion center with which
24 the agent is associated;
- 25 h. The agent's signature and the date; and
- 26 i. A nonrefundable application or renewal fee ~~established by the department in an~~
27 ~~amount not to exceed three~~of two hundred dollars in the form of a check made
28 out to "North Dakota State Department of Health, Compassionate Care
29 Program".

- 1 3. Each compassion center agent shall consent to a criminal history record check
2 conducted under section 12-60-24 to demonstrate compliance with the eligibility
3 requirements.
 - 4 a. All applicable fees associated with the required criminal history record checks
5 must be paid by the compassion center or the agent.
 - 6 b. A criminal history record check must be performed upon initial application and
7 biennially upon renewal. A compassion center agent shall consent to a criminal
8 history record check at any time the department determines necessary.
 - 9 c. An Individual convicted of a drug-related misdemeanor offense within the five-
10 year period before the date of application or a felony offense is prohibited from
11 being a compassion center agent.
- 12 4. The department may conduct an onsite assessment to verify information in a
13 compassion center agent application and the accompanying documentation as
14 authorized under section 19-24-09.
- 15 5. The department shall notify the compassion center in writing of the purpose for
16 denying a compassion center agent application for a registry identification card. The
17 department shall deny an application if the agent fails to meet the registration
18 requirements or to provide the information required, or if the department determines
19 the information provided is false. Denial of an application or renewal is considered a
20 final department action, subject to judicial review. Jurisdiction and venue for judicial
21 review are vested in the Burleigh County district court.
- 22 6. The department shall issue a compassion center agent a registry identification card
23 within thirty calendar days of approval of an application.
- 24 7. A compassion center agent with a registry identification card shall notify the
25 department of any of the following within ten calendar days of the change, in a manner
26 prescribed by the department:
 - 27 a. A change in the cardholder's name or address; and
 - 28 b. Knowledge of a change that would render the compassion center agent no longer
29 eligible to be a cardholder.

- 1 8. If a compassion center agent loses the agent's registry identification card, that agent
2 shall notify the department in writing within twenty-four hours of becoming aware the
3 card has been lost.
- 4 9. If a cardholder notifies the department of items listed in this section but the nature of
5 the item reported results in the cardholder remaining eligible, the department shall
6 issue the cardholder a new registry identification card with a new random ten-digit
7 alphanumeric identification number within twenty calendar days of approving the
8 updated information and the cardholder shall pay a twenty-five dollar fee. If a
9 cardholder notifies the department of an item that results in the cardholder being
10 ineligible, the registration registry identification card immediately becomes void.
- 11 10. A compassion center shall notify the department in writing within two calendar days of
12 the date a compassion center agent ceases to work for or be associated with the
13 compassion center. That individual's registry identification card becomes void.
- 14 11. The registry identification card of a compassion center agent expires one year after
15 issuance or upon the termination of the compassion center's registration certificate,
16 whichever occurs first. A compassion center agent shall renew a registry identification
17 card by submitting a complete renewal application no less than forty-five calendar
18 days before the expiration date of the existing registry identification card to prevent
19 interruption of possession of a valid registry identification card.
- 20 12. Notwithstanding subsection 2, the department may issue a registry identification card
21 to an otherwise qualified compassion center agent who is a compassion center
22 employee or volunteer and who is not a North Dakota resident.

23 **SECTION 29.** Section 19-24-29 of the North Dakota Century Code is created and enacted
24 as follows:

25 **19-24-29. Cardholders - Compassion centers - Revocation.**

- 26 1. The department may suspend or revoke a cardholder's registry identification card or a
27 compassion center's registration certificate for a material misstatement by an applicant
28 in an application or renewal.
- 29 2. The department may suspend or revoke a registry identification card or registration
30 certificate for a violation of this chapter or rules adopted under this chapter.

- 1 3. If a compassion center agent or a compassion center sells or otherwise transfers
2 marijuana or usable marijuana to a person not authorized to possess marijuana under
3 this chapter, the department shall revoke the cardholder's registry identification card or
4 the compassion center's registration certificate, or both. If the department revokes a
5 cardholder's registry identification card under this subsection, the cardholder is
6 disqualified from further participation under this chapter.
- 7 4. The department shall provide written notice of suspension or revocation of a registry
8 identification card or registration certificate.
- 9 a. A suspension may not be for a period longer than six months.
- 10 b. A manufacturing facility may continue to cultivate and possess marijuana during a
11 suspension, but may not dispense, transfer, or sell usable marijuana.
- 12 c. A dispensary may continue to possess usable marijuana during a suspension,
13 but may not purchase, dispense, transfer, or sell usable marijuana.
- 14 d. Revocation is a final decision of the department and may be subject to judicial
15 review. Jurisdiction and venue of an appeal is vested in Burleigh County district
16 court.

17 **SECTION 30.** Section 19-24-30 of the North Dakota Century Code is created and enacted
18 as follows:

19 **19-24-30. Violations - Penalties.**

- 20 1. A cardholder or compassion center that fails to provide a notice as required under this
21 chapter shall pay to the department a fee in the amount of one hundred fifty dollars.
- 22 2. In addition to any other penalty applicable in law, a manufacturing facility or a
23 manufacturing facility agent is guilty of a class CB felony for intentionally selling or
24 otherwise transferring marijuana in any form, in exchange for anything of value, to a
25 person other than a dispensary or for internationally selling or otherwise transferring
26 marijuana in any form other than usable marijuana, in exchange for anything of value
27 to a dispensary. A person convicted under this subsection may not continue to be
28 affiliated with a compassion center and is disqualified from further participation under
29 this chapter.
- 30 3. In addition to any other penalty applicable in law, a dispensary or a dispensary agent
31 is guilty of a class CB felony for intentionally selling or otherwise transferring usable

1 marijuana, in exchange for anything of value, to a person other than a registered
2 qualifying patient or a registered designated caregiver, to a registered qualifying
3 patient who is a minor, or in a form not allowed under this chapter. A person convicted
4 under this subsection may not continue to be affiliated with a compassion center and
5 is disqualified from further participation under this chapter.

6 4. In addition to any other penalty applicable in law, a dispensary or a dispensary agent
7 is guilty of a class ~~C~~B felony for intentionally selling or otherwise transferring usable
8 marijuana, in exchange for anything of value, in a form other than pediatric medical
9 marijuana oil, to a registered designated caregiver, for use by a registered qualifying
10 patient who is a minor. A person convicted under this subsection may not continue to
11 be affiliated with a compassion center and is disqualified from further participation
12 under this chapter.

13 5. A compassion center or compassion center agent that knowingly submits false records
14 or documentation required by the department to certify a compassion center under this
15 chapter is guilty of a class C felony. A person convicted under this subsection may not
16 continue to be affiliated with a compassion center and is disqualified from further
17 participation under this chapter.

18 6. ~~A compassion center must be fined up to one thousand dollars for a violation of this~~
19 ~~chapter if no penalty has been specified. This penalty is in addition to any other~~
20 ~~penalties applicable in law.~~ In addition to any other penalty applicable in law, if a
21 compassion center violates this chapter the department may fine the compassion
22 center up to one thousand dollars for each violation.

23 7. In addition to any other penalty applicable in law, a registered qualifying patient who
24 intentionally sells or otherwise transfers usable marijuana, in exchange for anything of
25 value, to another person, is guilty of a class ~~C~~B felony. An individual convicted under
26 this subsection is disqualified from further participation under this chapter.

27 8. In addition to any other penalty applicable in law, a registered designated caregiver
28 who intentionally sells or otherwise transfers usable marijuana, in exchange for
29 anything of value, to a person other than a registered qualifying patient to which the
30 caregiver is associated with registration, is guilty of a class ~~C~~B felony. A person

1 convicted under this subsection is disqualified from further participation under this
2 chapter.

3 9. An individual who knowingly submits false records or documentation required by the
4 department to receive a ~~registration~~registry identification card under this chapter is
5 guilty of a class C felony. A person convicted under this subsection may not continue
6 to be affiliated with a compassion center and is disqualified from further participation
7 under this chapter.

8 10. An individual who intentionally makes a false statement to a law enforcement official
9 about any fact or circumstance relating to the medical use of marijuana to avoid arrest
10 or prosecution is guilty of a class ~~B~~A misdemeanor. This penalty is in addition to any
11 other penalty that may apply for making a false statement or for the possession,
12 cultivation, or sale of marijuana not protected by this chapter. If an individual convicted
13 of violating this section is a cardholder, the individual is disqualified from further
14 participation under this chapter.

15 11. A physician who holds a financial interest in a compassion center may not knowingly
16 refer a patient to a compassion center or to a registered designated caregiver,
17 advertise in a compassion center, or issue a written certification. A physician who
18 violates this subsection must be fined up to one thousand dollars.

19 **SECTION 31.** Section 19-24-31 of the North Dakota Century Code is created and enacted
20 as follows:

21 **19-24-31. Protections.**

22 Except as provided in sections 19-24-30 and 19-24-32:

- 23 1. A registered qualifying patient is not subject to arrest or prosecution for the acquisition,
24 use, or possession of usable marijuana under this chapter.
- 25 2. A registered designated caregiver is not subject to arrest or prosecution:
- 26 a. For assisting a registered qualifying patient with the acquisition, use, or
27 possession of usable marijuana under this chapter, if the registered designated
28 caregiver is connected to the registered qualifying patient through the
29 department's registration process.
- 30 b. For receiving compensation for costs associated with assisting a registered
31 qualifying patient with the acquisition, use, or possession of usable marijuana

1 under this chapter, if the registered designated caregiver is connected to the
2 registered qualifying patient through the department's registration process.

3 3. It is presumed a registered qualifying patient is engaged in, or a registered designated
4 caregiver is assisting with, the acquisition, use, or possession in accordance with this
5 chapter if the registered qualifying patient or registered designated caregiver is in
6 possession of a valid registry identification card and is in possession of usable
7 marijuana in an amount that does not exceed what is authorized under this chapter.

8 This presumption may be rebutted by evidence the conduct related to acquisition, use,
9 or possession of usable marijuana was not for the purpose of treating or alleviating the
10 registered qualifying patient's debilitating medical condition under this chapter.

11 4. A person is not subject to arrest or prosecution, for being in the presence or vicinity of
12 the medical use of marijuana under this chapter.

13 5. A manufacturing facility is not subject to prosecution, search or inspection, or seizure,
14 except by the department or a department designee under this chapter for acting
15 under this chapter to:

16 a. Acquire, possess, cultivate, or transport marijuana for purposes of manufacturing
17 usable marijuana;

18 b. Transfer, transport, supply, or sell usable marijuana to a dispensary; or

19 c. Transfer marijuana and usable marijuana to and from a department designee or
20 manufacturing facility in accordance with this chapter.

21 6. A dispensary is not subject to prosecution, search or inspection, or seizure, except by
22 the department or a department designee under this chapter for acting under this
23 chapter to:

24 a. Acquire, possess, deliver, transfer, transport, supply, sell, or dispense usable
25 marijuana or related supplies and educational materials to registered qualifying
26 patients and designated caregivers; or

27 b. Transfer usable marijuana to and from a department designee or related
28 marijuana facility in accordance with this chapter.

29 7. A registered compassion center agent is not subject to arrest or prosecution for
30 working or volunteering for a compassion center if the action performed by the

1 compassion center agent on behalf of the compassion center is authorized under this
2 chapter.

3 8. The medical use of marijuana by a registered cardholder or the manufacturing and
4 dispensing of marijuana by a compassion center is lawful if in accordance with this
5 chapter.

6 9. A person in possession of medical marijuana waste in the course of transporting or
7 disposing of the waste under this chapter and rules adopted under this chapter may
8 not be subject to arrest or prosecution for that possession.

9 10. A person in possession of marijuana or medical marijuana in the course of performing
10 laboratory tests as provided under this chapter and rules adopted under this chapter
11 may not be subject to arrest or prosecution for that possession.

12 **SECTION 32.** Section 19-24-32 of the North Dakota Century Code is created and enacted
13 as follows:

14 **19-24-32. Limitation.**

15 This chapter does not authorize a person to engage in, and does not prevent the imposition
16 of any civil liability or criminal liability or other penalties for engaging in the following conduct:

17 1. Undertaking an activity under the influence of marijuana if doing so would constitute
18 negligence or professional malpractice.

19 2. Possessing or consuming usable marijuana:

20 a. On a school bus or school van that is used for school purposes;

21 b. On the grounds of any public or private school;

22 c. In any correctional facility; or

23 d. On the grounds of a child care facility or home daycare.

24 3. Undertaking any activity prohibited by sections 23-12-09, 23-12-10, 23-12-10.2,
25 23-12-10.4, 23-12-10.5, or 23-12-11.

26 4. ~~Vaporizing~~Using a combustible delivery form of usable marijuana or vaporizing usable
27 marijuana under this chapter if the ~~smoke or~~ vapor would be inhaled by a ~~nonpatient~~
28 minor-child.

29 5. Operating, navigating, or being in actual physical control of a motor vehicle, aircraft,
30 train, or motorboat, while under the influence of marijuana. However, a registered
31 qualifying patient may not be considered to be under the influence of marijuana solely

1 because of the presence of metabolites or components of marijuana that appear in
2 insufficient concentration to cause impairment.

3 **SECTION 33.** Section 19-24-33 of the North Dakota Century Code is created and enacted
4 as follows:

5 **19-24-33. Acts not required - Acts not prohibited.**

6 1. This chapter does not require:

7 a. A government medical assistance program or private insurer to reimburse a
8 person for costs associated with the medical use of marijuana;

9 b. A person in lawful possession of property to allow a guest, client, customer, or
10 other visitor to possess or consume usable marijuana on or in that property; or

11 c. A landlord to allow the cultivation of marijuana for medical use on rental property.

12 2. This chapter does not prohibit an employer from disciplining an employee for
13 possessing or consuming usable marijuana in the workplace or for working while
14 under the influence of marijuana.

15 **SECTION 34.** Section 19-24-34 of the North Dakota Century Code is created and enacted
16 as follows:

17 **19-24-34. Facility restrictions.**

18 1. A basic care facility, nursing facility, assisted living facility, adult day care facility, or
19 adult foster care home licensed in the state may adopt reasonable restrictions on the
20 medical use of marijuana by residents or individuals receiving inpatient services,
21 including:

22 a. The facility will not store or maintain the registered qualifying patient's supply of
23 usable marijuana.

24 b. The facility, caregivers, or hospice agencies serving the facility's residents are not
25 responsible for providing the usable marijuana for registered qualifying patients
26 or assisting with the medical use of marijuana.

27 c. Usable marijuana can be consumed by a method other than vaporizing or
28 combustion.

29 d. Consumption of usable marijuana is limited to a place specified by the facility.

30 2. A facility listed in subsection 1 may not unreasonably limit a registered qualifying
31 patient's access to or use of marijuana as authorized under this chapter unless failing

1 to do so would cause the facility to lose a monetary or licensing-related benefit under
2 federal law or regulations.

3 **SECTION 35.** Section 19-24-35 of the North Dakota Century Code is created and enacted
4 as follows:

5 ~~**19-24-35. Registry identification cards.**~~

6 ~~1. Registry identification cards must contain:~~

7 ~~a. The name of the cardholder;~~

8 ~~b. A designation as to whether the cardholder is a qualifying patient, designated~~

22 ~~registry identification card expires on that date.~~

23 **19-24-35. Rules.**

24 1. The health council shall adopt rules as necessary for the implementation and
25 administration of this chapter.

26 2. The health council may adopt rules regarding the operation and governance of
27 additional categories of registered medical marijuana establishments.

28 3. The health council shall adopt rules to establish requirements for reporting incidents of
29 individuals not authorized to possess marijuana or usable marijuana under this
30 chapter and who are found in possession of marijuana or usable marijuana. The rules
31 must identify professionals required to report, the information the reporter is required

1 to report, and actions the reporter shall take to secure the marijuana or usable
2 marijuana.

3 4. The health council shall adopt rules to establish requirements for law enforcement
4 officials and health care professionals to report to the department incidents involving

- 9 1. The department shall maintain a confidential list of cardholders and each cardholder's
10 address, phone number, and registry identification number.

12 must allow law enforcement personnel, physicians, pharmacists, compassion centers,
13 and compassion center agents twenty-four-hour access to enter a registry
14 identification number to determine whether the number corresponds with a current
15 valid registry identification card. The system may disclose:
- 16 a. Whether an identification card is valid;
- 17 b. The name of the cardholder;

- 26 1. Data in a registration application or renewal and supporting data submitted by a

28 center, or compassion center agent, including data on designated caregivers and
29 physicians, is confidential.
- 30 2. Data kept or maintained by the department may be disclosed for:

- 1 a. The verification of registration certificates and registry identification cards under
2 this chapter;
- 3 b. Submission of the annual report required by this chapter;
- 4 c. Submission to the North Dakota prescription drug monitoring program;
- 5 d. Notification of state or local law enforcement of apparent criminal violation of this
6 chapter;
- 7 e. Notification of state and local law enforcement about falsified or fraudulent
8 information submitted for purposes of obtaining or renewing a registry
9 identification card; or
- 10 f. Notification of the North Dakota board of medicine if there is a reason to believe a
11 physician provided a written certification and the department has reason to
12 believe the physician otherwise violated this chapter.
- 13 3. Upon a cardholder's written request, the department may confirm the cardholder's
14 status as a registered qualifying patient or a registered designated caregiver to a third
15 party, such as a landlord, school, medical professional, or court.

16 **SECTION 38.** Section 19-24-38 of the North Dakota Century Code is created and enacted

- 19 1. The governor shall appoint four members to serve on an advisory board that:
 - 20 a. Shall advise the department in implementation of the compassionate care

25 management on the compassionate care program.
- 26 2. The state health officer shall serve as an ex officio voting member and as chairman of
27 the advisory board.

- 11 7. Any expenses incurred and revenues generated by the department from the
12 compassionate care program.
