- 1 A BILL for an Act to provide an appropriation for defraying the expenses of the office of the
- 2 governor; to amend and reenact sections 54-07-04 and 54-08-03 of the North Dakota Century
- 3 Code, relating to the salaries of the governor and lieutenant governor; to provide an exemption;
- 4 to provide for a report; and to declare an emergency.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the funds
as may be necessary, are appropriated out of any moneys in the general fund in the state
treasury, not otherwise appropriated, to the office of the governor for the purpose of defraying
the expenses of the office of the governor, for the biennium beginning July 1, 2021, and ending
June 30, 2023, as follows:
