

**HOUSE BILL NO. 1018**

1 A BILL for an Act to provide an appropriation for defraying the expenses of the state historical  
2 society.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds  
5 as may be necessary, are appropriated out of any moneys in the general fund in the state  
6 treasury, not otherwise appropriated, and from special funds derived from federal funds and  
7 other income, to the state historical society for the purpose of defraying the expenses of the  
8 state historical society, for the biennium beginning July 1, 2021, and ending June 30, 2023, as  
9 follows:

7       **SECTION 3. REVOLVING FUND - APPROPRIATION.** All fees collected by the state  
8 historical society and deposited in the revolving fund established pursuant to section 55-03-04  
9 are appropriated to the state historical society for the purposes provided in chapter 55-03, for  
10 the biennium beginning July 1, 2021, and ending June 30, 2023.

11       **SECTION 4. GIFTS, GRANTS, AND BEQUESTS - APPROPRIATION.** All gifts, grants,  
12 devises, bequests, donations, and assignments received by the state historical society and  
13 deposited with the state treasurer pursuant to section 55-01-04 are appropriated to the state  
14 historical society for the purposes provided in section 55-01-04, for the biennium beginning  
15 July 1, 2021, and ending June 30, 2023.
