**POINT OF PERSONAL PRIVILEGE**

**SEN. HOGUE** rose on a point of personal privilege.

**REMARKS OF SENATOR HOGUE**

**MADAM PRESIDENT:** Today our state and nation rightfully honor the life and legacy of Dr. Martin Luther King Jr.

Dr. King was a childhood hero of mine. When the gun shots that claimed the life of Dr. King rang out in Memphis Tennessee on April 4, 1968, I was in kindergarten, and far too young to appreciate the significance of Dr. King's words and deeds.

But years later in high school I recalled watching a young television reporter named Dan Rather of CBS News do in depth coverage of the assassinations of President Kennedy, his brother Robert F. Kennedy, and Martin Luther King Jr. These were late-night, hour-long documentary stories not limited to the sound bites of the 5:30 news segment.

As a high school student then, I came away with the strong conviction that Dr. King was worthy of our lasting honor and respect. Dan Rather would describe him as the bravest man he'd ever met. President Ronald Reagan would declare Martin Luther King holiday on November 2, 1983. Ours is a better country because of the remarkable work of Dr. King.

For me the greatest legacy and lesson of Dr. King is his unyielding commitment to the idea that fundamental change in our country could be achieved through nonviolent means. For decades nearly one tenth of our nation's population was subjected to discrimination based on the color of their skin. Segregation in public transportation was declared unconstitutional by our US Supreme Court less than one year after Dr. King led a peaceful and yearlong boycott of the Montgomery, Alabama transportation system.

Throughout our nation's history, we'd scarcely known anything but violence to resolve our fundamental differences. Violence won us our independence from the British empire. Only violence brought an end to the enslavement of hundreds of thousands of African Americans in 1865. Only large scale and unprecedented violence halted the extermination of 3 million jews in Europe and Russia in the 1940s.

But it was Dr. King's deep dedication to non-violence that awakened the moral sense of the nation. This was a man who regularly was threatened with violence against himself and his family, including his children, and his life and movement were ended by cowardly violence. But the evening before his death while addressing a church congregation in Memphis he reminded his listeners: "I've seen the promised land. I may not get there with you. But I want you to know tonight that we, as a people, will get to the promised land."

I realize there remain small traces of bigotry and racism in our land, but Dr. King's steadfast commitment to peacefully advocating for racial equality has brought us to that promised land he so eloquently spoke of, and for that, my Senate colleagues, Dr. King deserves our unending gratitude and respect.

2. All children need models of effective leadership, and children of color particularly need models that show them what they can aspire to.
3. Racism has no place in our state and days like today help us note the progress we have made as well as good work yet to do.

**REMARKS OF MISS NORTH DAKOTA SIDNI KAST**

Hello everyone and thank you for having me here today to speak to you!

As stated, my name is Sidni Kast. I was born and raised in Minot by my parents Scott and Brenda and today we are also joined by my grandparents Adrian and Shirley who recently celebrated 68 years of marriage last August. I graduated from Minot High School in 2016, went on to get my Biology degree from Minot State University in 2019 and am currently pursuing my doctorate in physical therapy from the University of North Dakota where I will be graduating in May of 2024. But how did I get here, today, speaking to you as Miss North Dakota? This journey started back in 2019 on a whim, and under my mom's advice of course. I decided to apply for the job of Miss Norsk Hostfest. I did this because the winner would earn a \$1,000 scholarship and I knew that was something I needed if I wanted to pursue a doctorate degree as the cost of higher education continues to increase. Following this I was given the option to compete as Miss ND, something I never considered doing but I took a leap of faith for scholarship and the opportunity to sing on a stage again. That first year I competed I made the top 10 but was cut when they announced the top 5 and felt pretty defeated. I was an athlete all my life so competitive was my middle name. It felt as though I had failed when in reality it just wasn't my time yet. So I started my education at

UND and made the decision to give it one last shot. Because even if I didn't win Miss North Dakota, I would walk away with scholarship dollars for my education, life skills, and friendships.

However, on June 11th, 2022, my life changed in ways I never imagined. It was the day I was crowned Miss North Dakota and began the job of a lifetime. To give you a little background on myself, and something I always preface with is I am no stereotypical "pageant girl". In fact MOST of the women who compete in the Miss America Organization aren't. This organization has been around for over 100 years and has evolved with the women who compete in it. It gives young women the opportunity to discover what they are unconditionally passionate about. And the reason I say unconditional is because you as leaders all understand, it is not easy to fight for a cause 24/7 but when you love it, it is worth the sacrifices. And now, through those sacrifices, I can proudly say I have earned roughly \$16,000 from the Miss America Organization.

So what is it that I am unconditionally passionate about? As Miss North Dakota I have the opportunity to travel across our beautiful state to speak about what is called my "social impact initiative" which is a cause or issue a title holder speaks about to students, business owners, community members and today, you. The name of my social impact is called the "One Body Movement". This focuses on a holistic approach to taking care of our bodies each and every day. As a future physical therapist, I will be known as a movement expert. But when I created this idea, I wanted it to be more than movement because our overall health is so much more than that. Specifically I focus on physical, mental, and spiritual health each having a direct correlation to the other and impacting the overall quality of life of each of us. When I explain this to people of all ages I try to make them understand it from a different perspective because oftentimes when we think of health is what we see on Instagram, TV, movies. You know the 12 pack abs and perfectly toned arms but I want people of all ages to know, our health is so much more than what we see on the outside. Our health is not only what we feed our bodies, but what we feed our minds. It is who we surround ourselves with but also how we surround ourselves when we're alone.

When I go to school and am speaking to students, I compare their bodies to a car. Because our bodies, like a car, are machines that require maintenance. Now I want you to imagine your car or perhaps your dream car. It likely has four tires. Now, I want you to imagine that each of those tires represents a different part of your life. For me those tires include my physical health, my mental health, my social health and my work/school health. Now for each person those tires will likely represent different things because we all have different responsibilities. But have you ever felt there was a moment in your life where one, or maybe even two of those tires were deflated? The low tire pressure light came on or perhaps the tires were just flat? As we all know, if we have a flat tire, the car won't move forward. Personally I know that a little too well, you could ask my dad (also known as my personal mechanic) if you'd like more details. I'll give you the perfect example of a real life scenario. Over the last few months I have been quite busy. From the months of June to December I was jam packed with Miss ND appearances, continuing my graduate program, taking finals all while preparing for Miss America. My school/work life tire was filled to the brim, I had never felt more successful with my accomplishments and felt I was finally reaching my full potential professionally. My physical health was at an all time high as I continued to take care of myself to look and feel my best on stage. But what I wasn't giving enough energy to, and what was put on the back burner, were my social health and my mental health. I felt my friendships were put on hold, and I wasn't taking enough time to reflect on how I felt because that time simply did not exist. Has that ever happened to you before where work took priority over family/friends? You spent more time at the office than you did at home?

That is what I was experiencing leading up to Miss America. I had flat tires and I wasn't able to move forward efficiently. No matter how hard I pressed the gas, I felt stuck. And I think we all do that when it comes to certain events or times of the year. We put some important things on the back burner and it catches up to us. So what I preach when I speak to people, and it's a message that even I still learn from and consider when I make decisions is we have to find the balance, as best as we can, between our different tires of life. But at the end of the day, even though I've made all of these comparisons between a car and our bodies, the biggest difference is this. You can replace the tires on your car, you can replace the entire vehicle if you need to, but you cannot replace your body. Because you are only given one. And that is why I call it the "One Body Movement" because it helps people understand themselves as a whole, and not just their imperfections.

So how do we get people to buy-in to this concept? How do we break down the barriers that society has built up? This brings me to a method that many physical therapists use when getting their patients to buy-in to treatment. We ask the most important question: "what is your why". Your "why" is the thing that gets you out of bed in the morning, the thing that makes you start something, the thing that makes you, you. I'm guessing when you all started doing this, whether it be 40 years ago or 40 days ago, you each had a why. Whether you're a business owner, or you just started that new year's resolution, you probably had a reason to do so. When it comes to our patients, those whys become more simple than you would think. They want to improve on walking so they can keep up with their grandkids. They want to have better balance so they can enjoy a sunset walk on the beach with their spouse. Or there's that commercial where the grandfather prepares all year lifting weights overhead so when the time comes, he can lift his granddaughter to put the star on top of the Christmas tree. And THAT is what my goal is. It is to show you that taking care of yourself does not have to be for the 12 pack of abs because let's be honest, it's unrealistic but that is what society often makes us think we need to be. But instead it should be for those little moments. The things we don't think about getting to do, until we can't do them anymore. And the reason I love this topic so much and am so passionate about it is that everyone can relate to it. And a quote that rings true is this: "If you do not make time for your wellness, you will be forced to make time for your illness."

What I believe our state needs is better funding for public education and resources to take care of themselves and help future generations thrive. I have been fortunate to grow up in a community that gave me the tools I needed to succeed in my health journey but not everyone is able to have the same opportunity. Our schools especially need better resources when it comes to mental health as that is often the route of all problems as the mind is our most powerful organ. A statement one of my professors made last year that really struck me was: "your zip code defines your health status". I'll say it again, "your zip code defines your health status". Now if this were 5 years ago and you said that to me I wouldn't really understand it because how could where you live dictate if you were diagnosed with cancer, struggled with disease, or worse. But that just proves how much our environment can influence our health and why we need to put regulations in place that gives each member of society a fighting chance. And it is often these people, with the higher chance of poor health, to be unable to afford the demanding prices of a hospital stay. That is why I am so passionate about educating people on the prevention of illness. But, when I tell people this, the first thing they mention is the cost. Why buy the expensive fruits and vegetables when you can go a cheaper route with the chips. That gym membership is way too much. Therapy? That's not included in my insurance plan! But do you want to know what's more expensive than all of those things combined? Hospital bills. Surgery expenses. But people get so stuck on looking at the cost of today that they don't realize our lives are a lifelong investment. Sooner or later, you have to pay up and it's up to you to decide which route you take.

So perspective is a huge part of all of this right? That's something I've learned when it comes to my own life. It was last spring when I relied on my perspective pretty frequently. Oftentimes, in many graduate programs, the first year is the most challenging. It's time for weaning out of the class, even though our professors obviously want everyone to succeed. You have to prove to them, and to yourself, that you're truly passionate about this profession or else you wouldn't put yourself through such a grueling time. So when I was going through this, and trust me, there were days I asked myself - is this worth it? And I would then remind myself of the Sidni a short year before that very moment. The Sidni who was impatiently waiting for an answer on whether or not she was accepted into the school of her dreams to pursue a field that she knew was the perfect fit for her. So that perspective, that shift in mindset is exactly what got me through a difficult time and is something we can all benefit from.

What I will close with today is the same message I used to close my Miss North Dakota interview AND to close my Miss America interview. It is a quote from the song "Invictus". A song that my high school choir director, Lindsey Kerzmann, shared with me just one week before I became Miss North Dakota. It is about a man in the 1800s who suffered a double amputation of his legs and he wrote these words to show that even though all of the odds were against him, that the world seemed dark, he was not going to let that stop him from prevailing. The quote is "I am the master of my fate, the captain of my soul." These words have stuck with me since that moment and have helped me realize that no matter what happens to me, no matter the failures or success I endure, I will have the power to control my own actions, my own fate and that the only person that can limit me, is myself.

**SB 2334:** A BILL for an Act to create and enact a new section to chapter 57-39.2 of the North Dakota Century Code, relating to a local revenue loss reimbursement fund; to amend and reenact subsection 2 of section 57-39.2-04.15 and section 57-39.2-26 of the North Dakota Century Code, relating to a sales tax exemption for a fertilizer plant; to provide a continuing appropriation; and to provide an effective date.

Was read the first time and referred to the **Finance and Taxation Committee**.

#### FIRST READING OF SENATE CONCURRENT RESOLUTION

Sen. Patten introduced:

**SCR 4007:** A concurrent resolution directing the Legislative Management to consider studying the formation of a search and rescue volunteer association.
