

## **CHAPTER 31-05 DEPOSITIONS IN CIVIL ACTIONS**

**31-05-01. When depositions may be used.** Superseded by N.D.R.Civ.P., Rule 26(d)(3), now Rule 32(a)(3).

**31-05-02. When depositions may be taken.** Superseded by N.D.R.Civ.P., Rule 26(a), now Rules 30(a), 31(a).

**31-05-03. Who authorized to take a deposition in this state.** Superseded by N.D.R.Civ.P., Rule 28(a).

**31-05-04. Who authorized to take a deposition out of state.** Superseded by N.D.R.Civ.P., Rule 28(a).

**31-05-05. Officers ineligible to take a deposition.** Superseded by N.D.R.Civ.P., Rule 28(c).

**31-05-06. Commission to take depositions in or out of state - Who may issue - When issued - Form - Interrogatories.** Superseded by N.D.R.Civ.P., Rule 31(a).

**31-05-07. Notice for taking depositions - Required when - Contents.** Superseded by N.D.R.Civ.P., Rule 30(a).

**31-05-08. Depositions may be taken without notice, when.** Superseded by N.D.R.Civ.P., Rule 55(a).

**31-05-09. Time for service of notice for taking deposition.** Superseded by N.D.R.Civ.P., Rule 30(a).

**31-05-10. Service of notice by publication - When permitted - Method - Personal service out of state equivalent to.** Superseded by N.D.R.Civ.P., Rule 5(a).

**31-05-11. Cross-examination of unnamed deponent - Contents and service of notice for - Officers eligible to take.** Superseded by N.D.R.Civ.P., Rule 26(a), now Rules 30(a), 31(a); Rule 30(a), now Rules 31(a), 30(a).

**31-05-12. Taking of deposition may be adjourned from day to day.** Superseded by N.D.R.Civ.P., Rule 30(a).

**31-05-13. Depositions to be written and subscribed by whom.** Superseded by N.D.R.Civ.P., Rule 30(e).

**31-05-14. Officer's certificate to deposition - Required - Contents.** Superseded by N.D.R.Civ.P., Rule 30(f).

**31-05-15. Sealing and returning of depositions - When depositions may be opened.** Superseded by N.D.R.Civ.P., Rule 30(f).

**31-05-16. Time for filing depositions.** Superseded by N.D.R.Civ.P., Rule 30(f).

**31-05-17. Authentication of deposition.** Superseded by N.D.R.Civ.P., Rule 30(f).

**31-05-18. Introduction in evidence of deposition dependent upon showing of grounds for nonattendance of witness.** Superseded by N.D.R.Civ.P., Rule 26(d)(3), now Rule 32(a)(3).

**31-05-19. Reading of deposition permitted by whom, when, and in which actions - Deposition considered whose evidence.** Superseded by N.D.R.Civ.P., Rule 26(d)(4), now Rule 32(d)(4).

**31-05-20. Exceptions to depositions - When and how taken.** Superseded by N.D.R.Civ.P., Rule 30(c).

**31-05-21. Hearing on exceptions to depositions.** Superseded by N.D.R.Civ.P., Rule 30(c).

**31-05-22. Depositions for use in other states or foreign jurisdictions - Taking permitted - Taken before whom - Compelling attendance of witness.** Superseded by N.D.R.Civ.P. 45.
