## ANDREA PFENNIG - PROGRAM ADMINISTRATOR, ND DEPARTMENT OF COMMERCE

Mr. Chairman, committee members, my name is Andrea Pfennig, and I manage the Child Care Grant program for the Department of Commerce. I am here today to provide an update on Child Care Grants.

SB 2014 appropriated \$2.6 million to increase child care capacity in the state, through expansion or creation of child care facilities.

The program was developed quickly with significant input from North Dakota Child Care Aware (formerly North Dakota Child Care Resource and Referral) and the North Dakota Department of Human Services, Early Childhood Services. The maximum grant amount for the biennium was \$187,500 per facility, which was established by SB 2014. The legislation also required a matching requirement of one dollar of matching funds for every three dollars of state grant funds.

The Department of Commerce accepted grant applications between July 1, 2013 and August 30, 2013. Applications were reviewed and awards were announced in September 2013. The full \$2.6 million has been obligated.

Eligible projects included the purchase and renovation of real estate, furniture, fixtures, and equipment. Applicants were required to provide a letter from their DHS Early Childhood Service Regional Supervisor confirming a strong history of compliance or eligibility for future licensure. Applications requesting \$25,000 or more were required to provide a business plan. Applicants were encouraged to use services provided by ND Child Care Aware and Small Business Development Centers. Priority was given to facilities that were increasing infant and toddler capacity and projects located in communities with a child care deficiency of 0-34% as defined by Child Care Aware.

The Department of Commerce intended on having 2 grant rounds. However, due to the volume of quality applications in the first round, it was decided to not accept any additional applications, and to obligate funds to the submitted applications.

We received 77 applications in that first and only round, totaling approximately \$4.95 million in requests with total project costs estimated at approximately \$15.9 million. We will be able to fund 22 projects. Table 1 reflects the details of the approved projects. A map has also been provided to show the spatial distribution of funds.
