### 24 Hour Residential/Daily Skills Training-What is the Goal?

The goal is to learn skills necessary to live successfully in home and communities and gain stability in a supportive environment.

Skills needed daily to live independently, managing money, finding employment or volunteering, personal hygiene, proper etiquette, safety, and finding transportation.

### Case Management- What is the Goal?

Case managers form the **front line** of treatment for people with behavioral health issues. They coordinate care and track the progress of patients who suffer from severe and debilitating health disorders such as bipolar disorder and schizophrenia. Above all, their role is to help patients navigate the complex network of clinics, doctors and community resources that can be daunting to patients and their families.

### Medication Management – What is the Goal?

To reduce avoidable hospitalizations by improving the client's ability to **safely prepare and take** medications as prescribed.
