

**FIRE DEPARTMENT CERTIFICATE OF EXISTENCE  
AND NORTH DAKOTA INSURANCE TAX DISTRIBUTION FUND REPORT**

To the Honorable Gary A. Lee, Chairman of the Budget Section and Committee members,

This report provides information received during the funding years of 2015 and 2016 for the Expenditure of North Dakota Insurance Tax Distribution fund related to the fire department's Certificate of Existence. However, some information from 2015 has not been received from the fire departments.

This report contains a brief summation of the NDCC [18-04] legislation, timeline of activities, funding activities, concerns, resolutions that address these concerns, and appendixes.

## **LEGISLATIVE SUMMATION**

### **North Dakota Century Code Summation**

- **NDCC §18-04-01**

Eligible Fire Departments – Eligible fire department from cities, townships, or fire districts shall be in operation for a period of at least eight months before filing a Certificate of Existence. Criteria for eligibility:

1. Be in existence for at least eight months
2. Meet minimum requirements for class 9 protection or better
3. Compliant with requirements for reporting fires as set forth in NDCC §18-01-06

- **NDCC §18-04-02**

On or before October 31st of each year, the auditor, secretary of a city, or rural fire department of an organized fire department shall file with the State Fire Marshal and Insurance Commissioner a certificate stating existence of the fire department, date of its organization, number of engines, number of hook and ladder trucks, and the type of water supply system.

Certified fire departments, certified rural fire departments, and certified fire protection districts receiving funds shall file a report with the State Fire Marshal detailing expenditures of funds and its committed and uncommitted reserve balances. The report must identify the purpose of any committed reserve balance and anticipated time period for spending the committed reserves. The Insurance Commissioner will compute the

amounts due to certified fire departments on or before December 1<sup>st</sup> of each year, and pay the amount to each fire service jurisdiction in December of each year.

- **NDCC § 18-04-04**

All insurance companies issuing policies for fire allied lines, home owner's multiple peril, farm owner's multiple peril, and commercial multiple peril insurance shall complete a form showing the amount of premiums received for each property within the corporate limits of each city and property inside boundaries of each rural protection district and rural fire department as certified by the State Fire Marshal during the year ending on preceding 31<sup>st</sup> of December.

## **FUNDING PROCESS**

### **Timeline**

The timeline for this process is exhibited below.

- Middle of August, 2014 – Certificate of Existence and Expenditure of Insurance Tax Distribution Fund forms mailed to each fire department.
- October 31, 2014 – Certificate of Existence and Expenditure of Insurance Tax Distribution Fund forms due to State Fire Marshal's Office.
- December 1, 2014 (on or before) - Insurance Commissioner to compute amounts to distribute to each department.
- December, 2014 – Insurance Department distributes funds to certified fire departments.
- March 1, 2015 – Certificates due from fire departments that previously filed three years of Fire Department Existence Certificates.
- Middle of August, 2015 – Certificate of Existence and Expenditure of Insurance Tax Distribution Fund forms mailed to each fire department.
- September, 2015 - State Fire Marshal's Office received 2014 fund accounting from Insurance Office on sum of premiums and refunds paid to fire departments.
- October 31, 2015 - Certificate of Existence and Expenditure of Insurance Tax Distribution Fund forms due to State Fire Marshal's Office.

- December 1, 2015 (on or before) - Insurance Commissioner to compute amounts to distribute to each department.
- December, 2015 - Insurance Department distributes funds to fire departments.
- March 1, 2016 – Certificates due from fire departments that previously filed three years of Fire Department Existence certificates.
- Middle of August, 2016 – Certificate of Existence and Expenditure of Insurance Tax Distribution Fund forms mailed to each fire department.
- September, 2016 - State Fire Marshal's Office received 2015 fund accounting from the Insurance Office on sum premiums and refunds paid to fire departments.
- September 30, 2016 – Resend e-mails and letters to fire departments that did not respond.
- October 15, 2016 – Deputy Fire Marshal's to visit each department that did not respond.
- October 31, 2016 - Certificate of Existence and Expenditure of Insurance Tax Distribution Fund forms due to State Fire Marshal's Office.

### **2014 Funding**

The information for the 2014 funding was received on September, 2015. This information identified that 35 fire departments still had \$160,044 of uncommitted funds. The total amount of funds distributed for 2014 was \$6,780,298.71. This amount of funding was distributed to 321 fire departments that requested the funds. Currently, there are 374 fire departments within the State of North Dakota.


Previously, fire departments were not required to identify what was purchased with the money; although, 59 fire departments responded with this information. There were only 59 (18.4%) fire departments of the 321 fire departments that submitted any information on what items were purchased with the funds. See Table 1 and Graph 1 and 2 on page 5.

The 59 departments equaled 15% of the 374 total fire departments in the state of North Dakota in 2014. The 321 fire departments that requested funds comprised 85% of the total number of fire departments within the state.



## **2015 Funding**

There were 374 fire departments that received \$7,840,603.33 in 2015. A total of \$523,403,441.00 in premiums was obtained from 18,601 entities. The number of departments receiving funding in 2015 increased by 16%, and the total amount of funding provided in 2015 increased by 14% from 2014.

## **CONCERNS**

1. Fire departments are not meeting the reporting requirements.
2. One half (50%) of the fire departments are not currently meeting NDCC [18-04] requirements for reporting fires.
3. Only 18% of fire departments are currently submitting detailed reports about the spending of their funds.

## **RESOLUTIONS**

New initiatives to correct these concerns have already been initiated.

- Added additional spaces to ask more information about the expenditures on the Certificate of Existence forms
- Implement compliance requirements for obtaining funds (fire report submissions)
- Developed cooperative partnership with North Dakota Forestry Service to update fire reporting system.
