

Chairman Flakoll opened the hearing on SB 2199. All members were present.

Senator Erbele introduced SB 2199. The bill was introduced at the request of the North Dakota Soil Conservation Committee. They have had some confusion in their current policy concerning training new district supervisors. Some of their supervisors are elected for 3 year terms and some are appointed for one year terms with the requirement that newly elected supervisors must attend training sessions but it is unclear how often they needed to attend. This bill clarifies that they must attend orientation training once. Senator Erbele also had a proposed amendment to correct wording in the bill. (copy of proposed amendment attached)

Tom Christensen, Chairman of the North Dakota State Soil Conservation Committee, testified in favor of the bill. (written testimony) (meter # 1584)

Senator Flakoll asked, with respect to lines 9 and 10, where referencing date of selection, should the effective date be changed to allow for lag time?

Mr. Christensen said that is not a problem, elections are always in July. He explained the reasoning for the discussion of the term of the chairman was based on the legislative session. A chairman would be in place in a legislative off year then someone else would take over in the legislative year and that sometimes limited the effectiveness of the chairman in dealing with legislative issues.

Senator Flakoll asked if you are limited to three years for life?

Mr. Christensen said a committee member can serve two three year terms or six years total. The member could serve as chairman for three of those years.

Senator Seymour asked how long soil conservation districts have been in existence?

Mr. Christensen said since 1937.

Chairman Flakoll closed the hearing on SB 2199. (meter # 2108)

Senator Erbele said his proposed amendments were drafted by the legislative council.

Senator Klein moved and Senator Erbele seconded a Do Pass action on the amendment. Passed on roll call vote. Voting in favor were Senator Flakoll, Senator Erbele, Senator Klein, Senator Urlacher, Senator Nichols and Senator Seymour. No negative votes were cast.

Senator Klein moved and Senator Nichols seconded a Do Pass As Amended action on SB 2199. Passed on a roll call vote. Voting in favor were Senator Flakoll, Senator Erbele, Senator Klein, Senator Urlacher, Senator Nichols, and Senator Seymour. No negative votes were cast. Senator Seymour will carry the bill to the floor.
