Minutes:

Chairman Weisz opened the hearing on HB 1485. All Representatives were present.

HB 1485 relates to language of information for the title and registration.

Rep. Ruby introduced the bill.

Rep. Ruby: I'm a co-sponsor on this bill. I am by no means an expert in this area.

Rep. Kempenich had showed me a picture of small vehicles that is pretty popular in other countries and also in some parts of the United States. They are coming over with a title that is usually in Japanese and they are not a full fledged vehicle like others, they are a little more than an ATV but they are not quite to the standard of highway vehicles and he was working at having these things registered or titled in North Dakota.

Neutral testimony:

Keith Magnusson, DOT, spoke to answer a few questions.

Magnusson: What this bill does, we already do. He had found that out that we accepted other languages. Normally they will come with a translation with another document where we can translate it to English. Some of the vehicles he is looking at are going to have to do those things in a different way because they are really registered as off road vehicles. One title you

may have seen is from Oregon and they are recalling the title. They are off road vehicles and you are taking care of those.

Robert Behm, Minot, spoke against the bill, but was informed by the chairman that he was speaking to the wrong bill. Statements were withdrawn.

There were no further questions. There was no other testimony for the bill. No action was taken at this time.
