Minutes:

Chairman Herbel opened the hearing on HB 1520.

Rep. Carlson: It is not a new idea to me. It has to do with the composition of the legislative council. Rep. Berg asked me to put this bill in. Discussed composition and went over the bill.

This bill takes it back to a system where the counsel membership would be determined based upon the number of elected members in each assembly so the counsel would reflect the way we are elected. If you figure it out it would come out exactly the way it is. Discussed the problems we have had in the pass and the problems that it has presented. Do with it as you will. The leader felt there was some concern that the party that is in control of both chambers would have a majority of the votes on the counsel.

Rep. Kim Koppelman This would not change the composition?

Rep. Carlson: No it would not change it. It would change it very little. They talk about rounding up so if you were looking today there would be 6 and the house and 3 in the senate. Say the next session the house had a different make up with the Republican are still in control Say it was 56 to 38 and the Senate was 24-23; then is it worthy of looking at. You add those two numbers together there would still be more of one party in both chambers than there would be in the other. Does that deserve to be addressed? I don't know that answer to that.

Rep. Steve Zaiser That would give more power to the house than to the senate?

Rep. Carlson: I think we basically meet once to pick our interim committee members and then we go home. I do not like that at all.


