Minutes:

Chairman Cook called the Senate Political Subdivisions Committee to order. All members (5) present.

Chairman Cook opened the hearing on SB 2246 relating to reimbursement of lodging expenses and allowances for meals for state and political subdivision officers and employees.

Senator Krebsbach, District 40 introduced SB 2246 on behalf of the hospitality association, our state employees and for legislators. Being the fact that in the first quarter the meal reimbursement we are looking to raise from five to six dollars and the second quarter which is the twelve noon to six pm will raise from seven dollars and fifty cents to eight dollars and fifty cents and on the third quarter the sum of twelve dollars to fourteen dollars. This would bring back the amount to reimburse state employees and ourselves and also political subdivisions. The fiscal note should reflect that. If we let this go to long it would be a greater impact on the state budget. The next part would be the increase from fifty dollars to fifty five dollars for lodging. She asked for support on the bill.

Nicki Weissman , Executive Director of the ND Hospitality Association, testified in support of SB 2246. (See attachment #1)

Shannon Gangel, Seven Seas/Doublewood, testified in support of SB 2246. He shared a couple facts with the committee. Last year utilities alone at his properties went up 25%. We are asking for a 10% increase in the state per diem hotel rate and about 15% in food. It would be nice to say that if we allow state employees to stay at our properties at \$50 that we can pass the rest on to the traveling public which we would hope to be out of staters but unfortunately 70% of the hotel quests that we have are North Dakota people. Basically we are asking the public to foot the bill for this state.

Senator Hacker asked at what % of fees increase each year.

Shannon Gangel said he projected about 18% increase in non controllable expenses. The increase in food is about 15%. The problem we have with the per diem with food right now is we are asking for a 15 % increase which is already to low. We have been subsidizing that for many years.

Dave Achtenberg, Ramkota Hotel, Bismarck, ND, testified in support of SB 2246. Costs increase for the hotel every year. There are several bills up both on the state level and national level that could impact us greatly. One of those being the minimum wage increase. We do not know what our cost will be. We need some dollars to help support what we need to get done.

No further testimony in support or opposed to SB 2246.

Nicki Weissman was called back to podium.

Senator Hacker asked if there would be a permanent solution so this did not have to be brought up every session. It costs the government money to pass bills. It would be nice to standardize something like this.

Nicki Weissman said they have talked about that but it was felt the legislators had more control by doing it every two year. We also visited about tying it to the federal rate, so when the federal rate went up the state rate would also.

Senator Krebsbach It was mentioned to try and tie it to federal or do something so it is automatic ever so often. I liken this to what we do with our retirement. We have retirees who would love to have a fixed increase on their retirement, however there are times we have to watch and do what we can on the state budget by the revenue that are coming in. For a long time these people sat without increases and a lot of time what we did in state agencies is reduce travel and adjust according to what we could afford. I think there is a time to look at it but if we let it go another session we will be looking at a bigger increase to catch up. I would like to see some intermitted increases such as what we are purposing in this bill.

No further testimony on SB 2246.

Chairman Holmberg opened the hearing on SB 2246.

Nicki (did not identify last name, who represented, nor sign roster) testified on SB 2246, indicating the hotel association would like to see the increase in daily rate from \$50 to \$55 a day and the state employees per diem to have \$ 6 allocated for breakfast, \$8 for lunch and \$14.50 for dinner.

Chairman Holmberg asked of OMB when this has been done in the past, we had not added additional funding to budgets. We have required the agencies to suck it up.

Senator Kilzer, do you have a handout showing the increases that have taken place in the last decade or so. The response was that she would find out.

Chairman Holmberg indicated that what had been distributed to GVA does not come to Appropriations. The response was Nicki would get that information to the committee.

Senator Tallackson indicated the fiscal note looks at special funds. The response indicated that is how it was handled in the past.

Senator Robinson indicated we said we had not appropriated dollars in the past, I agree with that, but I am trying to reconcile the two. He also questioned whether the hotels would be in on this again. Chairman Holmberg indicated there will be an expenditure sucking away \$260,000 general funds but there is not an appropriation for that. He indicated this section of





Nicki Weissman: Testimony attached.

Rep. Weiler: If I travel in state and go to Fargo, and I see the breakfast is \$6, lunch is \$8, and \$14 for dinner. If I choose not to eat breakfast and lunch, do I get to add them up and use it all for dinner? Can you just not exceed the full day?

Nicki Weissman: My understanding is that everybody has to turn in receipts when they travel. If they don't eat breakfast, then they don't get that reimbursed.

Rep. Haas: It's different. Generally in our travel vouchers you report everything. You have to have a receipt for your room. For your meals you simply report them by quarter. There are 4 quarters on your travel voucher. First is breakfast, second is lunch, third is dinner, and fourth is overnight.

Rep. Froseth: If you look at the bill it says on line 9 breakfast is from 6am to 12, lunch from noon to 6pm, and dinner 6pm to midnight. I noticed in the newspaper this morning that the legislator is getting blasted again for passing a bill in the house that gives the legislator a 12% increase in their salary over the 8 years. This is a 17% increase, don't you think the media will blast us?

Nicki Weissman: You never know what the media is going to do with that.

Rep. Weiler: I still don't know what the correct answer is. Can you exceed the total for the day, or not exceed the total for any meal?

Nicki Weissman: As far as I know the fact is that you can spend all you want but you will only get paid so much. If you pay \$20 on your dinner and your allocation is \$14.50, you have to pay the rest.

Rep. Weiler: The reason I bring that up is because in here you have that the proprietor is responsible for taxes. Any hotel that we stay at for \$55 doesn't have the restaurants. The ones that have the restaurants are \$150 a night like the Holiday Inn. We don't stay there. We don't eat there. The ones that we stay at are the ones that have the continental breakfasts. So again my question is if we do not eat breakfast and I save \$6. If I go to dinner and spend \$20, do I only get reimbursed \$14 or do I get the daily total of \$28.

Rep. Haas: It depends on what you check on your travel voucher. Under the expense column in your travel voucher, there are four different blocks, one for breakfast, lunch, dinner, and overnight.

Rep. Weiler: So even if I don't eat breakfast I still check it for \$6, I will get reimbursed.

Rep. Haas: That is right.

Rep. Amerman: On the automatic gratuity of 15%, do you know in the past when you raise this has that been a part of it too?

Nicki Weissman: The 15% is additional that is added to the gratuity.

Rep. Haas: This was the first bill we heard this morning. The fiscal note is \$260,000 to the general fund.

Rep. Potter: Briefly I can say that I don't think this is worth it. I don't think that we should be asked every session to raise this. I will move a do not pass on SB 2246.

Rep. Weiler: I Second that.

Rep. Haas: Is there discussion?

Rep. Dahl: When the director of the hospitality association was here she mentioned that it was difficult for the hotels to sometimes accommodate state employees. I haven't actually heard that. I was wondering if any other committee members have heard of that.

Rep. Haas: I think that is an excellent point. I have never had trouble finding a room for the \$50 a night. I don't know how everyone else feels about it.

Rep. Potter: To respond to Rep. Dahl's question, two years ago they thought that the \$50 a night was wonderful. They were talking that up. I don't think the price of rooms has gone up that much in the past two years.

Rep. Wolf: Didn't we have a bill similar to this before crossover?

Rep. Haas: We had two bills. One increased the mileage reimbursement rate and one increased salaries.

Rep. Weiler: We had one on lodging tax. I don't know if it was this committee. It was for when we are session to raise the monthly housing allowance.

Rep. Amerman: One thing about the bill that I struggle with is that I don't understand why a 15% gratuity is included. The other thing that I wanted to mention in favor of the bill is if you have a patient at Medcenter One, you can get a thing to go to a hotel for \$55, if you have a family member in the hospital.

Rep. Weiler: I think that in response to Rep. Amerman's question about gratuity that is just a suggestion that you give a 15% tip. That is not in the bill. She is just making the statement that if you get \$6 for breakfast, you have to add on that gratuity.

Rep. Haas: Is there any other discussion on a do not pass motion for SB 2246. The do not pass motion passes with a vote of 10-0-3. Is there a volunteer to carry this bill?



Chairman Svedjan opened the hearing on SB 2246. Amendment 0101 is being distributed.
(attachment A)

Rep Klein moved the amendment 0101

Rep Wald seconded the motion

Rep Klein: What the amendment does is takes out the money for meals. It leaves the \$5 in for motels. The decrease is a total of \$647,837. That is both general and special funds.

Rep Carlisle: What is the purpose for taking the meals out?

Rep Klein: Because it effects not only a large number of people traveling, we figured that in most cases the motels have a continental breakfast. The \$3 change isn't going to be that significant, but the motel money was a major issue so we kept that one in.

Rep Wald: This also impacts political subdivisions because they are all on the same scale.

Chairman Svedjan: The reason the amendment doesn't show any dollars in it is because there is no additional money appropriated for this.

Rep Klein: That's correct. That all has to come out of the existing travel budgets.

Chairman Svedjan: The fiscal impact would be \$600,000 over all.

Rep Klein: No, that's just meals.

Chairman Svedjan: But it would be across all budgets.

Rep Kline: That's correct.

Rep Nelson: Did you address when the last time the meal allowance was addressed in legislation as opposed to the reimbursement for hotel rooms?

Rep Kline: No, we did not. It's been several years since we addressed it.

Rep Wald: The lodging allowance was increased by \$5 last biennium. It went from \$45 to \$50 and this goes from \$55 to \$60.

Rep Kerzman: Some of the debate on the floor was out of state reimbursement of actual costs - is that true of meals too? This just deals with instate meals here right?

Chairman Svedjan: That's correct and there's a different rate. It's tied into the federal rates when there is out of state travel.

Rep Carlson: The point that was made about the fact that it effects other than ourselves is an important point to remember. Because we send a significant number of our state employees on the road to go out and do services and most of us are thinking about ourselves and don't want to raise our own meals, but the point is the majority of that money is not spent on us. It is on our employees that we send out and make them spend the night overnight. They end up going backwards on the deal. It shouldn't cost them money out of their pocket to do the job we send them out to do. I won't support the amendment.

Rep Martinson: I agree with Rep Carlson and once we adopt these amendments, I'm going to further amend to put the \$5 back in.

Rep Klein: It's \$3 not \$5.



Chairman Cook and members of the Committee, for the record, my name is Nicki Weissman. I am the Executive Director of the North Dakota Hospitality Association. We have 350 members in North Dakota engaged in the hospitality industry. We **support SB 2246**. I also want to thank Senator Krebsbach and the other sponsors for bringing the bill forward.

SB 2246 is a bill we see every session or two to adjust the per diem rate paid for public employees for meals and lodging. It simply moves meal expenses from \$24 to \$28 per day, and increases lodging expenses from \$50 to \$55 per stay. The meal rates also include sales taxes (6-7%) and a gratuity (15%) so the real rate to proprietor for the three meals for the entire day is closer to 78% or \$21.84.

As a matter of background, the lodging rate often times places the state employee and hotel in a difficult position, where the hotel has contracted for a large event, and has only a few rooms that are not committed for the event, and are otherwise available to the regular traveler. (Because the state rate maybe substantially lower than going rates at the hotel, the state employee finds him or herself not being able to find accommodations that might otherwise be available.) As members of the hospitality industry we want to

accommodate the public employee in our businesses, but feel an adjustment in the per diem is warranted.

These rates were adjusted slightly during the last session, after being flat for 10 years moving from \$20 to \$24 (for meals) in 2005 and from \$45 in 2001 to \$50 in 2005 (for lodging). The operating costs of our members continue to go up for basic supplies, food, repairs, labor and energy costs, all of which warrant a slight increase for the state employee who stays in a North Dakota hotel or eats at a North Dakota restaurant. The proposed new lodging rate is still substantially lower than many of the hotels in our larger communities, the average cost of which is \$60-70 per night. And in comparison, the federal per diem for North Dakota is \$39 for meals, and \$60 for lodging.

Mr. Chairman and members of the Committee we urge a **DO PASS on SB 2246.**
