Explanation or reason for introduction of bill/resolution:

Create and enact new section relating to the national honor and remember flag

Minutes:

Chairman Bette Grande opened the hearing on HB 1163.

Rep. George Keiser, District 47, appeared in support. This bill is to have North Dakota join other states in adopting the national honor and remember flag. Some background was given. A gentleman by the name of George Lutz had a son who was killed a few years ago. He made a commitment to his wife and himself, but especially to his son, that he would do something to address the special situation of those who have fallen in the line of duty. George Lutz made a commitment that he would travel to all 50 states and make a presentation to one family and then to additional families that could identify within the ___ and present a flag. Last summer he made it to Bismarck. He had three or four families who had lost their children in the line of duty during our recent and current conflicts. I don't normally do this. I made a commitment to Mr. Lutz when he was here and to the veterans that were there at the gathering that I would bring this forward to the legislature and ask North Dakota to join other states. Subsequent to that presentation, as you know, we had a celebration in the Great Hall that the Governor convened to create a day of recognition for Vietnam War veterans. The Governor had a few of us who were responsible for creating that day through legislation last session asked us to appear with him. Then he asked each of us if we wanted to comment, and that is the only point where it got personal for me. When I was a young person, married, had a child, it was a different time. We had a draft. You stayed in college as long as you could. Nobody was anxious to go to Vietnam. There were war protests on campuses. You had choices of going to Canada. You could make a decision to try and enlist and choose your service. I made a lot of attempts to enlist, but I will share with you that in the Vietnam War, it was somewhat of a class war. If you were wealthy and had connections, you could get into ROTC programs that were quickly closed, fully enrolled or you could get into things like the Coast Guard, Air Force, or Navy because they were not really combat zones. If you were a lower income family without connections, chances were pretty slim that you would in fact find the opportunity to enlist even though it is a four-year commitment. My family was a poor family. My father was an immigrant. My mother was a child of immigrants, not well educated, not well connected. I did everything possible, but I missed every possible deferral. There was a marriage deferral. I got married a year after they eliminated it. There was a child deferral. We had a child after

they eliminated the deferral. At that time if you did not take a full load in college, you would be drafted and a full load was 12 credits or more. Long story short, that day comes when you graduate, you are married, you have a child, and I received in the mail my draft notice. I made a decision to enlist in the Army on the provision that I would have the opportunity to go to OCS and become an officer. I served with a company that had a disproportionate number of Blacks, Hispanics, and poor White kids. There was one kid who didn't go to Vietnam. He was a defensive back for the San Diego Chargers, and he kept saying he wasn't going. Once again, it demonstrates it pays to have connections. This is where it gets kind of personal for me. I have made two very long walks in my life. One was coming home on Christmas on leave and had not seen my wife or child for about nine months. At that time to travel as a military person, you had to be in uniform. When I was at the San Francisco airport, I had people spit on me as a war monger. It is a very difficult position to be in, but I could rationalize it because their right to spit on me was being guaranteed by what we were doing and I could live with that comfortably. The other long walk is if I am in Washington DC, I do go to the Vietnam Memorial, because my company friends are on that wall. We lost almost 70% of our company. They weren't close friends, but they had my back and, hopefully, at the appropriate times I had theirs. When I saw George Lutz come forward with this, I said you know he has made a commitment to do this for his son and I am making a commitment to do this for the people who have served our country and who have died in combat. It is an honor and a curse to have served with people who have died fighting with you and for us. **Attachment 1.** George Lutz's organization is attempting to provide flags.

Rep. Lonny Winrich: The letter from George Lutz refers to a federal bill HR 1034. Do you know the status of that in Congress?

Rep. Keiser: I only know the status as he talked about it when he was here last summer. He said that they have introduced it. It is not a high priority for the Congress. They think it could be handled at the states' level, and thus he made the commitment to go state to state.

Colonel Davina French, North Dakota National Guard, appeared. Thank you for the testimony. The person who just walked out is named Kimberly. That is the daughter of Ken Hendrickson who, on Monday it will be seven years, was killed with an IED. This started at TAPS. We are the only state that pays a great enormous amount for our tragedy assistance program. We took 39 family members over Memorial Day in May. Every year it keeps growing. We raise money and we take them there so that they can help heal.

Chairman Bette Grande: I appreciate hearing TAPS is doing that. This committee here has dedicated dollars to TAPS. It has been our mission each year to pool our money and do that. That is nice to hear how that is going.

John Jacobson appeared to testify for himself because the coordinating council has a neutral position on this bill. I was introduced to the bill by a member of the Patriots Riders. He hits all the events involving veterans. He is there with the flag. He showed me the brochure that he had showing the remembrance flag. I thought it was a very good idea and the purpose behind it I didn't really understand or know until Rep. Keiser mentioned it. Personally, I am in favor of the bill and I would like to see you go for it

There was no one neutral or in opposition of this bill.

The hearing was closed.

Vice Chairman Randy Boehning made a motion for a **Do Pass**.

Rep. Karen Rohr seconded the motion.

DO PASS, 13 YEAS, 0 NAYS. Rep. Karen Karls is the carrier of this bill.*

Testimony Attached

Representative George Keiser: District 47 in Bismarck. I bring to this committee a policy issue which in this case is very personal. Many years ago I was a high school student and at that time we had a draft. After high school we had to take a physical and eventually we went to college, it was during Vietnam and it was very interesting there were a lot of was that you could get out of service. Married and a child were on the way. Eventually, male students were required to take a full load or they would be eligible for the draft. After I graduated I was accepted to grad school, after one semester I was drafted. Some of my friends chose to go to Canada and I chose to serve. It was never my favorite part of my life but it was a tremendous experience. There were several things that I discovered; the Vietnam War was a caste war. If you were wealthy and white you could get into the National Guard or ROTC; if you were Latino, Native American, and black, low income white you didn't have that option. The vast majority of us were not coming from wealthy families. Last summer the governor asked me to speak. I remember coming home on leave to see my wife and child and I was very excited. At that time to get inexpensive military travel you had to wear your uniform. I flew through California and it was a very difficult time. As I walked though the airport in San Francisco I was spat on, jeered at, ECT. I didn't get angry, it was their right to do that and it was a result of my and others' efforts. The other walk I remember is walking through the Vietnam Memorial last weekend. There are members of my group that will never make it home. There was a gentleman named George Lutz whose son has been lost in Fallujah. He has a plan to travel to all 50 states to spread the word

about the honor and remember flag. I always have had some frustration that I have left and have a family and a life. There was nothing that I could do for the families, until George Lutz came along. If you could have been there when the governor presented the flag it was very emotional. When Mr. Lutz came Chairman Dever and I talked afterwards and decided to present this bill. We are here to ask for your favorable consideration. This is totally inadequate as a remembrance but it is better than what we have now. I will say that the governor was totally behind it in the ceremony because this is the one thing that I can do.

Senator Berry: So only families and relatives would be able to have this flag?

Representative George Keiser: That is my understanding but it can be flown.

Robert A. Koeller: See attached testimony #1.

Gene O'Neal: I just want to share a couple thoughts I just feel that we should adopt this flag. Too often we all really around the families and then 2 days later we move on. I too, have the greatest respect for the flag, but I feel this is another way for someone to.

Reggie Trebid: POC for honor and remember campaign when it came to North Dakota. We met with the governor and gold star family, this flag does not take away anything from the POW/MIA flag, from the USA flag we are just asking to continue to honor and remember those. It is meant to be flown and remembered so we see that we have lost people. Through history we have not had a symbol; the family that has a family member that has the flag is not a public symbol it is to be held to your heart. We can't give anymore, they have given their lives

Dear Governor

I want to share with you an important action taken by the Commonwealth of Virginia during our 2010 General Assembly session to acknowledge and honor our fallen military heroes. I hope you will consider encouraging your legislature to do likewise.

You may already have heard of the organization Honor and Remember founded by George Lutz. George lost his son, George Anthony Lutz II (Tony) of Chesapeake, Virginia, who was killed by a sniper's bullet while he was on patrol in Fallujah, Iraq in 2005. This tragic event led him on a mission to create a symbol that would serve as a continuous public reminder of all the individuals who have died in military service to America. George designed a flag and started an organization that seeks to accomplish this goal. He worked with our General Assembly members to have a bill introduced that designated the Honor and Remember Flag as the Commonwealth's emblem of service and sacrifice for the brave men and women of the United States Armed Forces who have given their lives in the line of duty.

I am thrilled to have been a part of this historic movement and I am an avid supporter of the flag. I ask that you take a moment to review the attached bill (HJ 137) with the hope that you will want to spearhead an effort to make this flag an official emblem of your state.

As part of his mission, George will launch the *Honor and Remember Across America Campaign* here in Virginia on June 5th. He plans to visit every state capital over a five-month period, making personalized flag presentations to Gold Star families and meeting with state officials to promote adoption of the flag.





I am not a veteran, nor have I served in any of the ~~5~~ branches of service. I stand behind every soldier's choice of employment, although I also believe, that was his or her choice of employment and duty. I chose not to join any military branch on a couple different occasions and for many reasons.

One reason – There are many fronts that require sacrifice from every citizen and/or patriot to ensure life, liberty, and the pursuit of happiness in and outside of our countries borders.

Good morning Committee Chairman Dever, Committee Members, I am Retired Major Harry E. Walters Jr. I am here today to speak for myself alone. I am Life Member of several veterans' organizations which includes 4 of the 5 organizations that make up ACOVA. I am a member of the Military Officers Association of America and the American Military Retirees Association. I am a Life Member of the 75th Ranger Regimental Association & the Vietnam Vets Motorcycle Club. Of all this association I do not know a single veteran that is in favor of the Honor & Remembrance Flag.

I come from a very military family. I took my first tour to Europe when I was less than 2 years old. My father was home on leave from Vietnam when I joined the Army. He retired with 23 years of service. Of his four sons we were all in the Army. I retired with 25 years of service, my brother John retired with 26 years. Our sons have & do serve in the Army. Two weeks ago we went to Ft Campbell, KY to welcome my one nephew home from his 5th tour in combat with the 101st Airborne Division. His younger brother is 100% disabled at the age of 25 due to an IED in Iraq. His cousin, one of my other nephews is preparing to deploy on his 3rd tour even as we speak. Even 2 of my nieces married soldiers. My immediate family has well over 100 collective years of service to this country & the Stars & stripes.

That is the flag we served for and that is the flag I want my coffin draped with when I pass. Mr. Lutz's proposed Honor & Remembrance flag is good intentioned but the flag to honor a fallen soldier should be the flag he or she died for. Please don't ever give my wife anything other than Old Glory.

The only other flag that should be nationally recognized is the POW-MIA Flag. Those that fit in that category have endured a sacrifice of the level none of the rest of us can understand. For that and that alone should there be a special distinction. To continue recognizing flag after flag for special interest groups would leave our flagpoles full but the flags meaningless.

I ask of you in respect of one family's service to this great country of ours, vote **NO** on HB #1163. Are there any questions of me?

March 11, 2011**

I am speaking to you as a concerned citizen of the great state of North Dakota, Bismarck, and as a veteran.

Let us talk a little about the flag of the United States of America (Old Glory). There are those veterans that say we have fought under Old Glory, some have bled under Old Glory, there are those that died under Old Glory, and those that say I will be buried under Old Glory and that is the only flag that is necessary. I respect their views and their wishes. I myself will be buried under Old Glory and proudly fly the flag every day.

Let us skip to the Vietnam War. As a result of the Vietnam War the issue arose of our POW's and MIA's. Our Government in all its prior wars and in its haste to move on forgot about the POW's and MIA's and ignored these warriors. The public and veterans did not stand for this and as a result the POW/MIA flag came into existence and has been recognized and adopted nationally. Because of the POW/MIA flag our government to this day is still looking for and bringing home those warriors. I have attended services for a MIA from Hardin, MT missing for 40 years, a MIA from Billings, MT missing for 39 years, and a MIA from Fargo, ND missing for 42 years. There are those that say this flag is not necessary. I proudly fly this flag so that we "Never Forget" and as a reminder that we must continue to look for and bring these warriors home.

Dear Governor

I want to share with you an important action taken by the Commonwealth of Virginia during our 2010 General Assembly session to acknowledge and honor our fallen military heroes. I hope you will consider encouraging your legislature to do likewise.

You may already have heard of the organization Honor and Remember founded by George Lutz. George lost his son, George Anthony Lutz II (Tony) of Chesapeake, Virginia, who was killed by a sniper's bullet while he was on patrol in Fallujah, Iraq in 2005. This tragic event led him on a mission to create a symbol that would serve as a continuous public reminder of all the individuals who have died in military service to America. George designed a flag and started an organization that seeks to accomplish this goal. He worked with our General Assembly members to have a bill introduced that designated the Honor and Remember Flag as the Commonwealth's emblem of service and sacrifice for the brave men and women of the United States Armed Forces who have given their lives in the line of duty.

I am thrilled to have been a part of this historic movement and I am an avid supporter of the flag. I ask that you take a moment to review the attached bill (HJ 137) with the hope that you will want to spearhead an effort to make this flag an official emblem of your state.

As part of his mission, George will launch the *Honor and Remember Across America Campaign* here in Virginia on June 5th. He plans to visit every state capital over a five-month period, making personalized flag presentations to Gold Star families and meeting with state officials to promote adoption of the flag.

I also want to make you aware that there is a bill in the U.S. House of Representatives (H.R. 1034) that, when passed, will make the Honor and Remember Flag an official symbol of the United States of America. Please visit the organization's website at www.honorandremember.org to learn more.



TESTIMONY ON HB 1163 - ND VETERANS COORDINATING COUNCIL.

A veteran is an individual that has signed a blank check in the amount of and up to including his or her life for their country. Good morning, my name is John L. Jacobsen. I am the Chairman of the Legislative Committee of the North Dakota Veterans Coordinating Council. I am also a member of the American Legion and the Veterans of Foreign Wars.

I served in the North Dakota National Guard and the US Army Reserve for a total of 30 years. I retired in 1995 as a Colonel. I was mobilized for Active Duty in 1991 during Operation Desert Shield/Desert Storm. Like all mobilizations, I left my home and family to serve in the Persian Gulf, stationed in the United Arab Emirates.

The Coordinating Council is made up of 15 members, 3 from each of the five Veterans Organizations in North Dakota:

- American Legion
- AMVETS
- Disabled American Veterans
- Veterans of Foreign Wars
- Vietnam Veterans of America

It is the policy of the Coordinating Council to support legislation that will benefit the welfare of the members of the Armed Forces. The committee MUST concur totally, that is all 15 members must agree on the legislation to be supported or else it does not get the support.

In this case, I have been instructed to recommend to this legislative committee that a "DO PASS" on HB 1163 is supported by the membership of the Veterans Coordinating Council.
