**TESTIMONY BEFORE HUMAN SERVICES COMMITTEE
SENATE BILL 2036
JANUARY 18, 2011**

Madam Chairperson, members of the committee, my name is Lisa Feldner. I serve as the Chief Information Officer for the State of ND. I am here to provide information on Senate Bill 2036 on behalf of the Information Technology Department and the Health Information Technology Advisory Committee.

Senate Bill 2036 contains a change in the last two lines of the bill:

- b. Connect to a wide area network service for health information exchange in accordance with federal requirements for health information exchange.

In early 2010, the State applied for and received a HITECH grant to implement a health information exchange (HIE) to exchange electronic medical records. At the time the grant was written, it was unclear how the HIE would be developed. In the event the HIE was built in the private sector, it was initially determined the language was needed in order for the state to connect its Medicaid system to the HIE – a requirement of the HIE.

Recent discussions with members of the Dakota Carrier Network and the ND Association of Telecommunications Cooperatives have indicated the language is not needed, and that the State could connect to an HIE regardless of who builds it.

SB 2036 Is Unnecessary: Explanation

SB 2036, which relates to the powers and duties of ITD is unnecessary.

First, under existing law section 54-59-02 of the North Dakota Century Code provides as a general policy that ITD is responsible for "all wide area network services planning, selection, and implementation for all state agencies..." But further provides:

Except as provided in section 54-59-05, the department [ITD] may not exercise its powers and duties in a manner that competes or otherwise interferes with the provision of telecommunications service to a private, charitable, or nonprofit entity by a privately or cooperatively owned telecommunications company.

Under current law, subsection 13 of section 54-59-05 of the North Dakota Century Code provides:

"[the Information Technology Department – ITD] [m]ay provide wide area network services to a state agency... or... political subdivision." But subsection 13 further states: "[ITD] may not provide wide area network services to any private, charitable or nonprofit entity except ITD may continue to provide wide area network services [ITD] provided to "private, charitable, and nonprofit entities receiving services from ITD on [or before] January 1, 2003.

Section 2 of the bill of SB 2036 would amend subsection 13 of section 54-59-05 permit ITD to:

"Connect to a wide area network services for health information exchange..."

Because ITD may "connect" to a wide area network service provided by a by a privately or cooperatively owned telecommunications company under existing law, SB 2036 is unnecessary.

Wide area network services means --

A **wide area network (WAN)** is a computer network that covers a broad area (i.e., any network whose communications links cross metropolitan, regional, or national boundaries ^[1]). This is in contrast with personal area networks (PANs), local area networks (LANs), campus area networks (CANs), or metropolitan area networks (MANs) which are **usually limited to a room, building, campus or specific metropolitan area (e.g., a city) respectively.**
