**Chairman Lyson:** Opened the hearing on SB 2117.

**Erik Dietrich,** Law Enforcement Training Coordinator for ND Parks and Recreation Department, presented written testimony in favor of the bill. See Attachment #1.

**Chairman Lyson:** If we pass this bill, will there be more rules and regulations?

**Erik Dietrich:** Citations are always limited. Our efforts are to educate our visitors, not cite them.

**Chairman Lyson:** So you are not looking to put more rules in than you have now?

**Erik Dietrich:** No

**Chairman Lyson:** I see here if they would disagree with you, they could take it to a district court, is that right?

**Erik Dietrich:** That's right.

**Chairman Lyson:** Have you run this by the state's attorney and the court system to see what they think of this? Would it cause an influx for them of people who would choose to go to court rather than pay the fine?

**Erik Dietrich:** I am not sure on that.

**Senator Schneider:** Does the fact that you have criminal penalties right now which means the individual would have to go to court make it less likely that the law enforcement official would cite them and instead choose just to let them go?

**Erik Dietrich:** We try to write as few citations as possible, we try to educate them.

**Senator Freborg:** If someone would poach a deer on park property, the fine would be \$100 to \$250. Would they also be subject to prosecution by Game and Fish?

**Erik Dietrich:** Yes, if there is something beyond our rules, they can be prosecuted.

**Chairman Lyson:** Would your report go to Game and Fish so they could take further action?

**Erik Dietrich:** Yes, we do work with the game wardens.

**Senator Uglem:** You don't see any additional fines being levied then. This is just a change in where they are going to be handled after the fine is levied.

**Erik Dietrich:** That is correct. We don't foresee any increase in our citation writing.

**Senator Burckhard:** Before, when any fine was levied, the money went to some other places. But now you want to use them for improvements?

**Erik Dietrich:** Yes

**Senator Burckhard:** Would there be accounting control?

**Erik Dietrich:** It would probably go into a dedicated account.

**Chairman Lyson:** For clarification, your citations are all numbered. They know exactly who cited the visitors, etc.

**Erik Dietrich:** Yes, we have to record our name and our badge number.

There was no testimony offered in opposition to the bill, and no neutral testimony was offered.

**Chairman Lyson:** Closed the hearing on SB 2117.

**Senator Schneider:** Move to amend the bill.



Minutes:

Rep. Porter: We will open the hearing on SB 2117.

Eric Dietrich: I am here to represent the North Dakota Parks and Recreation Department. I am in support of SB 2117. (See attachment 1)

Rep. Hunskor: Do you warn the people for the violation that they may have? Do you find that after a time or two of warning you have many people that have minor violations?

Eric Dietrich: We push the visitor education first. A citation is the last effort for any park visitor. We don't have many citations.

Rep. Nathe: You talk about using the fines to educate the visitors, how do you educate them?

Eric Dietrich: We use brochures, signage, or use funds to replace the damaged item.

Rep. Porter: I have a concern with the funds going to the State Park Fund. What is currently available to do the PR kind of things that you are talking about without this \$5,000 going to that fund?

Eric Dietrich: The majority of these fines would be used for destruction things.

Rep. Porter: If someone destroys a building at a park and gets caught, would that be a misdemeanor?

Eric Dietrich: All citations are criminal infractions.

Rep. Porter: If there is something as blatant as a destruction of property, wouldn't that be a misdemeanor that would include restitution to the state?

Eric Dietrich: Yes it would mean a court appearance.

Rep. Porter: If there is destruction of public property your handout says \$250.00 and if they do \$2,500 damage, how do you recoup the actual cost of the damage?

Eric Dietrich: We have other avenues available to us. If there is a serious case we can site them under different statutes of the North Dakota Century Code.

Rep. Porter: In those cases would you have to call in someone who is also certified as a law enforcement officer?

Eric Dietrich: For a criminal yes.

Mike Donahue: Representing the North Dakota Wildlife Federation and we support the SB 2117.

Rep. Porter: Is there any opposition for SB 2117? We will close the hearing on SB 2117.



TESTIMONY – SENATE BILL 2117  
SENATE NATURAL RESOURCES COMMITTEE  
JANUARY 14, 2011, FORT LINCOLN ROOM

Mr. Chairman, members of the Senate Natural Resources Committee, my name is Erik Dietrich, Law Enforcement Training Coordinator for the North Dakota Parks and Recreation Department. I appear today in support of Senate Bill 2117.

The intent of this bill is to decriminalize violations of state park rules, which are now criminal infractions. Currently violations of park rules such as having a dog off a leash or failure to display a park entrance permit would result in a criminal infraction. Criminal infractions require a court appearance for someone charged with violating a Regulation. To require a park visitor to come to court for a minor violation did not seem appropriate. It is the opinion of the Department that while these and other state park rules are essential to maintaining a safe and lawful environment, violations of these rules do not rise to the level of being a criminal infraction. Should park visitors engage in serious acts of vandalism, theft or assault the existing criminal code allows our licensed peace officers to respond accordingly. Sections 1 and 4 of SB 2117 address this change.

Section 2 of SB 2117 outlines the procedures for handling these non criminal violations, which is identical to the process used by the Game and Fish Department.

Sections 1 and 3 of SB 2117 set the fines for non criminal violations up to a maximum of \$250.00. Violations of most park rules would fall into three classes of offenses with corresponding fines of \$25.00, \$50.00, and \$100.00. These violations would be the most common and minor. Fines for more serious violations of park rules which are not classified would be subject to a fine between \$100.00 and \$250.00. Examples of this type of violation include destruction of park property or hunting where not permitted.

In regard to fines, Section 1 of SB 2117 also directs fines collected as a result of park violations to the State Park Fund. The attached fiscal note outlines the amount of revenue which fines are expected to generate based upon the number of citations currently written. As you can see the amount is very low, but because the violations being issued are actions taking place in a State Park or Recreation Area, the Department feels those limited funds could be used effectively in visitor education as it related to the most common violations of state park rules. In addition, as we are charged with the protection of these state resources, the funds would also be used to repair minor damage that results from park violations. An example would be destruction of live trees around some campgrounds which some people chop down for fire wood.

In the final section of SB 2117, Section 5, allows the Department to follow the same rules and processes for violations which occur in State Nature Preserves, which the department is also responsible for overseeing. Currently there are only three State Nature Preserves the Department has direct management of and including Nature Preserves in this bill will allow for continuity in our enforcement processes.

The Department requests SB 2117 be amended to include an Emergency Clause which will allow for the implementation of the new process prior to the 2011 summer season, instead of our staff implementing law changes in the middle of our busy summer season.

In closing, annually our 21 licensed law enforcement officers provide for the safety and enjoyment of over 1,000,000 visitors with weekend populations in many of our parks exceeding that of small cities. This bill will aid Department staff in more effectively dealing with the small percentage of park visitors who do not always follow the rules by offering appropriate and reasonable penalties thus ensuring a visit to any one of our outstanding state parks will continue to be a safe and enjoyable experience.

Mr. Chairman and members of the House Energy & Natural Resources Committee, my name is Erik Dietrich. I appear today in support of Senate Bill 2117 on behalf of the North Dakota Parks and Recreation Department.

The intent of this bill is to decriminalize violations of state park rules, which are now criminal infractions. Currently violations of park rules such as having a dog off a leash or failure to display a park entrance permit would result in a criminal infraction. Criminal infractions require a court appearance for someone charged with violating a regulation. To require a park visitor to come to court for a minor violation does not seem appropriate. It is the opinion of the Department that while these and other state park rules are essential to maintaining a safe and lawful environment, violations of these rules do not rise to the level of being a criminal infraction. Should park visitors engage in serious acts of vandalism, theft or assault; the existing criminal code allows our licensed peace officers to respond accordingly. Sections 1 and 4 of SB 2117 address this change.

Section 2 of SB 2117 outlines the procedures for handling these non criminal violations, which is identical to the process used by the Game and Fish Department.

Sections 1 and 3 of SB 2117 set the fines for non criminal violations up to a maximum of \$250.00. Violations of most park rules would fall into three classes of offenses with corresponding fines of \$25.00, \$50.00, and \$100.00. These violations would be the most common and minor. Examples of these minor violations include pet not leashed (\$25), failure to register (\$50) and destruction of natural resource (\$100). Fines for more serious violations of park rules which are not classified would be subject to a fine between \$100.00 and \$250.00. Examples of this type of violation include destruction of park property or hunting where not permitted. Please note, while this bill sets fine classifications in N.D.C.C. it does not increase any fine amounts which are currently set through the Department's existing fine schedule which is attached.

In regard to fines, Section 1 of SB 2117 states that fines collected as a result of park violations are to be directed to the State Park Fund. The attached fiscal note outlines the amount of revenue which fines are expected to generate based upon the number of citations currently written. As you can see the amount is very low, but because the violations being issued are actions taking place in a State Park or Recreation Area; the Department feels those limited funds could be used effectively in visitor education as it relates to the most common violations of state park rules. In addition, as we are charged with the protection of these state resources, the funds would also be used to repair minor damage that results from park violations. An example would be destruction of live trees around some campgrounds which some people chop down for fire wood.

In the final section of SB 2117, Section 5, allows the Department to follow the same rules and processes for violations that occur in State Nature Preserves, which the department is also responsible for overseeing.
