## 2013 Legislative Deadlines<sup>1</sup>

December 6 (Thursday)		Deadline for executive agencies and Supreme Court to file bills with the Legislative Council
January 8 (Tuesday)	1 <sup>st</sup>	Session begins <sup>2</sup>
January 14 (Monday)	5 <sup>th</sup>	No more than five bills may be introduced by each representative after this date
January 21 (Monday)	10 <sup>th</sup>	Martin Luther King Day. <sup>3</sup> Deadline for representatives to introduce bills. No more than three bills may be introduced by each senator after this date.
January 28 (Monday)	15 <sup>th</sup>	Deadline for senators to introduce bills <sup>1</sup>
January 31 (Thursday)	18 <sup>th</sup>	Deadline for introducing resolutions except amendments to the Constitution of North Dakota and study resolutions
February 11 (Monday)	25 <sup>th</sup>	Deadline for rereferrals of bills in house of origin to Appropriations Committees
February 18 (Monday)		George Washington's Birthday <sup>3</sup>
February 26 (Tuesday)	36 <sup>th</sup>	Bills and resolutions except constitutional amendments and study resolutions must be reported out of committee in house of origin. Deadline for introducing amendments to the Constitution of North Dakota and study resolutions.
February 28 (Thursday)	38 <sup>th</sup>	Crossover date for bills <sup>1,4</sup>
March 1 (Friday), March 4-5 (Monday and Tuesday)		Recess
March 11 (Monday)	42 <sup>nd</sup>	Study resolutions and proposed constitutional amendments must be reported out of committee
March 14 (Thursday)	45 <sup>th</sup>	Crossover date for resolutions
March 29 (Friday)	56 <sup>th</sup>	Good Friday <sup>3</sup>
April 1 (Monday)	57 <sup>th</sup>	Deadline for rereferrals of bills in second house to Appropriations Committees
April 11 (Thursday)	65 <sup>th</sup>	Bills and resolutions must be reported out of committee in second house
April 15 (Monday)		Recess - Storm related
May 3 (Friday)	80 <sup>th</sup>	Session limited to 80 legislative days <sup>5</sup>

<sup>3</sup>In 2011 the House and Senate were in session on Martin Luther King Day, George Washington's Birthday, and Good Friday.

<sup>4</sup>In 2013 the House and Senate made crossover on the 38<sup>th</sup> legislative day, Thursday, February 28, rather than on the 39<sup>th</sup> legislative day.

<sup>5</sup>Article IV, Section 7, of the Constitution of North Dakota limits regular sessions to 80 natural days during a biennium and defines a "natural day" as a period of 24 consecutive hours. House and Senate Rules 104 provide that a legislative day begins at 7:00 a.m., so each legislative day ends at 7:00 a.m. the following day.
