

Explanation or reason for introduction of bill/resolution:

A bill relating to patriotic plates.

Minutes:

Chairman Ruby opened the hearing on HB 1323.

Vice Chairman Owens introduced HB 1323. This bill seeks to make a new specialized plate. The plate is designed to allow those in North Dakota to purchase a plate to show their support for our veterans and our military forces. They are patriotic plates. There will be a \$15 fee, \$10.00 of which will go into the distribution fund and \$5.00 to State Treasurer. There will be an annual surcharge of \$10.00 to the State Treasurer. He stands in support of the bill.

Representative Weisz: What does a Patriotic Plate look like?

Vice Chairman Owens: He showed an example of what it would look like. (boots, dog tags, hat, on a flag background)

Representative Gruchella: Is this the same plate from the bill last session?

Vice Chairman Owens: I believe that it is the same emblem.

Representative Kempenich, District 39, spoke in support of HB 1323. He feels that this is a different way to support our military, and we should take a look at it.

Representative Becker: If someone wanted to get a vanity plate, would they only have to pay the \$15 fee for the Patriotic Plate instead of \$25, even if it is a vanity plate?

Representative Kempenich wasn't sure.

Chairman Ruby: Are there any qualifications to get this plate?

Representative Kempenich: No, anyone can get one.

Representative Delmore, District 43 in Grand Forks, spoke to support HB 1323. She has worked on bills like this before. She introduced her good friend, John Hanson, who is a veteran and has been very active in our veteran's organizations. She is pleased to be a sponsor again for this bill and wants to thank our veterans for all they have done. The plate is dedicated to those who have given so much for us, and it allows us to be part of that process. The design is beautiful and fitting.

John Hanson, Veteran from Grand Forks, spoke in support of HB 1323. He provided written testimony. See attachment # 1. (14:52)

Representative Kreun: The plate that Vice Chairman Owens showed, is that the one that you are requesting?

John Hanson: We are requesting a flag background, not in purple. It is the one we would like to see.

Chairman Ruby: I liked the symbolism that you used.

Bob Krause, Chairman of the North Dakota Veteran's Coordinating Council, spoke to support HB 1323. He thinks it is a great plate, and it is a small token that people of the state can use to show honor towards veterans and the military.

Dennis Heap, member of VFW Post 1874 in Grand Forks, spoke to support HB 1323. He feels that veterans have gone unnoticed for many years. They proudly serve their country. He has been thanked for his service many times and feels that it would be great if citizens of North Dakota could show their support by displaying this license plate. It would be a way of saying, "Thank you for your service."

There was no further support to HB 1323.
There was no opposition to HB 1323.

Linda Sitz, Director of Motor Vehicle Division, North Dakota Department of Transportation, spoke in a neutral capacity on HB 1323. She provided written testimony. See attachment # 2. She requests additional time to rework the fiscal note because of the new information provided.

Representative Delmore: How many plates would we have to sell to cover the initial cost of making a new plate?

Linda Sitz: The plate that he is talking about is a general issue type of plate. Right now we were given \$6, 200,000 to create a new general issue plate, because that is for all of the buffalo plates. It is hard to determine what percentage of the citizens are going to take the new general issue plate that the Department of Transportation is being asked to create, and which percentage of the citizens will take this plate that is being proposed.

Representative Delmore: How many plates would have to be purchased to cover the initial setup fee for designing and making the new plates?

Linda Sitz: Can I get back to you with that information?

Representative Schatz: How much did it cost to do the Lewis and Clark plates?

Linda Sitz: I am unaware of the cost, but will check into it.

Chairman Ruby: Did the Lewis and Clark plates have any funds that were directed otherwise? How many are there out there?

Linda Sitz: I would have to research that. About 17,000 of the Lewis and Clark plates were sold last year.

Representative Becker: Is a Lewis and Clark plate \$25?

Linda Sitz: It is \$15 for the initial plate and \$10 thereafter.

There was no further testimony on HB 1323.



Minutes:

Chairman Ruby brought HB 1323 back before the committee.

Linda Sitz provided the revised fiscal note for HB 1323 and reviewed it for the committee.

Chairman Ruby: (5:25) Right now the full amount of the plates is going into the Highway Distribution Fund, and this bill will break it up and divert it into the Veteran's Memorial and Maintenance Fund?

Linda Sitz: That is correct.

Representative Delmore: You seriously think that over 200,000 people will ask for this plate in two years? That is a huge number. How many people ask for a different plate besides a standard one now?

Linda Sitz: This was just a guess. It was hard to know, and we picked 20%. If you decrease the percentage, it will decrease this, but the majority of the money is going into the Post War Fund not the Highway Tax Distribution Fund.

Representative Delmore: Is there a way to amend this bill to get those fees to the Highway Tax Distribution Fund? If it is a veteran's plate, does it have to go to the Post War Fund and not to the Highway Tax Distribution Fund?

Linda Sitz: The way the veteran's plates are set aside, you can only get those plates if the Veteran's Affairs Committee approves that you can get them. This plate doesn't have that limitation on it. That is why we are thinking that the total number of individuals would be higher. In all honesty, the plate is a lot nicer looking than the buffalo plate.

Chairman Ruby: There would be nothing that would prevent us from amending this to make sure that all the funds are retained in the Highway Tax Distribution Fund, correct? Since it is not approved by them, they don't really care about whether they get the money. It is not really *their* plate.

Representative Becker: Is there a split for our current veteran's plates?

Linda Sitz: The 'support our veterans' plate' is a fund raiser for the Veterans' Affairs. \$10 of that goes to the Highway Tax Distribution Fund, and \$15 goes to the individuals that need additional funds above and beyond what they can get through the Veterans' Affairs Office.

Chairman Ruby: Is that the one with the yellow ribboning? How many of those are out?

Linda Sitz: It is, and I think it is 95.

Chairman Ruby: What are the hard costs of setting up and designing a new issue?

Linda Sitz: To set up a new design it is \$1,500 and IT costs of about \$5,000. Then there is the postage to send them out.

Representative Vigesaa: Have you given any thought to how you would finalize the design on this plate?

Linda Sitz: We would talk to the individuals that brought it in and work with the graphic design department in the Department of Transportation and Roughrider Industries. We would come up with a design that works for everyone.

Chairman Ruby: How could we make the changes so all the money goes into the distribution fund? How much of this would we need to remove? Would it mainly be in Subsection 2? Could we eliminate from line 14 down?

Linda Sitz: That is correct.

Chairman Ruby: What about in Subsection B where it talks about paying \$5 to the State Treasurer and then the other annual surcharge to the State Treasurer? Would that just stay to the Highway Tax Distribution Fund or does it go to the State Treasurer first and then back to the Highway Tax Distribution Fund?

Linda Sitz: Everything comes in to the Department of Transportation, and then we distribute it. We technically give it to the State Treasurer, we would split the \$10 that goes into the Highway Tax Distribution Fund and \$5 would go into that State Treasurer. Then they distribute it; if it goes into the Post War Fund or wherever it goes.

Chairman Ruby: Since we have taken away any of that direction, it will all go into the Highway Tax Distribution Fund as it does with a normal plate, we wouldn't need that language as well.

Linda Sitz: That is correct.

Representative Delmore: What would happen if we did that and raised the initial fee to \$20, since it is a brand new plate? Would that help to make it more revenue neutral?

Linda Sitz: I understand that with the changes that you are making, it is not going into the Post War Fund at all now.

Chairman Ruby: So, basically it would be your \$1500 set up fee and postage, and what else?

Linda Sitz: It would also be the computer changes that we have to do to recognize this plate. It is listed on the fiscal note as \$4000 the first year and \$1000 the years after.

Chairman Ruby: We can create the patriotic plate, and we could add another \$5.

Representative Delmore: It is not reserved for veterans. If you want the flashier plate, I don't think that \$20 or \$25 would be out of line. What are vanity plates right now?

Chairman Ruby: \$25 a year.

Representative Delmore: We could change it to \$20 or \$25 and recoup part of the cost.

Representative Gruchella: I believe part of the original intent of this bill was to raise money for the Veterans' Post War Trust Fund. Now we are moving all the money that would go in there?

Chairman Ruby: Yes, it would, unless we put a portion of the \$25 in there if we are raising it higher. How much is a regular plate right now?

Linda Sitz: \$5.00

Chairman Ruby: So, if we kept it at \$15, \$5 could still go into the Highway Tax Distribution Fund and the \$10 could be split between the Maintenance Fund and the Trust Fund, correct?

Linda Sitz: According to this bill it says that \$10 to the Highway Tax Distribution Fund and pay \$5 to the State Treasury. That State Treasury \$5 would have gone into the Post War Fund. It will cost us about \$9 to create each set of plates because of all the colors on here. That is a greater cost than usual.

Chairman Ruby: If we went \$15 and \$5 goes to the State Treasury to go into the Post War Trust Fund. This will cost the Department of Transportation more for each plate. How much does it cost to create a regular buffalo plate?

Linda Sitz: Around \$3.

There was continued discussion on possible amendment and dollar amounts.

Representative Delmore: This is important to several veterans. They take great pride and have tried this plate before. They want people to show that they are proud of what veterans have done. If we can make this as revenue neutral as we can, I think it is just one thing that we can do for them. Everyone can buy them and show their appreciation.

Chairman Ruby stated the amendment for clarification. He suggested an amendment to discontinue the Lewis and Clark plate.

Representative Gruchella: We do have 13 different veterans' plates now.

Chairman Ruby restated the amendment.

There was additional clarification on the distribution of the funds in the amendment.

Chairman Ruby: This will still cost \$1,000,000 to \$2,000,000 either way.

Representative Delmore restated the amendment. (42:00)

There was continued discussion.

Chairman Ruby restated the amendment from beginning to end. (44:50)

Representative Delmore moved the amendment.

Representative Oversen seconded the amendment.

A voice vote was taken. All aye. The motion carried.

Chairman Ruby: We will have to get another fiscal note, but the agency cost of setting up and distributing will still be in place. The distribution fund would not take a hit.

Vice Chairman Owens: Is it our intent to allow personalized status on these plates as well?

Linda Sitz: I would assume that they could be personalized also.

Vice Chairman Owens moved a **DO PASS** as amended and rereferred to House Appropriations on HB 1323.

Representative Delmore seconded the motion.

A roll call vote was taken. Aye 9 Nay 2 Absent 3

The motion carried.

Vice Chairman Owens will carry HB 1323.

This bill requires NDDOT to issue "patriotic" motor vehicle plates.

Explanation or reason for introduction of bill/resolution:

A BILL for an Act to create and enact a new section to chapter 39-04 of the North Dakota Century Code, relating to patriotic plates.

Minutes:

Rep. Dan Ruby, District 38: Introduced the bill.

Rep. Grande: Was this initially a sticker?

Rep. Ruby: The first Fiscal Note was designed with that in mind, that's how DOT understood it too. When we heard testimony, they brought in a possible plate design.

Chairman Delzer: We have some numbers here, but what are they assuming as far as how many people would do this?

Rep. Ruby: I think they estimated 168,969 plates.

Rep. Kempenich: You have to look more at the Lewis & Clark (L&C) issuance for a more realistic estimate, and that was closer to 15,000.

Chairman Delzer: Did you ask the department what the initial cost of setting this up was?

Rep. Ruby: I was trying to figure that out. People are here to provide information if you wish.

Chairman Delzer: I would think the cost would come close to covering it, once it's set up.

Rep. Ruby: Except the initial fee gets put into the highway distribution fund, so it doesn't go to costs. They do get their 61%. That's why we did raise the fee to \$20.

Chairman Delzer: Once they have the set up, what's the cost of punching the plate? And they figure every plate will be mailed?

Rep. Ruby: I don't know if that is all of them, but apparently a percentage of them. A few years ago they decided they were going to get rid of that L&C plate. They were encouraged to keep it going. We should probably thin down the number of issuances that we have.

Chairman Delzer: Have you looked at the bill in the Senate? That is a forced reissuance. This is voluntary.

Rep. Ruby: Exactly. This would still be in place, if that one is forced issuance. That way, anybody that didn't have the patriot plate would have the issuant plate.

Chairman Delzer: If you figured this for 15,000 plates, what kind of numbers would you have?

Linda Sitz, Director of Motor Vehicle, Department of Transportation: That would change it quite a bit. We can get those numbers for you.

Rep. Ruby: I was hesitant, because I want to support the military and let people show their patriotism, but there was some concern about the new issuance.

Chairman Delzer: You would propose stopping the L&C issuance as an amendment on the reissuance, but if the reissuance died on our side and this one passed over to the Senate and they did not put that in, we don't have any way to get that back.

Rep. Ruby: If that's something you wanted to put in, that's kind of a policy issue, but I think it was a consensus with our committee.

Chairman Delzer: It's not just policy, it's money, too. The blanks are all the same on these, it's just what they stamp them with, right?

Rep. Ruby: Obviously the sticker is different. If they stopped purchasing more L&C stickers, there would be some savings with that.

Chairman Delzer: Did you ask them how many of those plates they currently have either produced or available?

Rep. Ruby: We had some discussion about it, but I don't remember the number. Requests have dropped substantially, but they do still get some requests.

Chairman Delzer: Explain how they do a plate, please.

Sitz: What the state pen does is they have metal and sheeting that comes in with the coloring of the L&C, so it's already set, and we stamp it according to the request.

Rep. Grande: Did you have any discussion on moving from the plate to that sticker? Did you talk about the cost difference?

Rep. Ruby: We didn't get into the actual dollars, but we all know it would be much easier and cheaper to do just an emblem on the side of the plate. We had this last session for an issuance, same design. Not that DOT has to pick that design, they may change the colors or the design.

Chairman Delzer: Further questions? Thank you.



Minutes:

You may make reference to "attached testimony."

Chairman Delzer: This is the bill that would create a new issuance of plates, the way it's written. Most of the extra money would go to the Postwar Trust Fund or the Cemetery Fund. I think there are some pretty big fiscal impacts on the way it's written. I'm sure we wouldn't want to do a total reissuance of everybody doing this plate. Frankly, last session, when we said that people could put the ribbon on so that people can ask us for support of the troops as part of the license plate. I don't know what the cost was; I think it was \$5.00, but that money goes to one of the veterans groups.

Rep. Kempenich: The cost of the plate is \$8.81 a pair. It's done in other states. The plate isn't a general issuance.

Chairman Delzer: Have you done any drafting of amendments which would limit it?

Rep. Kempenich: No. I didn't know how much we wanted to change it.

Chairman Delzer: That would be one of the big issues. I think we've got some numbers on the 15,000.

Rep. Kempenich: 15,000 is what we were using.

Chairman Delzer: They sent some numbers on that did they not.

Rep. Kempenich: It was \$8.81 a plate.

Chairman Delzer: They used the same numbers that they have in their big fiscal note. They just lowered it to 15,000. One of the questions we had was, how much did they have left for the Lewis & Clark plates and they said they had enough on hand for a couple of months.

Rep. Kempenich: Two months, 725 that they could print out on that.

Ch. Delzer: Somewhere, I think in the DOT budget, we should probably try to stop the issuance of the Lewis & Clark plates.

Rep. Kempenich: There are about 23 states that have gone in a direction like this. We could run an amendment that they couldn't start production until they get like 2500 plates committed and give the group a chance to see if they can get to that, or 2000.

Rep. Dosch: I'm trying to understand the Fiscal Note, it's saying expenditures of \$2.8 million, but revenues of \$8.1 million.

Rep. Kempenich: That was with a general issuance. I think that was for 176,000 plates would be issued on the original fiscal note.

Rep. Dosch: What is the fiscal impact?

Chairman Delzer: The fiscal effect was still pretty high, even at the 15,000, but it would be about the same as doing that many more Lewis & Clark. The difference on the revenues compared to their expenditures is the extra money that would go to the postwar trust fund or veterans' cemetery. The only question is how many people are actually going to buy the plates, plus we have a general reissuance over in the Senate too, that I don't know where that bill is that.

Rep. Monson: You said delay this until a certain number of orders came in; those people that apply for this want their plates now, they don't want to wait till later.

Rep. Kempenich: We've done this before, maybe it was on the Lewis & Clark, that we delayed and I think it might have been 2000 that the Dept. had to have a request. Basically the groups had to go out and get enough commitments to get it started.

Chairman Delzer: Wasn't that on the initial first sticker, the FFA sticker. They had to have so many orders before they could put the sticker on. We did that with the University stickers as well.

Rep. Pollert: Do you want a patriotic plate, or do you want a veteran's sticker? I see it as a conflict between the two.

Rep. Kempenich: I'm guessing you could get your service sticker, they are doing that now. You can purchase a sticker for an extra \$25 and this got amended so it's paying for the costs and then a little bit going to the Postwar Trust Fund. When it first started, it was a loss.

Chairman Delzer: That issue Rep. Pollert brought up is the one I had heard about. Currently, the veterans' groups each have their own stickers that they buy. This patriotic plate would be for non-veterans. You have to be a veteran to get the sticker. They have to prove that. They are concerned about those patriotic plates overshadowing the stickers. This is just what I've been told.

Rep. Kempenich: It is a replacement of either Lewis & Clark or the buffalo plate. It is a plate.

Ch. Delzer: Committee what are your wishes.

Rep. Grande: We worked hard over the last couple of years, in the Dept. of Veterans' Affairs to get that yellow ribbon to support our veterans. I don't understand why we are doing another one. This was set up for a specific reason, and that was to help out with the cemetery. I liked the yellow ribbon sticker, everybody knows what that is.

Rep. Grande: I move a do not pass.

Rep. Holman: Second the motion for DNP.

Rep. Brandenburg: I'm mixed.

Rep. Owens, District 17: There are two types of methods for developing a license plate. Type 1 is where we can emboss the numbers into the plate. The other is a machine that allows you to literally print what you want on them. A number of other states use that machine to print and they can literally make one tag at a time. It's very cost-effective that they can have 200 different types of tags. You can have one that supports reelection to District 18 Democrats or something like that. It is very inexpensive to do that and for example, Colorado has on their DMV, it actually flashes in red, "over 100 to choose from". It is not embossed, it's not raised, and you get a little mud on it and you can't read it. Law enforcement doesn't like those. Six years ago the machine to do that cost \$1M. I imagine it has gone up a little bit by now. So in order to do a full issue plate. They are talking about colorful background and everything rather than just the logo in the signs, which is what we've got on the veterans' plates now and the ribbon; and everything else in the schools. Because it's just a logo plate on the embossed ones, we get away with only 1500 tags (it doesn't matter how many tags, they make a number of tags) but the cost is kept to \$1500 per issuance if we design a different one. On this tag, that's why it says 15,000; they have to literally print up a large number at once to make it cost effective, to bring that cost down to \$8.81 per pair. That's why the fiscal note says 15,000, because they literally have to do this large number. We're currently doing the embossed, because law enforcement, with a little mud and snow, can't read the old ones; but at least with the embossed they don't cake up as much and law enforcement can still read the tags. This bill is an old friend that keeps coming back every session. This time it passed because it was designed to support those who wanted to show their support, as mentioned earlier of the military, disabled and the veterans where you're not a veteran, that's the purpose. The money would go to the trust fund balance and the trust fund interest, being the interest they can spend and the balance would continue to grow. That is the way the bill is set up now and that's the difference between two styles of making license plates.

Rep. Brandenburg: Did the veterans weigh in with their feelings on this?

Rep. Owen: There were a few veterans there who have helped design this plate, they bring it every year, there was about four of them there. As far as the veterans' groups, a couple of veterans groups reported that out of all the veterans' bills they have, they have category 1 and category 2 priorities. This was a 2, this was not one of their 1's. Because that was specifically asked during the committee.

Chairman Delzer: You remember from Transportation two years ago, is that when we did the yellow ribbon? Do we have that, or do we just have people buying the yellow ribbons and putting them on there.

Rep. Owen: They just can't put them on there. I don't remember that particular one, but they can't just put a sticker on themselves. If it's a sticker, and if there is a location of the tag that's free so when they print up the tag, then they bring in DOT or DMV to put it on there.

Rep. Pollert: How is the money divvied up, does it just go to the highway distribution fund, nothing goes to the postwar trust fund or anything like that.

Ch. Delzer: I don't know about those veterans' stickers. I couldn't tell you on that for sure.

Rep. Kempenich: Just to the highway distribution fund.

Rep. Pollert: Nothing goes to the Postwar Trust Fund.

Chairman Delzer: I don't know for sure about those veterans' assistance program.

Rep. Owen: All those tags are different actually; it depends on what they are for. UND couldn't get the 1500 required to actually create theirs, but NDSU obviously didn't have a problem because they are running all over the place. Out of that \$25 annually to do that, \$15 goes to the university and \$10 goes into DMV. In this case, each one of them are divided up differently. For example, I have a veterans tag and that money goes to the veterans' cemetery, it is spelled out in law.

Ch. Delzer: We will take a voice vote on a Do Not Pass motion. 9 YES, 12 NO, 1 ABSENT
MOTION FAILS.

Rep. Skarphol: I can appreciate people wanting to show their patriotism. But it makes me wonder in this case, if we would be better off just to appropriate the money to the receiving entities and forego the costs of doing this. Seriously, it seems a little frivolous. Rather than invest money in making a license plate, let's just give the money to the entities that are going to be receiving the benefits of it. I appreciate the fact that people like to do this, but this just doesn't seem logical to me.

Rep. Grande: We are giving money to it, because the fee, some of the money, will go into the veterans' post war trust fund and for the second go around here, we're going to be doing that. We put \$210,000 towards the Postwar Trust Fund last time for them to catch up on the principal. Now we have a bill that's going to add money to the principal of it.

Rep. Skarphol: I wasn't suggesting we give \$2M to them, but it seems like a long way around to get to where we are going to give them something.

Chairman Delzer: The fact of the matter is, if we do a reissuance, and I don't know if that will pass, but even if we don't, all of a sudden you have so many different plates out there from ND and if this patriotic plate matches other plates to some degree in other states, you

lose your essence of what ND is all about, too, to some degrees. I understand wanting to support the veterans, but we do really create some questionable situations when we put this many different plates out there just to support them. Is there a way to fix the bill so it actually works?

Rep. Brandenburg: Since we're dealing with all of these veteran bills, couldn't we hold this off to the side and deal with the other veteran bills, and come back to this afterwards.

Rep. Pollert: We have another bill coming in 1439, that wants to put a half million dollars into the veterans postwar trust fund. So we have that bill in front of us. It was amended out from \$2 million down to \$500,000 policy. Then 1323, on the fiscal note, it would put \$5 million into the veterans postwar trust fund.

Chairman Delzer: That is if there was a total reissuance and everybody in the state had to take one of these plates and pay the extra money.

Rep. Pollert: Do you put the chicken before the egg or the egg before the chicken. It doesn't matter which one we do but one of them needs to be smashed.

Rep. Brandenburg: I think that to give \$5 million and everybody is going to buy that plate, I think is a stretch.

Chairman Delzer: But, by the same token, if you're talking 170,000 and going down to 15,000, that's 10% which is \$500,000.

Rep. Kempenich: I'll talk to the parties, but the truth is they couldn't start anything unless they had a 2500 plate commitment. If it isn't big enough to make it work then they can't start it.

Rep. Boe: If someone wanted to move again the Do Not Pass, I'd change my vote.

Rep. Wieland: The main reason I supported it is because my name is on the bill. I hadn't really realized that we were going to be addressing this bill first and not some of the others. I could certainly change my vote.

Chairman Delzer: I think we'll work those other bills, and see what we feel about them and what we end up with and then we can see if this is option that we could look at so that if people really came forward, we could put some more money into the bill. It might be the best option in the end.

Committee moved to another bill. Discussion resumed later.

Chairman Delzer: We have the bill before us. I would say if we're going to move forward, this needs to be fixed with an amendment. There is an option in here, if people did it; it would build the postwar trust fund up. What was the split between the trust fund and the interest?

Rep. Kempenich: Here is the breakdown (see attached #1) and it looks like the first year, in 13-15 and I think it is just going into the postwar trust fund. This doesn't have interest involved in this.

Chairman Delzer: Somebody said it was split, didn't they. It is \$5 to be added to the principal to be considered income. I would say if we're going to put this forward, it should all go to the principal. There should be a change made if you're going to do that, we should change that to \$10 to the principal and then we should probably say that it is limited to the first 15,000 and they have to have 2,500 committed to the plates, before they do any.

Rep. Kempenich: It's what the committee decides. I gave the information out and that would work, or Rep. Brandenburg had another idea.

Rep. Brandenburg: If we could further amend this bill, I would like to do that. Maybe we should turn this into a study and find out if we really have that much interest into it; I think the veterans are being taken care of. I think this is one that maybe we should rethink.

Chairman Delzer: If this does go forward, one of the problems that if we decide to do a general issuance, and I would have no idea what the body will vote on that. It's been a long time since we've done one. You wouldn't want this to be the general issuance and yet, it would cause problems to do a general issuance and have two different plates at the same time.

Rep. Brandenburg: I haven't heard the veterans talk about if they want this or not. You can find out, and they will either love it or hate it, but it does diminish those that in the past are being recognized as veterans and everyone will be running around with veteran's plates, assuming that they are a veteran. I'm just not sure that is what we want.

Rep. Skarphol: I'm not sure what a study would accomplish, it would seem to me that it would be cheaper to hire Odney Advertising to do a poll of the public and see if there is any interest. The veterans could do that to find out if there is enough interest.

Rep. Monson: I happened to have been in that hearing, and they were veterans there and they were pretty passionate about it.

Chairman Delzer: This isn't for the veterans; they already have their plates that say their branch. No matter what we do, even if we put a Do Not Pass on it, I'm not so sure but what we should change that language so that the \$10 goes to the principal of the postwar trust fund and get rid of the \$5.

Rep. Skarphol: I move the amendment to change the language to ensure that the \$10 goes to the principal of the postwar trust fund and delete the language with the \$5.00 for the interest side.

Rep. Monson: Seconded the motion.

Sheila Sandness, Legislative Council: I think the difference is the initial fee and the annual surcharge. So the initial fee is already going to the principal, would you just want the change that the annual surcharge also goes to the principle.

Ch. Delzer: Would we want to put a cap on the postwar trust fund, no I guess not.

Rep. Wieland: What was the original amount of the postwar trust fund?

Chairman Delzer: I believe it was between \$5 million - \$6 million. So they spent \$2 million of that before they got caught. No wonder the audits were so terrible. We have the motion to amend so that any extra money from this would go to the principle of the postwar trust fund. Voice vote - motion carried.

Rep. Kempenich: The initial start-up isn't that bad, if it did pass.

Ch. Delzer: If this does happen to pass, I would ask that when we have the DOT budget, that we look at putting language in there that the Lewis & Clark plate discontinues and this takes the place of it for the second plate of the state, and yet some people might like the Lewis & Clark plate, but I know that they are going to have to buy them again.

Rep. Monson: I have in my notes here, that there is a new issuance bill in Senate too.

Ch. Delzer: Yes, and who knows where that's at. Further discussion. What are your wishes?

Rep. Grande: I move a Do Not Pass as amended.

Rep. Brandenburg: Second the motion.

Chairman Ruby, Vice Chairman Owens, Representatives, members of the Transportation Committee. I want to thank you today to allow me to present testimony on House Bill 1323. A Bill for an Act to Create and enact a new section to Chapter 39-04 of the North Dakota Century Code, relating to patriotic plates.

I'm here today to ask for support of issuing a Patriotic License Plate that will show that every person who purchases this plate that they show Patriotism, to our country, state, Veterans and the now serving Military and future Military who guards our rights and freedoms.

What is the Definition of Patriotic? Webster's Dictionary states that it is to be: loyal, devoted to, committed, steadfast, and unwavering. This describes what our Veterans and Military have showed in the past and will continue to show in the future.

You are asking why a Patriotic License Plate. Since the WW I and WW II the Military came home to a Welcome Home Celebration that history still preserves today. Then Korea that took our Military to a Foreign Country to fight Communism, and stood steadfast to not allow the Communist to take over the whole country at the loss of many people. When our Military came home from Korea the Welcome Home was not as great as WW I and WW II, and we have to remember that many gave there all in Korea, Viet Nam is called a "Conflict" where is seemed to be a War Zone to the Military who served in Country and the surrounding areas. It was real, with the deaths and injuries that many still have today from Viet Nam, PTSD and many more silent injuries that only those who have served know about. When the Military came home from Viet Nam, the received a Welcome Home with demonstrations, at the airports, where hundreds gathered, to yell, and I will not repeat what they said or the actions that they showed to the Military. Desert Storm Military came home as Heroes for what they accomplished, we have been at "War" for ten years or more, the Welcome Homes are tapering off.

As I stand here I think of a day last week when I presented the American Flag to a family of a Veteran that I had known for over 40 years, who had passed away, who served our country, protected our flag, I was presenting a flag with the words, "From a Grateful Nation I am proud to present this Flag of our Country that Skip so proudly served". How many have looked into the eyes of the family which lost a loved one now we can show support to the spouse and the family, with the American Flag, that has covered so many caskets in years past and many more in the future. This is another reason for the flag background. He paid the price of service, now we need to pay the price to say thank you with the new plates

This is the reason that we need a Patriotic Licenses plate for anyone to purchase and to proudly display on the vehicles they own. This will show support to our Veterans, in hopes that the ones who did not get a Welcome Home they deserved will see a Patriotic License Plate on a vehicle and see that this is meant to "Remember our Veterans" for what they did for us. You may be

asking what this plate will look like, to me it needs to have our flag in the back ground and a design that all Veterans know the meaning of, and a figure that only the Veterans know the true meaning of and that is what I call a "Booney Stomper" that shows true meaning and devotion to our Veterans and the Military.

I know that this may cost some funds from the state to design the new background, but the initial fee should cover this, by the ones who purchase the plate, but to me what the Military and the families have already paid, with their loved one going to fight for Freedom, and may not come home, the price does not compare to what unwavering devotion that the Veterans, the Families of the Veterans and the Military of today pays each day, waiting or have waited for their loved one to come home.

As I stated before is that anyone who wants this plate, shows loyalty to the Veterans and the Military every day of the year when their vehicle is traveling down the street, interstate, and into other states it shows that North Dakota is proud of our Veterans and Military, each and every day. The cost of the License Plate, you have to remember those who have already paid the price.....

In closing I want to tell you of a part of a meeting I was at, with Mr. John Marshall, who some of you may know, we were at a meeting to discuss the Veterans Memorial Park in Grand Forks. During our discussion it became very still in his office, he had a look on his face that a few have seen as he reached into his desk, he stood up, put his hand out and clasped my hand and when I opened my hand he had presented me with his coin, I thanked him for the coin and he stated "No thank you for your service". I looked at the coin in my hand and I read the inscription, that is inscribed on the face of the coin, with the words "Freedom is not Free thank you for mine." I will remember that moment when John thanked me again for his freedom. We talked about what is the cost of Freedom, when a Military member did not return home, when a life was lost, or the life of a Military member was changed forever The cost that some Veterans still pay, with the non-visible wound that no one see's, except his loved one when they wake up at night in a cold sweat and shaking as they are relive a incident and cannot forget what happened. Their lives are changed forever. The Patriotic Plate will show that we Remember and support them.

Thank you again for allowing me here today so that we can show our loyalty to our country and North Dakota, that we remember our Veterans and Military for what they have done and still do, with passing this House Bill.

House Bill 1323

Mr. Chairman and members of the committee - I'm Linda Sitz, Director of the Motor Vehicle Division at the North Dakota Department of Transportation (DOT). Thank you for giving me the opportunity to present information to you today.

Before DOT testifies we would like to acknowledge the sacrifices of our veterans and thank them for defending the freedoms some of us take for granted.

House Bill 1323 appears to introduce another license plate series to Motor Vehicle. Currently Motor Vehicle issues 63 types of plates resulting in 382 different license plate types on which registration fees are calculated. Each new plate inventory must be stored at Rough Rider Industries. With 63 types of plates already in existence, this bill adds to the complexity of what is asked of DOT and Rough Rider Industries. Currently 14 varieties are available for veterans or veteran's causes. See appendixes A, B, and C.

This bill states the director shall issue a plate which would be called a Patriotic plate. The bill is silent as to what a Patriotic plate is or who is responsible for paying for or creating such plate. To give you an example of our setup fees associated with our cost of a new organizational plate, normally and pursuant to N.D.C.C. § 39-04-10.13 DOT charges \$1,500 to create a new organizational plate and requires a minimum of 50 applications plus payment from intended purchasers. Under this statute, the new organizational plate's yearly fee is twenty-five dollars; ten dollars goes to the highway tax distribution fund and fifteen dollars goes to the organization.

As DOT interprets this bill, the initial fee of fifteen dollars will be split between the highway tax distribution fund, with five dollars going to the post war trust fund. The entire annual surcharge collection of ten dollars will be paid into the post war trust fund. Each year thereafter all surcharge funds of ten dollars will go to the post war trust fund and nothing will be deposited into the highway tax distribution fund.

SB 2326 adds more complexity to the situation by stating the director **shall** make a plate general issue during the next biennium. If SB2326 is passed, each buffalo type plate will need to be recreated with the variety of organizational logos.

There is a fiscal note attached to this bill.
