John Paczkowski from the Chief Regulatory Section of the ND State Water Commission introduced the bill. See Attachment #1.

Chairman Lyson questioned whether the board had a track record of not responding.

John said they respond about 50% of the time and that they meet maybe once a month and are allowed 45 days to respond. He theorized why there may be response delays.

Chairman Lyson questioned if a procedure has been started and then they get a response, can the procedure be interrupted?

John said that could be done.

Senator Burckhard asked for an example of who would have to apply for this and why would they apply for it?

John responded if an entity is going to build a dam for example they would be required to file a construction permit and by code they must notify their local water resource board of their intention. That gives the water board a chance to weigh in on the project and give input to the State Engineer's office before processing the permit. There are water resource boards roughly for each county. There are additional boards within basin boundaries.

Senator Triplett asked what happens when there are overlapping jurisdictions of water boards in a region.

John responded that there are joint boards formed when multiple counties are involved and there is a primary county put in charge.

Senator Triplett asked whether he has heard from the water boards that the 45 days is too short a time.

John said he hasn't heard that it is.

Senator Murphy questioned how jurisdiction works when there are multiple boards that overlap.

John attempted to clarify how it works.



TESTIMONY ON SENATE BILL NO. 2052

Mr. Chairman and members of the Natural Resources Committee, my name is John Paczkowski and I am the Chief of the Regulatory Section for the State Water Commission. On behalf of State Engineer, Todd Sando, I am here in support of Senate Bill No. 2052 which will clarify procedures when a water resource board fails to provide a response regarding a construction permit application.



As part of the permitting process for the construction or modification of a dike, dam, or other device used "for water conservation, flood control regulation, watershed improvement, or storage of water" that meets the permitting threshold, N.D.C.C. § 61-16.1-38 requires the state engineer to forward the application "to the water resource board of the district within which the contemplated project is located." This process makes the board aware of the project and allows the board the opportunity to suggest any changes, conditions, or modifications to the state engineer.

As it provides now, there is no direction given regarding how to deal with the lack of a response from the water resource board. The additional language being proposed today will simply codify the process staff has been using to deal with just such situations in the past.
