Senator David Hogue - Chairman

Senator Larry Robinson - District 24 - Introduces the bill and said he was asked by the Municipal Judge Association. This bill expands the ability of municipal judges to solemnize marriages. He relates his experience with his wife that coordinates marriages for Riverbend Farm.

Senator Nelson - Asks if the clerks of court and the recorders also have a location restriction.

Senator Robinson - Said he knows in the case of municipal judges their jurisdictional area is the city limits. That is what they are trying to address here.

Judge Bill Severin - Municipal Court Judge, Bismarck - In support of the bill. He said it is practical and it's positive. He gives an example of weddings he has performed. He says the clerks of court cannot perform weddings.

Senator Berry - Asks if he can preside over a wedding from while in a different location.

Judge Severin - Replies he believes so because you don't have to hold court in a courthouse, you hold court wherever the judge is sitting. He explains the private arrangements he makes with couples that he weds.

Vice Chairman Larry Klemin: Testimony from Senate Judiciary Committee Reverend Auntie Carel Two-Eagle Pipe Keeper, and Presiding Bishop, Church of the Helping Hand, Inc. on page two of her testimony she refers Section 6 and says "No state or federal law is allowed to recognize or to not, recognize any method of worship, so the language recognized denominations is illegal and they cannot exist without its blessing, then chapter 10-33 is probably unconstitutional and illegal as well. Therefore Section 6 should be struck from the final version of this bill".

Chairman Kim Koppelman: 10-33 is still part of the law, it is licensed clergy and that is an interesting point but it really isn't what the bill is about. If you notice item 7, I remember when we put that in and that says by any person authorized by the rituals and practices of any religious persuasion. I think her point is cared for in the law already and if we are going to call it clergy and we have a chapter on licensing clergy we should continue to cross reference that section. My recommendation is that we remove the overstrike on line 6.

Hanh, Senator Hogue and members of the Senate Judiciary Committee, and the sponsors of this bill. I send good greetings and strong prayers to you all.

For the record, I am the Reverend Auntie Carel Two-Eagle, a Traditional Lakhota spiritual person, a Keeper of a Holy Pipe, and the Presiding Bishop of the Church of the Helping Hand, Inc. I come before you today about SB 2225, to advise you of some problems with its original wording, and to recommend changes which will improve it, and make it acceptable under the Constitution of the USA.

The first bill I ever testified before ND Legislators on was a similar bill, back in 1997, & it was also before the Senate Judiciary Committee. I told that Committee that some of the wording in that bill was unConstitutional in its original form, and I am telling you the same thing about this bill, now. The 1997 Senate Judiciary Committee was wise enough to listen to me, and then-Senator Marv Mutzenberger and I worked on amending that bill, which was eventually passed and signed into law. It is my prayer you will be similarly wise.

In the 1997 bill, reference was made to "ordained Christian ministers", which is unConstitutional, because it violates the Doctrine of Separation of Church and State. In this bill, Section (4), which specifies "ordained ministers of the gospel" is similarly unConstitutional, and therefore illegal, because Christianity is the only religion which refers to its "guidebook" as "the gospel". The US Constitution specifies that there shall be no law made regarding establishment of a 'religion of state'. The Supreme Court has upheld this section of the Constitution and the Doctrine of Separation of Church and State repeatedly.

The over-arching superiority of the US Constitution over all state Constitutions is well-documented - therefore, no state Constitution can make even the appearance of an 'official' religion either.

Section (4) should be struck from the wording of SB2225 for that reason, as well as the fact that Section (7) makes it redundant. The wording of Section (7) covers everything needed.

For that reason, Section "(5) priests" should also be struck.


Section (6) of SB2225 refers to something that is not allowed by the Constitution - licensure of clergy. It does not matter whether it is 'by the state' or by any group.

Section (6) mentions "recognized denominations pursuant to chapter 10-33", apparently of the ND Century Code. No state or federal law is allowed to recognize or to not recognize any method of worship, so the language "recognized denominations" is illegal under the US Constitution. Since the US Constitution enlivens all state Constitutions, and they cannot exist without its blessing, then Chapter 10-33 is probably unConstitutional and illegal as well. Therefore, Section (6) should be struck from the final version of this bill, and Chapter 10-33 needs a close looking-at, too.

Again, the language of Section (7) makes the language of section (6) redundant - in addition to its unConstitutionality.

By removing Sections (4), (5), and (6) from SB2225, we would have a bill which meets Constitutional requirements and which would not result in eventual litigation which the state of North Dakota would lose; litigation which would be easily and entirely avoided by said removal of these Sections of this bill.

Thank you for hearing me in a good way now, and for heeding my council in these regards. I stand ready to answer any questions you may have.
