Minutes:

**Relating to a request by a legislative majority or minority leader for an opinion of the legislative council on the constitutionality of pending legislation.**

**Senator David Hogue - Chairman**

**Senator Triplett** - Introduces the bill and explains its intent. She said they are trying to help the membership of the legislature think about the constitutionality of bills before passage. She goes on to say it is in all of their interest to improve the process. The bill allows any of the four leaders of either House to make a written request to the director of Legislative Council directing an issuance of a formal opinion of Legislative Council on the constitutionality of pending legislation.

**Senator Sitte** - Asks if she has an example of the issues.

**Senator Triplett** - She states the one that brought it to her mind was the fighting Sioux bill last session.

**Senator Hogue** - States that the attorney's in Legislative Council regard themselves as a lawyer for the Senator or Representative that they are crafting a bill for and respect the attorney client relationship. He asks if this bill will change that if they tell a legislator their bill is no good.

**Senator Triplett** - Says they do that already and it wouldn't be just one person's opinion.

**Senator Hogue** - Asks if it would be in form of a formal opinion.

**Senator Triplett** - Replies yes, but if formal opinion is the wrong phrase it could be changed. She just wants it in writing. She goes to explain there would be a time crunch because of the legislative process. The idea is to provide a higher quality bit of information to legislators.

**Senator Hogue** - Asks if this would compromise their neutral stance on bills when they have to rule on the constitutionality of it.

**Senator Triplett** - She still sees it as a role to help the committee. She explains she hopes they would offer a solution to a problem. She does not see this as adversarial in anyway but a help to legislators.

**Tom Trenbeath** - Chief Deputy Attorney General - In support - He said their office is happy to provide opinions but are uncomfortable with constitutional questions. He said it is their role to defend the constitutionality of anything the legislature passes. He explains how an amendment changes their opinion. He said this provides a format for a formal presentation through leadership with a formal response from the attorney's in Legislative Council.


