

An Act to establish a statewide human trafficking commission.

**Chairman K. Koppelman:** Opened the hearing on SB 2219.

**Senator Poolman:** See testimony #1

**Rep. L. Klemin:** Last sentence on subsection 1 on page one; Attorney General may establish the commission by appointing an existing state wide coalition. What does that refer to?

**Senator Poolman:** I am going to guess that I may be referring to FUSE.

**Attorney General Wayne Stenehjem:** I would appoint a committee of 9 or 10 people if this were to pass. That would include one of our agents from BCI; the victim advocate if that is approved that is part of my budget as it now stands in the House, a representative or two from FUSE that is the coalition that Representative Klemin referred to. I would not intend to just appoint that group, I would focus on a couple of members of that which would include the counsel on abused women services, a prosecutor either from my office, an assistant AG or from the North Dakota Association of counties. We will need some none government organization involvement because there are some of those organizations providing services as well as the faith community. There are a number of churches that are providing services and I think that is critical that we have their involvement as well and the local law enforcement. My intention would not be to just appoint someone else and have them take care of it.

**Rep. L. Klemin:** I don't think I have ever seen anything like that where you can just appoint a coalition and take it over?

**Attorney Stenehjem:** You can take that out if you want I don't have any objection to it. I have kind of outlined what I think the group would be and that would enable us to do the kinds of things that need to be done. I had just become aware in the last year or so that

there are churches that are providing services and I think it is important that we include them. There are a number of request we get for law enforcement saying please come out and do some training so I think coordinating with training activities could be useful and input from this group on the kinds of training that our needed and are available is helpful. There also are public awareness campaigns. The state of Montana for example has a poster campaign where they place posters urging people who feel they may possibly be victims of human trafficking to call the national hotline. Those are posted at truck stops, hospitals and even some at hotels. We would want to do that kind of thing as well.

**Rep. L. Klemin:** On other kinds of commissions we have all this stuff about them being paid compensation for their time.

**Attorney Stenehjem:** I intend not to pay per diem, because they would already be employees. I am hoping not to incur many expenses.

**Chairman K. Koppelman:** Double dipping has occurred at times and we said that is not the intent so it is wise to go about it the way you are suggesting. When I read that line I actually was impressed with it, because the first knee jerk reaction I hear from a lot of our colleagues when they see a bill like this is do we need another government body. The idea that maybe there is something or a group out there would be good efficiency.

**Attorney Stenehjem:** So it is clear I don't intent to do that. I think it is important that we have the components that I was talking about so we can coordinate everything, find out who is doing what. There are a lot of things that are going on that others may not be aware off and I think focusing it all together makes a lot of sense.

**Dan Olmer ~ Volunteer on Youth Works:** This bill ties it all together. If you think of 2107 that you are working on now you are changing the law, we are taking a serious step forward with that particular piece of what the law will be and how we want to treat this particular problem. The second bill that is in my mind fairly critical is 2199, the million dollars that I sincerely hope this committee will seriously advocate for because it doesn't work unless you put the money behind it. We are really not exactly sure what we are going to do with all of these victims. At Youth Works we have had a number of them. We have had to protect them from pimps and there is sort of a fine line as to whether or not this is sort of a witness protection program we are entering into or is it a treatment plan. There is a lot that we have to learn and I think that 2219 ties it all together. I am very impressed with Wayne Stenehjem taking this on as seriously has he has been. We trust that he will do as good of a job as he does with everything else.

**Chairman K. Koppelman:** I know that the Attorney General's around the country worked together on various issues, could you highlight for the committee what if anything is going on in this front with human trafficking?

**Attorney Stenehjem:** This is a huge issue with the National Association of Attorneys Generals. We have worked together, we have had a number of training sessions, and educational programs for ourselves. This is an issue that is going on all across the country and the other thing I want to mention too is we talk about sex trade but this human

trafficking also involves the labor trade so it is not just entirely the sex trafficking and that is something we haven't even started to get our hands around here in North Dakota.

**Chairman K. Koppelman:** With that in mind is there cooperation occurring state to state then to try deal with the issues?

**Attorney Stenehjem:** Yes we have a number of programs and training sessions and some law enforcement initiatives will be announcing a little bit later about efforts with federal, local and Montana.

**Rep. Kretschmar:** How often do you envision this commission will meet?

**Attorney Stenehjem:** It will first depend on the package of bills that you pass and what you do with the legislation that we have and then who is on the commission. Then that commission will be discussion how often it is that it is necessary, probably more often early. Maybe we can do it less often later on, but we will need to wait and see how things proceed. This is a very critical part of the entire package of legislation that you are considering and I thank you for the tremendous amount of time you have spent and the attention that you have given to this issue.

**Christina Sambor ~ FUSE Coordinator:** Fuse has really positioned itself to be a clearing house for an overall impact that this issue is having state wide and discipline wide. We have a leadership group that we go to and talk to about 25 people just to get one person to speak for all those voices, we kept it as small as we could. I think that is really a place where it is a safe space for everyone to talk and contribute their ideas and BCI has a seat at the table as does the US Attorney's Office and have been a strong voice at FUSE. However there are separate needs of the law enforcement community to have places where they can have really frank discussion about operations and that is going on around the state as well. I think 2219 gives us a great opportunity to bring what FUSE is doing and apply it broadly to some of those other efforts so that we all have a place to talk about what the different sectors are doing. In practice you see that those different practitioners want to collaborate but they also want to have collaborations within their specific sector. Really what this does is it builds that state wide effort. This is something that as the Attorney General mentioned is really best practice across the country and something that is encouraged very strongly by the Officer Victims of Crime Division of the Department of Justice and things that they will support financially too. Those will be things that we will be looking for in the future in terms of service provider roll. I think it is great to have a statement in a century code that this is something that needs to continue and something that is highlighted as a priority in our code.

**Rep. Lois Delmore:** I think many of you probably will be involved in this commission as well and I think it will be helpful to have a state entity where we can draft legislation, we can get some of the other things that maybe would be more difficult for you to do just as your own group, would you agree with that?

**Christina Sambor:** Yes I do. What I think really has been one of the most encouraging things with this whole thing is the level of cooperation and integration between the Attorney General's office and our coalition and so we fully expect and have been told that we would

defiantly be welcome as part of that conversation. I don't think we look at is a territorial issue, we understand that from a practical stand point something moving on some of these concrete things can be hard to do when you have a group of 25 so maybe kind of pulling that together with a couple representatives and taking that to people that are more focused on the law enforcement side or people that are starting to look at the labor trafficking side of things. Labor trafficking is something we haven't really started to approach. Our coalitions focus specifically on commercial sexual exploitation and so we certainly see the need to start collaborating around labor trafficking as well and would welcome the opportunity to lend our experience and what we have done on the commercial sex side to that effort.

**Chairman K. Koppelman:** Do you know if there is a big problem in North Dakota with labor trafficking?

**Christina Sambor:** I don't know. In terms of numbers it is the same issue that we have. I suspect that the labor department will obviously have caseloads that we could start look at. Certainly you see a lot of labor trafficking victim's also experiencing sexual harassment or sexual violence, because they are in a place that there is no ability to advocate for themselves. Some of those numbers may be easier to get than the sex trafficking, because we do have the department of labor that is investigating those types of cases.

**Christopher Dodson ~ North Dakota Catholic Conference:** This committee understands now how multi phasic this problem is now. You are dealing with law enforcement, social services, labor issues and so many other different things. I think this committee understands and can really make the pitch on why this is part of this three legged stool of 2107, 2199 and this bill are necessary all together. I want to emphasize that faith based groups are involved but there are also faith based groups that just want to do more but they don't know what to do and a group like this that sees the big picture on how these things are related maybe can open doors for faith based groups, churches and so on to get involved. To answer your question, labor trafficking may not occur here as much as in other states but it pops up and if you recall a few years ago there was a situation where the company they hired had no idea, but it turned out the individuals here claimed they were held up in Louisiana in bad conditions and then shipped here for a job. It does pop up but I think more importantly there is this overlap that we need to be congestive of at all times between the sex trafficking and the labor trafficking.
