Chairman Dan Ruby opened the hearing on SB 2248.

**Bill Kalanek, North Dakota Towing Association**, introduced SB 2248 and provided written testimony. See attachment #1.

Vice Chairman Lisa Meier: In other states do they have amber and white lights on their tow trucks?

Bill Kalanek: The distinctions vary some, but typically it is amber and white.

Vice Chairman Lisa Meier: Would this bill make North Dakota adjacent to what other states are doing with their tow trucks?

**Bill Kalanek**: That is my understanding. We also worked closely with the North Dakota Highway Patrol, and this was the suggestion that they made. They thought that this was the most consistent and the best route to go.

Chairman Dan Ruby: What is the significance of the white?

**Bill Kalanek**: I think that if you get the variation, motorists are more likely to slow down than if the lights are just spinning amber. This was the best option that we were offered.

**Representative Gary Sukut**: Are there two lights or one light that is half white and half amber?

**Bill Kalanek**: It doesn't designate in the law how the lights are to be presented, but it would be in an alternating fashion that the lights would operate.

Representative Gary Sukut: Do you know what they cost?

**Bill Kalanek**: I would have to defer to a member of the association. I could get some information for you.

Representative Gary Sukut: Are the tow truck drivers comfortable with this?

Bill Kalanek: The association membership was unanimous in their desire to do this.

Chairman Dan Ruby: This doesn't allow either/or. It says that they have to use both?

Bill Kalanek: Correct.

There was no further support for SB 2248. There was no testimony in opposition to SB 2248. There was no neutral testimony on SB 2248.

On behalf of our members I'd like to voice support for Senate Bill 2248. Senate Bill 2248 seeks to make working conditions for tow truck drivers operating on our roads around the state safer by allowing a change in the signal lights used by towing companies.

According to statistics provided to me by the association, in the year 2014, 68 tow truck drivers were killed nationwide by collisions on the roadways when performing their work. This number exceeds the number or law enforcement and other emergency responders killed by collisions while assisting the public on our roads. It is the associations' position that passage of this bill is a prudent attempt to ensure our members are as safe as they can be while working to clear accidents and remove abandoned vehicles from the roads.

The bill you have before you would simply change the signal light designation for tow trucks in statute from amber to a combination of white and amber.
