




PER CAPITA PERSONAL INCOME




PERCENTAGE OF NORTH DAKOTA POPULATION (ALL AGES) IN POVERTY COMPARED TO THE UNITED STATES



Cumulative increase from 2004 through 2008 is 37%.





AVERAGE DAILY OIL PRODUCTION AND AVERAGE PRICE PER BARREL OF OIL









GENERAL FUND REVENUES -BEGINNING BALANCE, ONGOING REVENUES, AND TRANSFERS






North Dakota's sales tax rate is 5 percent. The estimated effect on general fund revenues of a one percentage point change in the state's 5 percent sales and use tax is approximately \$267 million per biennium, or \$133.5 million per year, based on the May 2009 legislative revenue forecast.

Individual income tax rates range from 1.84 percent to 4.86 percent based on the individual taxpayer's level of federal income tax liability. The estimated effect on general fund revenues of a 10 percent change in the state individual income tax rates (e.g., the 1.84 percent rate would increase by .184 percent to 2.024 percent, or decrease by .184 percent to 1.656 percent) is approximately \$63 million per biennium, or \$31.5 million per year, based on the May 2009 legislative revenue forecast.


Corporate income tax rates range from 2.1 percent to 6.4 percent of taxable income. The estimated effect on general fund revenues of a 10 percent change in the state's corporate income tax rates (e.g., the 2.1 percent rate would increase by .21 percent to 2.32 percent or would decrease by .21 percent to 1.89 percent) is approximately \$22 million per biennium, or \$11 million per year, based on the May 2009 legislative revenue forecast.


HISTORY OF GENERAL FUND APPROPRIATIONS (Amounts Shown in Millions)




2009-11 BIENNIUM ALL FUNDS APPROPRIATIONS



NUMBER OF STATE EMPLOYEES¹ (Full-Time Equivalent Positions (FTE))




COST OF STATE EMPLOYEE HEALTH INSURANCE PREMIUMS HISTORY







STATE SCHOOL AID - PER STUDENT PAYMENTS




AMERICAN COLLEGE TESTING PROGRAM SCORES




NATIONAL ASSESSMENT OF EDUCATIONAL PROGRESS

The national assessment of educational progress (NAEP) is the only nationally representative and continuing assessment of what America's students know and can do in various subject areas. Assessments are conducted periodically in mathematics, reading, science, and writing. However, because mathematics and reading are the only assessments required every two years by "No Child Left Behind" legislation, North Dakota tests science and writing in alternating years, resulting in four years between test years for science and writing.

Since NAEP assessments are administered uniformly using the same sets of test booklets across the nation, NAEP results serve as a common metric for all states.


Average NAEP Scores - Eighth Grade




Average NAEP Scores - Fourth Grade






HIGHER EDUCATION - GENERAL FUND APPROPRIATIONS AND TUITION REVENUE (Amounts Shown in Millions)








NORTH DAKOTA UNIVERSITY SYSTEM RESEARCH EXPENDITURES (Amounts Shown in Millions)









CHILDREN AND FAMILY SERVICES - NUMBER OF CHILDREN IN FOSTER CARE







DEPARTMENT OF COMMERCE LEGISLATIVE APPROPRIATIONS







MANUFACTURING JOBS





MOTOR FUELS TAXES

Both gasoline and special fuels (diesel) are taxed in North Dakota at a rate of 23 cents per gallon. A one-cent increase in the gas tax is estimated to generate an additional \$3.4 million per year or \$6.8 million for a biennium. A one-cent increase in the special fuels tax is estimated to generate an additional \$1.9 million per year or \$3.8 million per biennium. The federal tax rate per gallon is 18.4 cents for gasoline and 24.4 cents for diesel fuel.
