<u>NOTICE OF INTENT TO AMEND</u> <u>ADMINISTRATIVE RULES RELATING TO</u> <u>N.D. ADMIN. CODE CHAPTER 75-02-01.2</u> <u>TEMPORARY ASSISTANCE FOR NEEDY FAMILIES PROGRAM</u>

TAKE NOTICE that the North Dakota Department of Health and Human Services will hold a public hearing to address proposed amendments to N.D. Admin. Code chapter 75-02-01.2 at 9:00 a.m. on Tuesday, December 19, 2023, in Bismarck, N.D. in Room 210, located on the second floor of the Judicial Wing of the State Capitol.

The proposed amendments to N.D. Admin. Code chapter 75-02-01.2, Temporary Assistance for Needy Families Program, are necessary to comply with 2023 Senate Bill No. 2181.

The proposed changes are as follows:

Section 75-02-01.2-01 is amended to remove the definition of "benefit cap child" and to amend the definitions of "caretaker relative", "department", "eligible caretaker relative", and "legally responsible".

Section 75-02-01.2-02.3 is amended to replace "a person" with "an individual".

Section 75-02-01.2-06 is amended to replace "person" with "individual".

Section 75-02-01.2-12 is amended to replace "persons" with "individuals".

Subsection 3 of section 75-02-01.2-13 is amended to replace "person's" with "individual's".

Section 75-02-01.2-18 is amended to replace "persons" and "persons" with "individuals" and "individual".

Subdivision i of subsection 1 of section 75-02-01.2-21 is amended to replace "persons and families" with "individuals".

Section 75-02-01.2-30 is amended to remove of the language "no earlier than the sixth month of pregnancy" to allow eligibility for pregnant women in the first and second trimester of pregnancy in response to 2023 Senate Bill No. 2181.

Section 75-02-01.2-30.1 is repealed in response to 2023 Senate Bill No. 2181 to allow for a child born to a parent who was an adult during that probable month of conception to be eligible when the parent received assistance.

Subsection 1 of section 75-02-01.2-31 is amended to remove the language "in the third trimester of her pregnancy" to allow eligibility for pregnant women in the first and second trimester of pregnancy in response to 2023 Senate Bill No. 2181.

Subsection 1 of section 75-02-01.2-33 is amended to remove the language "a benefit cap child" to allow for a child born to a parent who was an adult during that probable month of conception to be eligible when the parent received assistance causing the child to not be eligible for assistance in response to 2023 Senate Bill No. 2181.

Subsection 1 of section 75-02-01.2-37 is amended to remove the language "in the last trimester of her pregnancy" to allow eligibility for pregnant women in the first and second trimester of pregnancy in response to 2023 Senate Bill No. 2181.

Subsections 1 and 6 of section 75-02-01.2-44 are amended to replace "persons" with "individuals".

Section 75-02-01.2-51 is amended to update the incentive to allow an individual who has used the time limited percentage to receive it again if they have been off Temporary Assistance for Needy Families Program for twelve months or longer in response to 2023 Senate Bill No. 2181.

Section 75-02-01.2-90 is amended to replace "person" with "individual".

The proposed amendments are anticipated to have an impact on the regulated community in excess of \$50,000. No taking of real property is involved in this rulemaking action.
