The Notice of Intent to Adopt/Amend Administrative Rules and a copy of the proposed rules related to Article 10-16 (Multi-State Lottery) of the N.D.A.C. are enclosed as required by N.D.C.C. § 28-32-10(1).

The proposed rules for General Rules, Retailer, Conduct and Play, 2by2 Game, and North Dakota Lottery Players Club Points for Prizes and Points for Drawings are emergency rules with a declared effective date as interim final rules of July 6, 2014. The emergency rules are necessary to meet the online vendor's conversion date and implementation of new products/services, along with the Multi-State Lottery Association game changes for 2by2. N.D.C.C § 53-12.1-13 allows the North Dakota Lottery to adopt emergency rules as necessary without the grounds otherwise required under N.D.C.C § 28-32-03.

NOTICE OF INTENT TO
ADOPT/AMEND ADMINISTRATIVE RULES

TAKE NOTICE that the Office of Attorney General will hold a public hearing to address proposed amendments to North Dakota Administrative Code article 10-16 related to the multi-state lottery at 2:00 p.m. CT on Monday, August 11, 2014, at the North Dakota Lottery office, 1050 East Interstate Avenue - Suite 200, in Bismarck. The purpose of the proposed amendments is to adopt and update rules. The proposed amendments addressing changes to General Rules definitions; Retailer duties and sales and bonus commission; Conduct and Play sale or gift of a ticket, validation of a ticket, and subscription; 2by2 Game expected prize pool percentage and odds and Tuesday draw double prize feature; and North Dakota Lottery Players Club Points for Prizes and Points for Drawings are emergency rules with a declared effective date as interim final rules of July 6, 2014. The proposed amendments are not expected to have an impact on the regulated community in excess of \$50,000.

The proposed rules may be viewed at the North Dakota Lottery office, 1050 East Interstate Avenue - Suite 200, Bismarck, North Dakota 58503-5574. A copy of the proposed rules may be requested by writing the above address or calling 701-328-1574. Written or oral comments on the proposed rules sent to the above address or telephone number and received by Friday, August 22, 2014, will be fully considered.
