## **Item Description**

**Enrollment** - At the end of the 2013 regular legislative session, the Dakota College at Bottineau FTE student enrollment projection for the 2013-15 biennium was 504 for the fall 2013 semester and 530 for the fall 2014 semester.

**Tuition collections** - Dakota College at Bottineau estimated tuition revenue of \$2,332,399 for the 2013-14 fiscal year.

**One-time funding** - In Section 2 of Senate Bill No. 2003, the Legislative Assembly identified \$217,358,169 of funding from the general fund as one-time funding items for the University System. Of this amount, \$75,000 has been allocated to Dakota College at Bottineau for deferred maintenance, \$28,500 for software upgrades, and \$16,675 for capital projects contingency, and \$1,145,320 is for capital projects at Dakota College at Bottineau.

**Capital projects** - The Legislative Assembly authorized the following capital projects for Dakota College at Bottineau for the 2013-15 biennium:

## Status/Result

The fall 2013 semester FTE enrollment was 502, 2 fewer than projected and 28 more than the fall 2012 semester.

The current actual net tuition collections for the 2013-14 fiscal year is \$2,172,175. Dakota College at Bottineau currently estimates collections to be \$70,000 less than projected.

Dakota College at Bottineau anticipates using all the funds provided for deferred maintenance during the 2013-15 biennium. \$28,500 was appropriated for software upgrades, and the bid was \$30,000. Dakota College at Bottineau will use \$1,500 appropriated for operations to pay the remainder. Dakota College at Bottineau anticipates completion of the software upgrades in July 2014.

The status of each project as of April 2014 is:

- Campus backup generator Bids received for the project were in excess of budget by \$74,380. Dakota College at Bottineau received an additional \$16,675 from the capital project contingency pool and will use \$57,705 of operating funds for the remaining costs. The project is estimated to be complete by August 2014.
- Gross Hall updates Funds have not yet been secured for the project.
  Dakota College at Bottineau will be requesting reauthorization for the project during the 2015 legislative session.

**Higher education challenge matching grant program** - The Legislative Assembly appropriated \$29 million from the general fund to the University System office for the higher education challenge matching grant program. A total of \$1 million is available for grants to Dakota College at Bottineau.

- Mead Hall updates Funds have not yet been secured for the project.
  Dakota College at Bottineau will be requesting reauthorization for the project during the 2015 legislative session.
- Milligan Hall updates Funds have not yet been secured for the project.
  Dakota College at Bottineau will be requesting reauthorization for the project during the 2015 legislative session.
- Old Main remodel Funds have not yet been secured for the project. Dakota College at Bottineau will be requesting reauthorization for the project during the 2015 legislative session.
- Thatcher Hall upgrades Dakota College at Bottineau is processing bids for the project. The college anticipates project completion by August 2014.

Through April 2014, Dakota College at Bottineau has not received any grant funding through the program.
