NONRESIDENT TUITION RATES NORTH DAKOTA COMPARED TO OTHER STATES

This memorandum provides information regarding nonresident tuition rates in North Dakota compared to other states and information on tuition waiver policies in South Dakota and Montana.

NORTH DAKOTA

The 1973 Legislative Assembly amended North Dakota Century Code Section 15-10-18 to require Committee on Budget approval of nonresident tuition rates. Section 15-10-18 was amended again in 1983 to identify the Budget Section as responsible for approval of nonresident tuition rates. The 1999 Legislative Assembly removed the requirement for approval from the Budget Section, leaving the State Board of Higher Education responsible for approving nonresident tuition rates. The Budget Section generally approved nonresident tuition rates set at approximately 267 percent of the resident tuition rate for each institution. The board has never had a policy establishing a standard or default nonresident tuition rate, however, the board continued to annually approve nonresident tuition rates at approximately 267 percent of the resident rate until the 2002-03 academic year, when it approved a nonresident tuition rate at Williston State College at 150 percent of the resident tuition rate. Since the 2002-03 academic year, the board has approved various nonresident tuition rates at North Dakota University System (NDUS) institutions. Some institutions have continued to set nonresident tuition at 267 percent of the resident tuition rate, but at other institutions, nonresident tuition has been set at rates equivalent to the resident tuition rate or at some other rate between the resident tuition rate and what used to be the standard 267 percent rate. State Board of Higher Education policy 805.1, relating to tuition, states in part:

- "3. Tuition rates shall include rates for residents and nonresidents, as those terms are defined by law, and, except as otherwise approved by the Board, the following rates for these special categories:
 - For residents of South Dakota, Montana, Saskatchewan, and Manitoba, a tuition rate equal to 150 per cent of the resident rate at UND or NDSU and 125 per cent of the resident rate at other institutions;
 - b. For undergraduate students who are children or spouses of graduates of NDUS institutions, a tuition rate equal to 150 percent of the resident rate, regardless of residency; and
 - c. Such other special rates as may be established by agreements entered into under N.D.C.C. § 15-10-28, N.D.C.C. ch. 15-10.1, or under regional higher education compacts."

Resident and nonresident tuition rates at University System institutions for the 2015-16 academic year are as follows:

In a review of select other states, the South Dakota Board of Regents policy states nonresidents should pay more than residents, however, there is not a specific percentage identified in board policy. The board also has a policy allowing universities to request reduced nonresident tuition rates to manage enrollment. In addition to waivers established by the state legislature, the board has approved specific reduced tuition programs for graduate fellows and assistants, North Dakota residents, Wyoming residents, and residents of WICHE states.

The Montana Board of Regents of Higher Education has a policy stating tuition levels will bear a relationship to the costs incurred by the campus in providing the education to the student. The policy also allows campuses the flexibility to set nonresident tuition as low as 150 percent of the resident tuition rate. The board policy also provides for tuition waivers for employee dependents, American Indians, faculty and staff, veterans, war orphans, and surviving dependents of Montana National Guard members, firefighters, and peace officers. Campuses may also award discretionary waivers for nonresident students, senior citizens, qualified veterans, and other students with superior academic achievement, service to the campus, or other meritorious accomplishment.
