MARRIAGE DEFINITION - IMPACTED SECTIONS

Several states have required the use of gender neutral language when applying laws and regulations to same-sex couples. The statutes listed in the chart provide the topic addressed in each impacted North Dakota Century Code section as well as the exact wording used. The column entitled "Use of 'Spouse'" deciphers whether the current terminology could be replaced with the term "spouse" without causing further legal ramifications or if the language would need to be further amended. Black's Law Dictionary defines "spouse" as a term used to describe a person's husband or wife.

The use of the term "spouse" is used in 17.0203.01000 to remain consistent with the terminology used throughout the code. Amending the language to use the term "spouse" is purely linguistic and does not have any legal impact on the statutes.

The District of Columbia, Minnesota, New Hampshire, Rhode Island, Vermont, and Washington include gender neutral requirements in statute or allow for equal treatment of same-sex couples under other family laws, including the Uniform Parentage Act. These six states enacted same-sex marriage prior to the United States

Supreme Court decision in June 2015. Several different options exist for alternative language, the most common being "individuals who are married to each other" and "spouse."
