## STATE-OWNED REAL ESTATE

Pursuant to 2005 House Concurrent Resolution No. 3005, the 2005-06 interim Budget Committee on Government Services is to seek information identifying state-owned real estate and to study the utilization of real estate owned by state agencies and institutions, the best use of state-owned real estate, and whether the state should establish and maintain an inventory of state-owned real estate. As part of this duty, the committee requested the Legislative Council staff to conduct a survey of state agencies and institutions to obtain information regarding the state-owned real estate, including the current use and anticipated future use of the property, any restrictions on the use of the proceeds from the sale of the property, any mineral rights or easements, and any leases and related lease income.

The results of the survey indicate that 38 state agencies and institutions own land totaling 1,057,333 acres and 1,820 buildings consisting of approximately 21,794,832 square feet. The committee may want to invite selected agencies to provide the committee with additional explanation. The table below summarizes the state agency/institution responses to the real estate survey. Copies of the detailed information submitted by each agency/institution are attached as Appendices A through LL:
