ENGROSSED SENATE BILL NO. 2075

(At the request of the Public Service Commission)

1 A BILL for an Act to amend and reenact sections 49-22-03 and 49-22-07 of the North Dakota
2 Century Code, relating to transmission facilities and power emergencies.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. AMENDMENT.** Section 49-22-03 of the 1995 Supplement to the North
5 Dakota Century Code is amended and reenacted as follows:

6 **49-22-03. Definitions.** In this chapter, unless the context or subject matter otherwise
7 requires:

- 8 1. "Certificate" means the certificate of site compatibility or the certificate of corridor
9 compatibility issued under ~~the provisions of~~ this chapter.
- 10 2. "Commission" means the North Dakota public service commission.
- 11 3. "Construction" includes any clearing of land, excavation, or other action that would
12 affect the environment of the site after April 9, 1975, but does not include activities
13 incident to preliminary engineering or environmental studies.
- 14 4. "Corridor" means the general location of a transmission facility.
- 15 5. "Energy conversion facility" means any plant, addition, or combination of plant and
16 addition, designed for or capable of:
 - 17 a. Generation of fifty thousand kilowatts or more of electricity;
 - 18 b. Manufacture or refinement of one hundred million cubic feet [2831684.66
19 cubic meters] or more of gas per day, regardless of the end use of the gas;
 - 20 c. Manufacture or refinement of fifty thousand barrels [7949.36 cubic meters] or
21 more of liquid hydrocarbon products per day; or
 - 22 d. Enrichment of uranium minerals.
- 23 6. "Facility" means an energy conversion facility, transmission facility, or both.

- 1 7. "Permit" means the permit for the construction of a transmission facility within a
2 designated corridor issued under ~~the provisions of~~ this chapter.
- 3 8. "Person" includes any individual, firm, association, partnership, cooperative,
4 corporation, limited liability company, or any department, agency, or instrumentality
5 of a state or of the federal government, or any subdivision thereof.
- 6 9. "Power emergency" means an electric transmission line and associated facilities
7 that have been damaged or destroyed by natural or manmade causes resulting in
8 a loss of power supply to consumers of the power.
- 9 10. "Route" means the specific location of a transmission facility within a designated
10 corridor.
- 11 ~~40.~~ 11. "Site" means the location of an energy conversion facility.
- 12 ~~44.~~ 12. "Transmission facility" means any of the following:
- 13 a. An electric transmission line and associated facilities with a design in excess
14 of one hundred fifteen kilovolts. "Transmission facility" does not include a
15 temporary transmission line loop that is:
- 16 (1) Connected and adjacent to an existing transmission facility that was
17 sited under this chapter;
- 18 (2) Within the corridor of the sited facility and does not cross known
19 exclusion or avoidance areas;
- 20 (3) Less than one mile long; and
- 21 (4) In place for less than one year.
- 22 b. A gas or liquid transmission line and associated facilities designed for or
23 capable of transporting coal, gas, liquid hydrocarbons, liquid hydrocarbon
24 products, or carbon dioxide. ~~The provision of this~~ This subdivision does not
25 apply to an oil or gas pipeline gathering system. For purposes of this chapter,
26 a gathering system includes the pipelines and associated facilities used to
27 collect oil from the lease site to the first pipeline storage site where pressure
28 is increased for further transport, or pipelines and associated facilities used to
29 collect gas from the well to the gas processing facility.
- 30 c. A liquid transmission line and associated facilities designed for or capable of
31 transporting water from or to an energy conversion facility.

1 ~~42.~~ 13. "Utility" means any person engaged in and controlling the generation,
2 manufacture, refinement, or transmission of electric energy, gas, liquid
3 hydrocarbons, or liquid hydrocarbon products, including, ~~but not limited to,~~ electric
4 power generation or transmission, coal gasification, coal liquefaction, petroleum
5 refinement, uranium enrichment, and the transmission of coal, gas, liquid
6 hydrocarbons, or liquid hydrocarbon products, or the transmission of water from or
7 to any energy conversion facility.

8 **SECTION 2. AMENDMENT.** Section 49-22-07 of the 1995 Supplement to the North
9 Dakota Century Code is amended and reenacted as follows:

10 **49-22-07. Certificate of site compatibility or route permit required.** ~~No~~ A utility
11 ~~shall~~ may not begin construction of an energy conversion facility or transmission facility in the
12 state, or exercise the right of eminent domain in connection with ~~such~~ that construction, without
13 first having obtained a certificate of site compatibility or a route permit from the commission
14 pursuant to this chapter. ~~A~~ The facility ~~shall thereafter~~ must be constructed, operated, and
15 maintained in conformity with ~~such~~ the certificate or permit, and any terms ~~and~~ conditions
16 ~~contained therein and subsequent, or~~ modifications thereof of the certificate or permit. A
17 certificate or permit may be transferred, subject to the approval of the commission, to any
18 person who agrees to comply with its terms, conditions, and modifications.

19 If a power emergency exists which necessitates the relocation of a portion of an electric
20 transmission line and associated facilities from the designated route, the owner of the line shall
21 give telephonic notice to the commission in advance of the relocation. The line may then be
22 relocated to restore power as soon as practicable. After the line has been relocated the owner
23 shall file with the commission a request to approve the relocated route.
