## Fifty-sixth Legislative Assembly

Bismarck, January 18, 1999

If no valid claim is made to such estate by the heirs or the next of kin of the deceased member for a period of one year after the granting of letters of administration, the residue of the estate must be deposited with the state treasurer for the benefit of the veterans' home ~~improvement~~ operating fund.

Was read the first time and referred to the **Industry, Business and Labor Committee**.
