The roll was called and all members were present except Representatives Gunter, Koppelman, Jensen, Meier, and Warner.

A quorum was declared by the Speaker.

POINT OF PERSONAL PRIVILEGE

REP. MARTINSON: Mr. Speaker: I rise on a point of personal privilege and request that my remarks be printed in the Journal.

Representative Lisa Meier was selected to represent North Dakota and join six other young political leaders from across the nation as a delegate to the Republic of Korea during a two week political study program sponsored by the American Council of Young Political Leaders (ACYPL), a bipartisan non-profit organization located in Washington, DC. The program with Korea will take place November 28th - December 14th.
